Indianapolis Feb 17th 1851

Council met, Present Messrs McCuat, Eckert, Landis, Rooker, Hetselgessen and Mr. Cully President.

The object of the meeting being the consideration of the proposition of Mr. Lockwood and others to light this city with gass, which subject had been refered to a select Committee with instructions to Report an ordinance on the subject, and Mr. Cully one of the Members of said Committee in accordance with said instructions Reported an ordinance on the subject which was read, and after considerable debate had thereon, was refered back to said Committee with instructions to perfect the same and present it at the next Regular Meeting of the Council for their consideration.

Mr. Eckert laid before the Council the Certificate of Sale of Lot No 9 in Out Block No 147, sold to George Youngerman, said Lot belonging to the State, He moved that the sum of \$1.20/100 be refunded to said Youngerman and the Certificate cancelled, which motion prevailed.

(364) The Bill of Mr. Lockwood for seating the several Public School Houses in this City built by the Council was presented, and the sum of \$252.00 was allowed him, it being the contract price.


The Committee on School Houses made the following Report, which was accepted.

That the desks are all finished satisfactory, and in accordance with the plan and specifications, therefor recommend the payment of the bill of the contractor, Except the price for making extra Benches amounting to the sum of \$10.00 which we consider not in the Contract.

The following Resolution was presented, Read and adopted.

Resolved, That the Committee on Public School Houses is hereby directed to furnish each School House erected by the City Council with one or more privies at their discretion, and the necessary fences, the same to be paid from the General fund of the



City, and refunded from the School fund as soon as the same may be collected and in the hands of the City Treasurer.

The resignation of Mr Wygant as one of the Superintendants of the Public School in the 3rd district was read and accepted by the Council, and on Motion, Samuel McMillen was appointed to fill said vacancy.

On Motion the Council adjourned.
