The Common Council of the City of Indianapolis met in its Council Chamber, on Monday evening, December 2d, A. D. 1878, at seven o'clock, in regular session.

John Caven, Mayor, and, ex officio, President of the Common Council, in the Chair, and the following members: Councilmen Anderson, Bermann, Brown, Bruner, Cummings, Dill, Layman, Marsee, Maus, Morris, Morse, McKay, O'Brien, Off, Reading, Reasner, Rodibaugh, Showalter, Steeg, Tucker, Walker, Wiese, and Wright—23.

ABSENT—Councilmen McGinty and Sindlinger—2.

The Proceedings of the Common Council, for the regular sessions, held on November 4th and 18th, and of the Third Joint Convention, held on November 18th, 1878, having been printed, and placed on the desks of the Councilmen, said proceedings were duly approved as published.

Sealed proposals for making the below-proposed improvement [under the provisions of the special ordinance noted before the same] was opened and read by the City Clerk, and was then referred to the Committee on Contracts:

REPORTS FROM OFFICIAL BOARDS.

The Board of Public Improvements, through President McKay, submitted the following report; which was considered and duly concurred in by clauses:

Indianapolis, December 2, 1878.

To the Mayor and Common Council:

Gentlemen:—We would respectfully report, as follows, upon sundry papers referred to us:

1st. Are motions directing the Street Commissioner to fill, with gravel, the mud-holes in the first alley east of Alvord street, running north from Malott avenue; also to re-gravel Hill avenue, where needed.

We recommend this work be done.

2d. Is a motion directing the Street Commissioner to fill the chuck-holes in New York street, between West and Blackford streets.

We recommend this work be done.

3d. Is a motion directing the Street Commissioner to clean the south gutter of Michigan Road, from Washington street to Oriental street.

We recommend this work be done,

4th. Is a motion directing the Street Commissioner to clean the gutters of Co-burn street, between East street and Virginia avenue.

We recommend this work be done.

5th. Is a motion directing the Street Commissioner to place a cinder crossing on Prospect street, opposite the east side of Olive street.

We recommend this work be done.

6th. Is a motion to grant a permit to R. H. Rees to lay a stone crossing over Indiana avenue—said crossing to be laid at his own expense, and under direction of the City Civil Engineer.

We recommend said permit be granted.

7th. Is a motion directing the Board of Public Improvements to report old "Romeo's" condition for work.

We have visited this forlorn object, and are grieved to report his condition deplorable in the extreme. He seems crusty and out of joint, and is at present unable to work.

8th. Is a motion directing the Street Commissioner to make necessary repairs to the plank floor of the iron bridge over White River on Washington street.

We recommend this work be done.

9th. Is a motion directing the Street Commissioner to lower the alley-crossing on east side of West street, between New York and Vermont streets, to correspond with grade of alley.

We recommend this work be done.

10th. Is a motion directing the Street Commissioner to put down einder crossing on McCarty street, at West and Chadwick streets.

We recommend this work be done.

11th. Is a motion instructing the Street Commissioner to discharge men and teams that are now in his employ, if necessary to make room for delinquent taxpayers to work out their city tax.

We would recommend that when applications are made for the purposes indicated in the motion, the Street Commissioner employ only those who, in his judgment, are competent and able to do the work required.

12th. Is a motion directing the Street Commissioner to clean the gutters of Madison avenue, between Merrill street and the J., M. & I. Railroad tracks.

We recommend this work be done.

13th. Is a petition from Valentine Meier and others, asking that the crossing at the intersection of Pearl and Missouri streets be repaired.

We recommend the prayer of the petitioners be granted.

Councilman McKay moved to amend Councilman Morse's motion, by limiting lease to one year, awarding same to highest bidder; which amendment was adopted.

Councilman Morse's motion, as amended, was then duly adopted.

MESSAGES AND PAPERS FROM THE BOARD OF ALDERMEN.

The following message from the Board of Aldermen was read and considered by clauses:

To the Common Council:

Gentlemen:—At a regular session of the Board of Aldermen, held on November 19th, 1878, said body refused to concur in the action of the Common Council, as had on the previous evening, in the following particulars:

- 1st. It determined to adhere to its action of November 5th, when, by partial concurrence in the action of your honorable body, had at your session of the evening before, it instructed the Fire Board to put Steam Fire-Engine No. 7 out of service.
- 2d. It refused to concur in your approval of the recommendation made by the Board of Public Improvements, whereby the Street Commissioner was instructed, instead of lowering the crossing of Meridian and McCarty streets, to fill cinders or gravel on each side thereof.
- 3d. The Committee on Railroads reported adversely to the adoption of Councilman Brown's motion (which your honorable body had favorably acted upon on September 2d, 1878—see page 406), ordering the Union Railway Company to furnish its flagmen at certain street crossings with lanterns after dark, because, "in their opinion, the action asked for would not be attended with any beneficial results."
- 4th. The Committee on Public Schools reported adversely to the vacation of Arsenal Park Addition, unless the owner thereof would revise his petition therefor, "so as to conform its streets to those streets in the city which, when extended, would pass through it."

I hereby notify you of foregoing non-concurrent proceedings, that you may duly consider and take action upon same.

To the Mayor, and Members of the Common Council and

Board of Aldermen of the City of Indianapolis:

Gentlemen:—The undersigned, real and personal property owners in squares numbered 44, 45, 46, 47, 54, 55, 56, 57, 64, 65, 66, 67, 74, 75, 76, 77, 84, 85, 86, 87, and 88, in the City of Indianapolis, do most respectfully petition your honorable bodies to reconsider the vote by which the motion was adopted on November 18th, 1878, authorizing the continuance in the Fire Department of Fire-Engine No. 7; and do earnestly recommend, as a measure looking toward economy in the city government, that you adhere strictly to the action of the Council of November 4th, 1878, when the following motion was adopted by a vote of 18 to 6: "Moved, That the Fire Board be, and are hereby, instructed to have No. 7 Fire-Engine and one hose-reel discontinued from service in the Fire Department, and properly housed, for future use, if necessary."

Councilman Walker then moved that the Common Council recede from its action of November 18th [see page 598, ante], and concur in the Aldermanic action, as set forth above.

Councilman Cummings moved to lay Councilman Walker's motion on the table; which the Common Council refused to do by the following vote:

AYES, 9-viz.: Councilmen Brown, Bruner, Cummings, Morse, O'Brien, Reading, Steeg, Tucker, and Wiese.

NAYS, 14—viz.: Councilmen Anderson, Bermann, Dill, Layman, Marsee, Maus, Morris, McKay, Off, Reasner, Rodibaugh, Showalter, Walker, and Wright.

Councilman Walker's motion was then adopted by the following vote:

AYES, 15—viz.: Councilmen Anderson, Bermann, Dill, Layman, Marsee, Maus, Morris, McKay, O'Brien, Off, Reasner, Rodibaugh, Showalter, Walker, and Wright.

Nays, 8—viz.: Councilman Brown, Bruner, Cummings, Morse, Reading, Steeg, Tucker, and Wiese.

The second clause of foregoing message being under consideration, on Councilman McKay's motion, the Common Council determined to adhere to its former action.

The Aldermanic non-concurrent action, as set forth in the third clause of preceding message, was duly approved.

The fourth clause of foregoing message being under consideration, on Councilman McKay's motion, the Common Council determined to adhere to its action of September 23d, 1878 [see pages 464 and 465, ante], when it adopted the resolution of vacation.

The following message was then read:

To the Common Council:

Gentlemen:—At an adjourned session of the Board of Aldermen, held on Monday evening, November 25th, 1878, the following proceedings were had:

1st. General Ordinance 55, 1878, entitled "An Ordinance regulating the Cleaning of Privy-Vaults, Water-Closets, and other Receptacles of Human Excrements, and requiring persons who may engage in such business to be duly licensed before undertaking such work" (passed by your honorable body on November 4th), was amended as follows:

SEC. 3. By striking out the words "and which machine or apparatus shall have been first examined and approved by the Board of Health of said city," and inserting, in lieu thereof, the words "which machine shall use a hose of not less than four (4) inches in diameter."

SEC. 6. By striking out the word "five," and substituting the word "ten."

Sec. 9. By striking out the phrase "together with imprisonment, not exceeding thirty days."

2d. The following entitled ordinance was introduced, and duly passed:

G. O. 57, 1878—An Ordinance granting Fred. P. Rush & Co. permission to rebuild their three-story Frame Elevator, on the south part of the northwest half of Square No. 84, on Delaware street, between Maryland street and the Union Railway Tracks.

Resolved (the Common Council concurring), That the City Marshal, under the direction and advice of the City Attorney, notify the parties to move the fences and buildings from the street; and, if not done at once, to take the proper measures to re-open the same.

And was adopted by the following vote:

The following Aldermanic motions were read; and the reference of same to the Board of Public Improvements, with power to act, was duly confirmed:

That the Street Commissioner be ordered to fill up the chuck-holes in Russell avenue.

Councilman Wiese offered the following motions; which were severally referred to the Board of Public Improvements:

That the Street Commissioner be directed to fill the chuck-holes in Union street, between McCarty and Ray streets.

That the Street Commissioner be directed to clean the gutters of Meridian street, between McCarty and Ray streets.

That the Street Commissioner be directed to fill the chuck-holes in Madison avenue, between Merrill street and the J., M. & I. Railroad.

Councilman Wright presented the following petition and appended paper; which, at his suggestion, were referred to the Judiciary Committee and the City Attorney:

To the Mayor and Common Council of the City of Indianapolis:

The undersigned, Elizabeth Chamberlain, respectfully shows that she is the

widow of Moses Chamberlain, and has been for twenty years past.

That she is the owner of a strip of ground, twenty-two feet in width, on Vermont street, in the City of Indianapolis, Marion county, Indiana—being a part of outlot 153.

That said property was appraised and taxed, for city purposes; and that, during the last three years, she has paid taxes thereon, to the City Treasurer, as follows: March 10th, 1876 (No. 2681), \$33.00; September 5th, 1877 (No. 2788), \$25.63; April 2d, 1878 (No. 2855), \$19.10.

That, during all these years, and at these times of payment, her entire estate real and personal, has not exceeded in value the sum of one thousand dollars. She has not been allowed the exemption given in clause 8, section 6 of the Act approved December 21st, 1872.—Statutes of Indiana, volume one (1), page seventy-four (74).

She prays that the exemption be allowed her for this year, and succeeding years, and that a proper part of the taxes above referred to, and paid, be refunded herto-wit, the taxes on \$500 of said property, for each and all of said years.

On Councilman Layman's motion, the matter was then referred to the Council and Aldermanic Judiciary Committees and the City Attorney, with instructions to prepare and report, at the next meeting of this body, an ordinance to regulate the construction of telegraph, telephone, and like lines, but allowing the work of this particular company to proceed in the meanwhile, under the direction and control of aforesaid committees and officer.

Councilman Wright then moved the adoption of the original motion; which the Common Council refused to do.
