PROCEEDINGS OF BOARD OF ALDERMEN.

ADJOURNED SESSION-APRIL 15, 1879.

The Board of Aldermen of the City of Indianapolis met in the Aldermanic Chamber, on Tuesday evening, April 15th, A. D. 1879, at halfpast seven o'clock, pursuant to adjournment.

PRESENT—His Honor, the President, Wm. D. Wiles, in the Chair, and Aldermen Chandler, Foster, Grubbs, Mussmann, Piel, and Ridenour—7.

ABSENT-Aldermen Coburn, Snider, and Stratford-3.

MESSAGES AND PAPERS FROM THE COMMON COUNCIL.

The following message was read :

To the Board of Aldermen of the City of Indianapolis:

Gentlemen:—The Common Council, at its regular session of 7th instant, refused concurrent approval to the report of your Committee on Streets and Alleys, which recommended the use of not more than twenty-five loads of coarse gravel in repairing S. Meridian street, between McCarty and Morris streets, that amount of repair-material being, in its judgment, entirely inadequate for such purpose.

At same session, said body adopted the following motion; which I herewith transmit, for your action:

That the Indianapolis Gas-Light and Coke Company be, and they are hereby, directed to look after the condition of lamps in covered bridge on Washington street over White River. Spiders, sparrows, and bats have had undisturbed possession of the premises for a long time. The bridge is in danger, and should be looked to.

On Alderman Chandler's motion, the motion transmitted by second portion of message was referred to the Aldermanic Committee on Gas-Light.

Adjourned Session

To the Board of Aldermen of the City of Indianapolis:

Gentlemen :- At the adjourned session of the Common Council, held on last evening (April 14th, 1879), said body determined to adhere to its action, theretofore had, in favor of permitting Messrs. Jacob Fritz, David Russell, and John L. S. Arnold to construct driveways over their respective sidewalks out of plank, but stipulated that such driveways should be made of 2x4 inch planks, laid edgewise.

Also examined the property of Jacob Fritz, on Yandes street, and David Russell, on Biddle street, and find that they have not planked the sidewalk.

PROCEEDINGS OF THE

Mayor Caven's report that the amount of fines (\$30.75) by him collected during the month of March, 1879; also, that the amount of fines (\$14.45). by him collected during the months of January, February, and March, 1879, and due the Home for Friendless Women, had been duly paid into the city treasury [see page 917. *ante*], was read, and was duly approved.

Report from the Council Committee on Contracts, giving abstracts of proposals and recommending that contracts be awarded as below, was read; and the action of the Common Council, in concurring therein [see pages 917 and 918, *ante*], was duly approved:

- 1st To R. H. Patterson, for grading and bowldering Maryland street and the north gutter thereof, from Illinois street to Tennessee street, at \$1.20 per lineal foot front on the north side, and at 84 cents per lineal foot front on the south side.
- 2d. To William Morrison, for improving the first alley west of California street, from Pratt street to First street, by grading and graveling, at 10 cents per lineal foot front on each side.
- 3d. To Hiram Seibert, for re grading and re-paying the east sidewalk of Virginia avenue, from Maryland street to Alabama street, at 45 cents per lineal foot front.

The following report from the City Clerk [see page 921, ante] was read, and was duly approved :

To the Common Council and Board of Aldermen of the City of Indianapolis:

Gentlemen: --In accordance with instructions given, I would report that, on Saturday, March 12th, 1879, I did personally serve on the Water Works Company of Indianapolis, the resolution adopted by your honorable bodies, on the 7th and 8th instants, requiring said corporation to extend its water-mains on Madison avenue, from Morris street to Nebraska street.

First.—The following motions, directing the Street Commissioner to do certain work at various points, all of which we recommend be done:

1. To clean the gutters of Garden street, from Merrill street to Norwood street.

2. To clean the gutters of South Arsenal avenue and Summit street, between Washington street and the I. & St. L. Railroad tracks.

3. To put a plank crossing over the gutter of Michigan Road, in front of an alley between Washington street and Oriental street.

4. To fill the ruts and chuck-holes in Illinois street, from Seventh to Twelfth street.

5. To fill, with gravel, the chuck-holes in Indiana avenue, from North street to Fall Creek.

6. To build a bridge across the gutter on the south side of Buchanan street, where Wright street intersects said street.

7. To fill the chuck-hole in McCarty street, where said street intersects East street.

8. To build a bridge across the gutter on the north side of Buchanan street, where Greer street intersects said street.

9. To fill the chuck-holes in Harrison street, between Noble and Dillon streets.

10. To fill the chuck-holes in Blake street, between Washington and Michigan streets, *provided*, the motion is amended to read "from New York to Michigan street"—the street from Washington street to New York having already been provided for in a previous motion.

11. To clean the gutters of Tennessee street, from McCarty street to Ray street.

Second.—A motion granting A. Caylor permission to move his scales from where they now stand, in front of No. 187, and place the same in front of No. 177, Indiana avenue.

We recommend the permission be granted, *provided* the removal contemplated be done under the supervision of the City Civil Engineer.

The following report from the Board of City Commissioners was read:

To the Mayor and Common Council of the City of Indianapolis:

Gentlemen:—The undersigned, City Commissioners, respectfully report to your honorable body that, in the matter referred to them in regard to assessing damages and benefits in the opening and widening of Dillon street, they were enjoined, by the notice served on them from the Judge of the Circuit Court of the United States for the District of Indiana, from taking any action in said case, and that your Commissioners have met, from time to time, on adjournment, to give time for the Court to decide the matter enjoined. And now, with the advice of the City Attorney, report the above facts, and await your pleasure for further action by us.
