APPROPRIATION ORDINANCE NO. 6, 1929

AN ORDINANCE, appropriating the sum of Six Hundred Ninety-three Thousand Dollars (\$693,000.00) to be received from the sale of the "Municipal Airport Bonds" to the Board of Public Works of the City of Indianapolis, Indiana, for the purpose of acquiring the different parcels of land heretofore designated to be used as an aviation field, and for the purpose of maintaining, equipping, constructing and operating the same as a municipal airport, declaring an emergency and fixing a time when the same shall take effect.

AN ORDINANCE, transferring moneys from certain funds and reappropriating the same to other numbered funds of the Department of Health and Charities, and fixing a time when the same shall take effect.

WHEREAS, there are not sufficient funds in Garage Fund No. 724, or City Hospital General Fund No. 216, of the Department of Health and Charities, to meet the necessary expenses legally chargeable to said funds, and

WHEREAS, there is available a surplus of Thirty-two Hundred Twenty (\$3220) Dollars remaining in Power Plant Fund No. 321, of said

Department of Health and Charities, which sum will not be needed for the purposes for which same was appropriated, and 204

WHEREAS, an extraordinary emergency exists for the transfer and reappropriation of the funds hereinafter described, for the proper carrying on of the necessary functions and duties of the Department of Health and Charities:

Be It Ordained by the Common Council of the City of Indianapolis, Indiana:

Section 1. That the sum of Twenty-seven Hundred and Twenty (\$2720) Dollars, now in Power Plant Fund No. 321, of the Department of Health and Charities, be, and the same is, hereby transferred therefrom and reappropriated to Garage Fund No. 724, of said Department.

Section 2. That the sum of Five Hundred (\$500) Dollars, now in Power Plant Fund No. 321, of the Department of Health and Charities, be, and the same is, hereby transferred therefrom, and reappropriated to Hospital General Fund No. 216, of said Department.

Section 3. This ordinance shall take effect from and after its passage and publication according to law.

GENERAL ORDINANCE 25, 1929

ORDINANCE AMENDING GENERAL ORDINANCE NO. 121, 1925

Being an ordinance concerning the government of the City of Indianapolis, providing penalties for its violation, and with stated exceptions repealing all former ordinances, by adding thereto three new sections known as Sections B-714,, B-715, and B-716, and fixing the time the same shall take effect.

Be It Ordained by the Common Council of the City of Indianapolis, Indiana:

Section 1. That General Ordinance No. 121, 1925, being an ordinance concerning the government of the City of Indianapolis, providing penalties for its violation, and with stated exceptions repealing all former ordinances, be amended by adding thereto the following sections:

Section B-714.—DEFINITIONS—A Bulk Oil Storage Station is herein defined as a place where crude petroleum, gasoline, naphtha,

benzine, benzol, kerosine, rock oil, and earth oil, or any other liquid, except such as will stand a test of 150 degrees Fahrenheit, closed cup tester, are stored in wholesale quantities, for wholesale purposes only, where the aggregate capacity of all storage tanks is more than 6,000 gallons.

A Filling Station is defined herein as a place where gasoline, kerosine, or any other fuel for operating motor vehicles, is offered for sale to the public and deliveries are made through measuring pumps or meters into the tanks of motor vehicles.

Section B-715. No Filling Station as defined herein shall be established, erected or installed within a radius of 300 feet of any Bulk Oil Storage Station as defined herein, nor shall any Bulk Oil Storage Station be constructed, erected or installed within 300 feet of any Filling Station as herein defined, nor shall any Filling Station as defined herein be constructed, erected or installed within 300 feet of any place or location where a railway company or any person, firm or corporation has established or proposes to establish an unloading place for unloading the contents of any tank car containing crude petroleum, gasoline, naphta, benzine, camphine, carbon oil, spirit gas, burning fluids, alcohol, spirits of turpentine, kerosine, rock oil, and earth oil.

Section B-716. It shall be unlawful to transfer kerosine, gasoline, or any other fuel for operating motor vehicles from any motor-driven tank truck or horse-drawn tank wagon into the fuel tank of any motor vehicle upon the public streets, alleys, or highways of the City of Indianapolis, Indiana.

Section 2. This ordinance shall take effect from and after its passage, approval by the Mayor, and publication according to law.

Which was read a first time and referred to the Committee on Public Safety.

INTRODUCTION OF RESOLUTIONS

RESOLUTION NO. 3, 1929

WHEREAS, the Interstate Transit, Inc., operating Colonial Stages, have heretofore leased a room at 104 Monument Circle for a ticket office, and now desire to use certain limited curb space in front of this office for the purpose of stopping their buses, loading and unloading passengers, and have made request therefor to the Board of Public Safety, which Board has approved the request under certain terms and conditions stated in the correspondence, copy of which correspondence is filed with this resolution, all subject to the action of this Common Council.

THEREFORE BE IT RESOLVED, That said Interstate Transit, Inc., is hereby given and granted permission, subject to further regulation or even cancellation by the City of Indianapolis, to use a limited amount of curb space, not exceeding sixty (60) feet, in front of their ticket office at 104 Monument Circle, under the direction and regulation of the Board of Public Safety for the purpose of stopping their buses and loading and unloading passengers at such place, the permission being given with the distinct understanding and agreement as disclosed in correspondence with the Mayor of the City of Indianapolis, whereby the City reserves to itself the right of supreme regulation of this privilege now and hereafter, to the advantage or disadvantage of said Interstate Transit, Inc., as the case may be:

AND with the understanding further that the Board of Public Safety may do and have the right and privilege of making and adopting certain detailed rules and regulations as to the use of said curb space, the length of time for buses to remain at said place and such other detail of use as said Board may desire to regulate and control, all without in any way binding the City of Indianapolis to an indefinite term of privilege.

MISCELLANEOUS BUSINESS

John A. Stettler, a representative of the mail carriers of Indianapolis, addressed the Council informally, asking repeal of the Daylight Saving ordinance.

Mr. Michael J. Shav, representing the vicinity of Butler University, spoke to the Council in behalf of his community, requesting the establishment of a fire engine house.

On motion of Mr. White, seconded by Mr. Springsteen, the Common Council adjourned at 9:30 p. m.
