

## REGULAR MEETING

Monday, June 17, 1929, 7:30 P. M.

The Common Council met in the Council Chamber at City Hall, Monday, June 17, 1929, following an informal hearing, at 7:30, by the Works Committee on General Ordinances 34 and 35, 1929. President Edward B. Raub took the chair.

## COMMUNICATIONS FROM THE MAYOR

June 5, 1929.

Mr. President and Members of the Common Council of the City of Indianapolis:

#### Gentlemen:

#### SPECIAL ORDINANCE NO. 7, 1929 (As Amended)

AN ORDINANCE changing the name of ASHLAND AVENUE to CARROLLTON AVENUE, between 5th Street and 63d Street, and fixing a time when the same shall take effect.

## APPROPRIATION ORDINANCE NO. 8, 1929 (As Amended)

AN ORDINANCE appropriating the sum of Eight Hundred

Eighteen Dollars and Ninety-six Cents (\$818.96) from the unexpended balance of the General Fund for the year 1928 to the several executive departments of the City government of the City of Indianapolis, Indiana, and fixing a time when the same shall take effect.

#### GENERAL ORDINANCE NO. 27, 1929

AN ORDINANCE, authorizing the improvement of Hervey Street, from the east property line of East Garfield Drive (new street) to the west property line of Shelby Street, pursuant to Improvement Resolution No. 14161 of the Board of Public Works of the City of Indianapolis, Indiana, and fixing a time when the same shall take effect.

#### GENERAL ORDINANCE NO. 28, 1929

AN ORDINANCE, authorizing the improvement of Orange Street from the east property line of Spruce Street to the west property line of Evison Street, pursuant to Improvement Resolution No. 14162 of the Board of Public Works of the City of Indianapolis, Indiana, and fixing a time when the same shall take effect.

#### GENERAL ORDINANCE NO. 32, 1929

AN ORDINANCE, appropriating and transferring to the City Civil Engineer Gasoline Fund, Special, the sum of Thirty-four Thousand Dollars (\$34,000.00) out of gasoline tax fund now unappropriated, for the repair and maintenance of improved streets and public thoroughfares, bridges, and for labor, material, supplies and equipment necessary thereto, and fixing a time when the same shall take effect.

#### GENERAL ORDINANCE NO. 33, 1929

AN ORDINANCE, authorizing the purchase by the Board of Public Works or its duly authorized agent, one five-ton truck complete with cab, dump body and hoist of wood type or similar and authorizing the trading in thereon of one 1919 model five-ton Packard truck, Car No. 88, authorizing payment for the same out of Street Commissioner's Fund No. 72 and fixing a time when the same shall take effect.

Dear Mr. Holt:

It it my opinion that a contingency has arisen requiring the expenditure of a part, not exceeding \$500.00, of the appropriation "Reserve for Contingencies," Item No. 26 of the Budget of the Department of Finance, and as provided for in Section 4 of Appropriation Ordinance No. 4, 1928.

It is necessary that various briefs, answers and other documents be printed, some of which have already been prepared, in connection with the litigation regarding the Citizens Gas Company property, and these will, of course, have to be put in bound form for use by the courts and attorneys. It is also probable that some additional expense will have to be incurred and paid in connection with the handling of this litigation by the attorneys in case they should have to go to other places and thereby incur traveling and hotel expense.

I am, therefore, determining and recommending that the sum of \$500.00 be appropriated for expenditure in connection with the litigation regarding the Citizens Gas Company property now pending in the United States District Court here at Indianapolis.

AN ORDINANCE, authorizing the sale of certain appraised property located at the Municipal Airport and aviation field of the City of Indianapolis, and fixing a time when the same shall take effect.

WHEREAS, the following property which is now located on the Municipal Airport, is of no further use or benefit to the City of Indianapolis and should be appraised and sold:

One two-story, five-room frame house and three out buildings located on the former Feller farm;

One one-story, three-room frame house and five out buildings located on the former W. I. Hoag farm;

Aproximately six acres of wheat on the farm of Charlotte H. Dunn McCuen;

Approximately fifteen acres of wheat, five acres of timothy and twenty acros of clover on the former Oscar Hoffman farm;

Approximately twelve acres of timothy on the former Mariette Pierson farm:

Approximately nine acres of clover and fifteen acres of wheat on the former Jot E. Foltz farm:

Approximately thirteen acres of wheat and six acres of clover on the former Oyler farm;

Approximately thirty-five acres of clover and thirty-five acres of wheat on the former Granite Improvement Company's tract of land and all the timber on the property formerly owned by the Granite Improvement Company, Edwin and Oscar King, H. Oscar Hoffman and Albert Hoffman, trustee, being in all approximately One Hundred Nine and Six-Tenths (109.6) acres of timber.

Timber on the following described land:

Parcel No. 1—Being a part of the northwest quarter of the southeast quarter of section 22 in township 15 north, range 2 east, Wayne township, formerly known as the Albert Hoffman Trustee farm, containing 16.85 acres.

Parcel No. 2—Being a part of the northeast quarter of section 22 in township 15 north, range 2 east, and also a part of the southeast quarter of section 15 in township 15 north, range 2 east, all in Wayne township, formerly owned by the Granite Improvement Company, containing 71:5 acres.

Parcel No. 3—Being a part of the east half of the southeast quarter of section 22, in township 15 north, range 2 east, in Wayne township, formerly owned by Edwin and Oscar King, containing 8:5 acres.

#### THEREFORE:

Be It Ordained by the Common Council of the City of Indianapolis, Indiana:

Section 1. That the property described in the preamble hereof and located on ground now known as the Municipal Airport and aviation field of the City of Indianapolis, is of no further use or benefit to the City of Indianapolis and the same should be appraised and sold according to law.

Section 2. The Board of Public Works of the City of Indianap-

olis, is hereby directed and authorized to take the necessary steps and procedure by petitioning the Judge of the Marion Circuit Court to appoint three (3) disinterested freeholders of the City of Indianapolis to appraise all of the above described property and upon approval by the Judge of the Marion Circuit Court of the appraisers' report of appraisat to sell the said personal property to the highest and best bidder at public or private sale as the Board sees fit. The Board of Public Works is further authorized hereby to sell the said personal property for cash or to receive the appraised value thereof as part of the consideration in any contract that the Board may make pursuant to law for the clearing and grubbing of the said airport site.

Section 3. This ordinance shall take effect from and after its pasasge and approval by the Mayor.

AN ORDINANCE, approving a certain contract granting The C., C., C. & St. L. R. R. Co. the right to lay and maintain a sidetrack at the northwest corner of Missouri and Georgia Streets, according to blue print attached, in the City of Indianapolis, Indiana.

#### PETITION

To Board of Public Works, City of Indianapolis:

#### Gentlemen:

In order to provide adequate team track facilities for industries located in the west part of the city and patronizing our Railway Company, we, the C. C. & St. L. Ry. Co. propose to build a team track and driveway at the northwest corner of Missouri and Georgia Streets. This track will have to cross West street just north of our existing tracks and the first alley east of West Street and a portion of this same track will be located in Georgia Street. The proposed crossing at West Street will be at the grade of the present pavement and no part of the track at Georgia Street will disturb the existing driveway along the street. We therefore respectfully apply for permission to lay and construct the track across West Street, Georgia Street and alley.

NOW, THEREFORE, This agreement made and entered into this 6th day of June, 1929, by and between The Cleveland, Cincinnati, Chicago & St. Louis Ry. Co., a corporation, party of the first part, and the City of Indianapolis, by and through its Board of Public Works, party of the second part.

WITNESSETH: That the party of the first part, being desirous of securing a right-of-way for a sidetrack or switch from the west line of West Street to a point in Georgia Street east of West Street and also across an alley in the City of Indianapolis, which is more specifically described as follows: West Street and Georgia Street Crossing. commencing at the intersection of the west line of West Street with the north line of Georgia Street, measure southwardly 15 feet to point "A," the point of beginning of proposed track; thence measure eastwardly at right angles to west line of West Street and along a curve to the left having a radius of 359.26', a distance of 176 feet to point "B" as the place where proposed track leaves Georgia Street and enters the property of said Railway Company, said point "B" being in the north line of Georgia Street about 85 feet east of northeast corner of Georgia and West Streets. Alley Crossing—commencing at the intersection of the north line of Georgia Street and west line of first alley east of West Street, measure northwardly 14 ft. to point "C," as the place where proposed track enters the said alley; thence measure northeastwardly 12 feet to point "D," the place where track leaves the alley, said point "D" being about 18 feet north of northeast corner of Georgia Street and first alley east of West Street, hereby covenants and fully binds itself, its successors, legal representatives and assigns, that, in consideration of the grant of the privileges and authority herein given, it will lay, construct and maintain said track upon the terms and conditions hereinafter set forth, to-wit:

- (1) They shall be so laid, improved and kept in repair as to be safe for persons on foot, in vehicles or otherwise, and shall, at all times, be subject to the orders of the Board of Public Works of the City of Indianapolis.
- (2) Said track and switch shall be laid upon such grade as shall be established by said Board, and shall be put down under its supervision and to its satisfaction and approval. Said track shall be raised or lowered to conform to any grade which may, from time to time, be hereinfater established, whenever so ordered, in writing, by said Board, and shall be made to conform in all respect with any ordinance passed by the Common Council or with any resolution or resolutions made by said Board, for the elevation or depression of said tracks.
- (3) The crossing where said track intersects West Street shall, at all times, be kept improved and in repair and free from obstructions or defects of any kind. No car or cars shall be permitted to obstruct such crossing or to be thereon except for such time as may be absolutely necessary in moving them back and forth, and they shall be at no time stopped or detained thereon in such manner as to obstruct public travel.
- (4) Said party of the first part agrees, upon the written order of said Board, made for any good cause affecting the interest of the City or the public welfare, to take up and remove said track, and upon said party's failure so to do, upon such notification in writing, of ten

(10) days, to promptly pay the cost of having the same done, and the party of the first part hereby releases all claims for damages whatsoever that may arise by reason of such removal; and in removing said track or causing the same to be done, said Board shall in no wise become a trespasser.

- (5) The party of the first part agrees to pave between said track to the entire satisfaction of the second party, and in case said tracks shall be or become out of repair or in need of being reconstructed, or become in any way defective (of which fact the Board shall be the exclusive judge), it shall be the duty of the said party of the first part to promptly repair or remove same, failing in which, after notification in writing of ten (10) dayss, said Board shall do or cause the same to be done at the expense of the said party of the first part and for which expense and cost the said party of the first part shall be liable.
- (6) The said party of the first part herein binds itself to hold said party of the second part and said city harmless from any and all claims for damages growing out of the existence, maintenance or use of said track, and to pay any judgment, with costs, that may on that account be rendered against the said party or said city, and also to pay all necessary expenses that may be incurred by said city in defending against any such claims.
- (7) Any violation of any of the provisions of this instrument by said party of the first part, or by any one for it or at its instance or with its permission, shall operate as an immediate and absolute forfeiture of the privileges and authority given or granted by this contract, provided, however, that the same may be terminated by said Board as hereinbefore set forth.

Said party of the second part by virtue of the provisions of an act of the General Assembly of the State of Indiana, entitled "An act concerning municipal corporations," approved March 6, 1905, and in consideration of the things hereinbefore set forth and upon the terms and provisions stipulated, hereby gives, grants and duly vests said party of the first part the right, privilege and authority to lay and maintain an additional sidetrack or switch across streets and alleys hereinbefore mentioned in the City of Indianapolis, all as shown by the drawing attached herein, filed herewith and for greater certainty marked "Exhibit A."

## GENERAL ORDINANCE 40, 1929

AN ORDINANCE dividing the City of Indianapolis into Two Hundred Fifty-Five (255) Election Precincts, defining the boundaries thereof, repealing all ordinances and parts of ordinances in conflict therewith, and fixing the time when the same shall take effect.

Be It Ordained by the Common Council of the City of Indianapolis, Indiana:

Section 1. That the City of Indianapolis be and the same is divided into Two Hundred Fifty-Five (255) Election Precincts, and the boundaries thereof shall be as follows:

#### FIRST PRECINCT—FIRST WARD

Beginning with the center line of Emerson Avenue at its intersection with the south line of the right-of-way of the Union Traction Company of Indiana; thence south along the center line of Emerson Avenue to the north right-of-way of the C., C. C. & St. L. R. R. Co.; thence southwesterly along said right-of-way to the center line of School Street extended south; thence north along the center line of School Street extended south and the center line of School Street to the south right-of-way of the Union Traction Company of Indiana; thence east along said right-of-way to the center line of Emerson Avenue, the point of beginning, shall constitute the First Precinct of the First Ward of the City of Indianapolis, Indiana.

#### SECOND PRECINCT—FIRST WARD

Commencing at the intersection of the center line of School Street with the center line of Twenty-Eighth Street; thence west along the center line of Twenty-Eighth Street to the center line of Olney Street; thence north along the center line of Olney Street to the right-of-way

of the Union Traction Company of Indiana; thence east along said right-of-way to the center line of School Street; thence south along the center line of School Street to the center line of Twenty-Eighth Street, the point of beginning, shall constitute the Second Precinct of the First Ward of the City of Indianapolis, Indiana.

General Ordinance 38, 1929, was read a third time by the Clerk, as amended, and passed by the following rollcall vote: "Ayes, 9, viz: Mr. Buchanan, Mr. Harris, Mr. Lieber, Mr. Meurer, Mr. Nicholson, Mr. Rathert, Mr. Springsteen, Mr. White and Pres. Raub."

On motion of Mr. White, seconded by Mr. Harris, the Council adjourned at 8:50 P. M.
