This subdivision consists of one hundred (100) lots, with streets. The size and numbers of lots, and widths of streets, are shown on this plat. Distances given are in feet and decimal parts thereof. "A" is the beginning point; "A-B"—the north line; "B-C"—the east line, and "A-D"—the west line of the west half ($\frac{1}{2}$) of the northwest quarter of section two (2)."

Honorable Edward Raub, Councilman, City of Indianapolis, City Hall, Indianapolis, Indiana:

Dear Mr. Raub:

There is no group more sincerely interested in the new municipal airport than the members of the Solo Club. There are members in this group who have been actively engaged in fiying ever since the World War, and aviation as a vocation, will continue to interest a large percentage of our members. For these reasons the club feels sincerely interested in aiding the city to provide a well advanced plan to take care of aviation development.

We singly and as a group have considered entrance into the port, and feel that the method of reaching the same is one of the primary factors, which will later determine the ports success or failure to a large degree. We wish you to know that we feel the winding, narrow and difficult to follow route, out Kentucky and Oliver avenues would be a distinct disadvantage to the port. Such a route would fail to take into consideration the desirability of making it easy for persons west of the city as well as our own citizens to reach the port. We feel after due consideration that a broad entrance north to the National Road is by far the better method of entrance and the most easily and quickly developed.

There is also no doubt about its being the cheapest broad route to acquire, as only \$30,000.00 is needed to provide a 100-foot roadway north to the National Road. The other, or the Kentucky and Oliver avenue route would require broadening and straightening and extensive improvement for one-half of the total distance from the centre of the city to the port, and our citizens are now familiar with the high cost of such improvement.

We therefore respectfully urge that you take immediate steps to acquire the ground necessary for the entrance from the National Road. We are anxious that all reasonable speed be used in the completing of Indianapolis's new aviation centre so that our city will soon be in a fair way to compete with other progressive cities in bringing the new aviation manufacturers here to Indianapolis.
