## INTRODUCTION OF APPROPRIATION ORDINANCES

## APPROPRIATION ORDINANCE 14, 1929

AN ORDINANCE, authorizing the Board of Public Safety to purchase stop signs of types not operated mechanically, for use on public streets and places in this city, appropriating from the estimated unappropriated and unexpended balance of the general fund for the year 1929 the sum of five thousand dollars (\$5,000) to Police Department Fund No. 44 of the Board of Public Safety for said purpose, repealing Appropriation Ordinance No. 4, 1929, and fixing a time when the same shall take effect.

Be It Ordained by the Common Council of the City of Indianapolis, Indiana:

Section 1. That the Board of Public Safety of the City of Indianapolis is hereby authorized to purchase stop signs of types not operated mechanically, for use on public streets and places in this city, and that there be and hereby is apropriated out of the estimated unappropriated and unexpended balance of the general fund for the year 1929 and transferred to Police Department Fund No. 44 of the Board of Public Safety the sum of five thousand dollars (\$5,000) for the purpose of purchasing said stop signs.

Section 2. Appropriation Ordinance No. 4, 1929, passed by the Common Council of the City of Indianapolis on May 9, 1929, and approved by the mayor on May 15, 1929, is hereby repealed.

Section 3. This ordinance shall be in full force and effect from and after its passage and approval by the mayor and publication according to law.
