COMMUNICATIONS FROM THE MAYOR

Gentlemen:

In RE: Police Station—Indianapolis Att'n.: Mr. Dammeyer.

Gentlemen:

Inclosed please find herewith two blue prints of a plan showing

proposed addition to the Indianapolis Police Station for increasing the space for taking care of prisoners. These plans show fourteen (14) individual prison cells to be constructed in the 3d story above the present cells, east of the Turnkey's office.

We are also inclosing our estimate for the cost of this work. These cells are to be constructed with steel plate sides and backs and hard steel grating and doors front and top. The floors to be constructed of concrete, ceiling to be insulated against heat and cold, and then plastered. The walls are to be plastered. The present roof which leaks in a number of places is to be repaired or possibly replaced with an entire new roof.

Each one of the cells is to contain two bunks, a water closet and a lavatory. The entire inside of the room, together with all of the cells to be given two coats of lead and oil paint. Ample heat is to be provided in the entire room. A doorway is to be cut through the west wall of this room to gain access into the present 3d floor court rooms. This work is also to include some changes in the 2d floor Turnkey partition, so that prisoners can be taken up the stairway without going through the Turnkey's private desk room.

This plan was submitted to Mr. Worley, Chief, who gave his entire approval. It will take about two to three weeks to make working drawings and specifications before taking bids.

GENERAL ORDINANCE 91, 1929

AN ORDINANCE, authorizing the permanent improvement of Morgan street by grading and paving the same pursuant to Improvement Resolution No. 14442 of the Board of Public Works of the city of Indianapolis, Indiana, and fixing a time when the same shall take effect.

City of Indianapolis, Ind.

WHEREAS, the Board of Public Works of the city of Indianapolis, Indiana, having heretofore on the 9th day of October, 1929, confirmed Improvement Resolution No. 14442 for the permanent improvement of Morgan street from Richland street to Lee street in the city of Indianapolis by grading and paving the same and remonstrances having been filed thereagainst within the time provided by law and the Board of Public Works of the city of Indianapolis, Indiana, resolved that the proposed improvement covered by Improvement Resolution No. 14442 is of public utility, general benefit and convenience, NOW THEREFORE

Be It Ordained by the Common Council of the City of Indianapolis, Indiana:

Section 1. That the permanent improvement of Morgan street from Richland street to Lee street in the city of Indianapolis, is of public utility, general benefit and convenience and that such improvement be made and completed pursuant to Improvement Resolution No. 14442 of the Board of Public Works of the City of Indianapolis, Indiana. Said improvement to be done all in accordance with details, plans and specifications submitted by the City Civil Engineer in said resolution and pursuant to the laws of the State of Indiana governing improvements of the nature contained in said resolution No. 14442.

Section 2. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

GENERAL ORDINANCE 92, 1929

AN ORDINANCE, providing for and authorizing the City Controller, for and on behalf of the city of Indianapolis, to borrow the sum of seventeen thousand dollars (\$17,000.00) and for the sale of thirty-four (34) bonds of five hundred dollars (\$500.00) each of said city, payable from the general revenues and funds of said city or from the sinking fund of said city, or as may be required by law, for the purpose of procuring money to be used for the remodeling and repairing the city prison and enlarging the capacity of the same, and providing for the time and manner of advertising the sale of said bonds and the receiving of bids for the same, together with the mode and terms of sale, appropriating the money received from said sale to the Board of Public Works of the City of Indianapolis, and fixing a time when this ordinance shall take effect.

WHEREAS, on October 18, 1929, the Board of Public Works of the city of Indianapolis adopted its Miscellaneous Resolution No. 370,

providing for the remodeling, repairing and enlarging the capacity of the city prison of the city of Indianapolis, and authorizing the employment of an archtect to submit plans and specifications; and

WHEREAS, plans and specifications and drawings have been submitted to the Board of Public Works, entailing an estimated expenditure for said remodeling, repairing and enlarging of said city prison in the amount of seventeen thousand dollars (\$17,000.00); and

WHEREAS, there is not now and will not be sufficient funds in the treasury of the city of Indianapolis with which to meet the aforesaid expenditures for the improvements indicated, and there being no appropriation heretofore made by the Common Council therefor, and it being necessary for the said city of Indianapolis to borrow the aforesaid total of seventeen thousand dollars (\$17,000) in order to procure a fund to be devoted to the purposes set out herein as aforesaid and to issue and sell its bonds in said amount, payable from the general revenues and funds of the said city, or as may be otherwise authorized or required by law, including an act of the General Assembly of the State of Indiana, entitled "An Act Concerning Municipal Corporations," approved March 6, 1905, and all acts amendatory thereof and supplemental thereto; NOW, THEREFORE,

Be It Ordained by the Common Council of the City of Indianapolis, Indiana:

Section 1. That the City Controller be and he is hereby authorized for the purpose of procuring money to be used in the repairing, remodeling and enlarging the capacity of the city prison of the city of Indianapolis, to prepare, issue and sell thirty-four (34) bonds of the city of Indianapolis, Marion county, Indiana, of five hundred dollars (\$500.00) each, which bonds shall bear the date of January 2, 1930, and shall be numbered one (1) to thirty four (34), both inclusive, and shall be designated "Municipal Improvement Bonds of 1929, Second Issue," and shall bear interest at the rate of four and one-half per cent ($4\frac{1}{2}$ %) per annum, payable semi-annually, on the 1st day of January and the 1st day of July each year of the period of said bonds; and said bonds shall be issued in ten (10) series, of which each of the first nine (9) series shall be three (3) bonds of five hundred dollars (\$500.00) each, and the tenth series shall be seven (7) bonds of five hundred dollars (\$500.00) each. The first series of said bonds shall be due and payable on January 1, 1932, and one of said series shall be due and payable on the first day of each year thereafter, until and including January 1, 1941.

The interest on said bonds shall be evidenced by proper coupons thereunto attached, for the payment of said semi-annual interest, and the first coupon attached to each bond shall be for the interest on said bond from the date of issue until the first day of July, 1931. Said bonds and the interest coupons thereunto atached shall be negotiable and payable at the office of the City Treasurer of the city of Indianapolis at Indianapolis, Indiana, and said bonds shall be signed by the Mayor and City Controller of the city of Indianapolis and attested by the City Clerk, who shall affix the seal of said city to each bond, and the interest coupons attached to said bonds shall be authenticated by

a lithographic facsimile of the signature of the Mayor and City Controller of said city engraved thereon, which shall for all purposes be taken and deemed to be equivalent to a manual signing thereof; said bonds shall be prepared by the City Controller of said city in due form, irrevocably pledging the faith and credit of the city of Indianapolis, Indiana, to the payment of the principal and interest stipulated therein, respectively. It shall be the duty of the City Controller, at the time of the issuance and negotiation of said bonds, to register in the book kept for that purpose, all of said bonds so issued and negotiated in serial numbers, beginning with the bond numbered one (1), giving also the date of issuance, the amount, date of maturity, rate of interest, and the time and place where said interest shall be payable; and said bonds shall be substantially in the following form, all blanks for numbers and dates to be properly filled in before the issuance thereof.

Section 2. The City Controller shall, as soon as possible after the passage of this ordinance, advertise for bids or proposals for said bonds, by at least one (1) insertion each week for two (2) weeks in two (2) daily newspapers of general circulation, printed and published in the English language in the city of Indianapolis, Indiana, and as required and authorized by law, and may otherwise advertise for such bids or proposals as he may deem advisable. Such advertisement shall describe said bonds with such detail as the City Controller may see fit, and shall set forth the amount of the bonds to be sold and the rate of interest they may bear; the date of opening bids or proposals therefor, the terms of sale, the right of the City Controller to reject any and all bids, the amount of deposit each bidder shall be required to make, and when and where the bonds shall be delivered and paid.

Section 3. Each and every bid and proposal shall be presented to the City Controller sealed, and shall be accompanied by a duly cerfiffed check or cashier's check, upon some responsible bank or trust company in the city of Indianapolis, payable to the order of the City Treasurer for a sum of money which shall equal two and one-half per cent $(2\frac{1}{2}\%)$ of the face or par value of the bonds bid for or proposed to be purchased. The City Controller shall continue to receive all bids or proposals therefor at the office of the City Controller until eleven (11) o'clock a. m. on the day fixed by the City Controller and designated in the advertisement for receiving bids or proposals, at which time and place and between said hour and twelve (12) noon, of said day, he shall open said bids or proposals, and shall continue to receive bids at said time and place from day to day thereafter until said bonds

are sold. The City Controller shall award said bonds, or as he shall see fit a part or any number thereof, to the highest and best bidder therefor, but said City Controller shall have the right to reject any and all of such bids or proposals or any part thereof, and shall have the right to accept a part of any bid, and to award upon any bid the whole or a less number of bonds covered by said bid, he being the sole judge of the sufficiency or insufficiency of any kind. He may also in his judgment and discretion award a part of said bonds to one bidder and a part to another. These provisions shall apply to the case of reoffering and readvertising of said bonds as hereinafter provided.

In case the City Controller shall reject all bids submitted, or if he shall award only a part of said bids, he shall readvertise the bonds remaining unsold in the manner as herein prescribed for the original advertisement, but in such readvertisement he is authorized and directed to fix the date and time both of receiving and opening bids or proposals, and for purchasers to take up and pay for the bonds which may be awarded. And he shall continue from time to time in like manner to readvertise said bonds for sale until said bonds are sold.

In case any bid or proposal shall not be accepted and there shall be no award of bonds thereon by the City Controller, he shall thereupon return to such unsuccessful bidder the certified or cashier's check accompanying the same. If the City Controller shall award the whole or any part of the bonds upon any bid or proposal he shall deliver the certified or cashier's check accompanying same to the City Treasurer, who shall thereupon present the same for payment and shall be entitled to collect the same and shall hold the proceeds collected thereon until the completion of the purchase and the payment for the bonds so awarded. If, for any reason, said check shall not be paid upon presentation, such non-payment shall be taken and deemed a breach of contract for purchase of said bonds upon the part of the purchaser, and the city, in that event, shall have the right to readvertise said bonds for sale at once, and shall, in such event, retain said check and shall have the right to collect the same for its own use, and said check and proceeds thereof, when collected, shall be taken and deemed as agreed and liquidated damages for such breach of contract, and as a payment thereof to the city. In case any successful bidder shall fail to complete the purchase price of the bonds so awarded and to pay for the same within the time and manner herein required, or which may be prescribed by the City Controller as herein provided, the proceeds of such certified or cashier's check deposited by such bidder shall be taken, considered and deemed as agreed and liquidated damages for the breach of such bidder's contract of purchase and shall be taken and deemed as a payment to the city for such damages, and shall be retained and held by said city for its use, but if such successful bidder shall complete the purchase of said bonds awarded to him pursuant to the provisions hereof and his bid and award thereon, said proceeds of said certified or cashier's check shall thereupon be returned to such bidder, or at the option of the City Controller at the time of the completion of the sale and payment of the bids said proceeds of said certified or cashier's check may be applied and deemed a payment on account of the purchase of said bonds.

AN ORDINANCE, amending Section A-411 of General Ordinance No. 121, 1925, being an ordinance concerning the government of the city of Indianapolis, Indiana, by adding sub-section (E) thereto, and fixing a time when the same shall take effect.

Be It Ordained by the Common Council of the City of Indianapolis, Indiana:

Section 1. That Section A-411 of General Ordinance No. 121, 1925, being an ordinance concerning the government of the city of Indianapolis, Indiana, be amended by adding thereto sub-section (E) as follows:

"Sub-section (E). The provisions of this section shall not apply to public garages provided suitable fire extinguishers capable of pro-

tecting every square foot of space of each floor are placed on each floor of any garage; and provided further that the capacity and placing of such fire extinguishers shall be in accordance with the recommendations and specifications of the building commissioner and the chief of the fire forces of the city of Indianapolis."

Section 2. This ordinance shall take effect from and after its passage, approval by the Mayor and publication according to law.

Be It Ordained by the Common Council of the City of Indianapolis, Indiana:

Section 1. That the twenty-fifth line of section 1 of General Ordinance No. 8, 1929, being an ordinance approving the order of the Board of Public Safety of the city of Indianapolis designating a bus stop location on the Monument Circle at the English Hotel, be amended to read as follows:

"On the southwest segment of the Monument Circle."

Section 2. This ordinance shall take effect from and after its passage and approval by the Mayor.

Mr. White made a motion that a Special Committee of three be appointed by the President to arrange for a hearing and make any preliminary investigation necessary. The motion was seconded by Mr. Springsteen, and adopted by majority vote, Mr. Meurer voting "no."

President Raub appointed Mr. Meurer as chairman of the special committee. Mr. Meurer refused to serve as chairman. President Raub then appointed Mr. Lieber, chairman, Mr. Harris and Mr. Meurer as the committee. Mr. Meurer refused to serve on the committee. President Raub then appointed Mr. Buchanan as the third member of the committee.

On motion of Mr. White, seconded by Mr. Springsteen, the Council adjourned at 8:30 P. M.
