INTRODUCTION OF RESOLUTIONS

By Board of Health:

RESOLUTION 8, 1929

WHEREAS, the Board of Health of the City of Indianapolis after thorough investigation and consideration and by its own resolutions adopted and spread of record, has recommended to the City Council that there is immediate necessity for additional funds to be used by said board in the employment and use of methods and measures to control, eradicate and prevent the spread of a disease, namely spinal meningitis, within the corporate limits of this city, and

WHEREAS, it is necessary for said Board of Health to adopt extraordinary methods and measures requiring the expenditure of sums of money not anticipated at the time of the adoption of the budget for said Board of Health for said fiscal year, and

WHEREAS, the Mayor of said city and the City Controller have and do now recommend to this Council that there is immediate necessity for an appropriation not exceeding Five Thousand (\$5,000.00) to be appropriated from the Fund No. 2-26 Reserve for Contingencies in the budget of the Department of Finance. NOW, THEREFORE,

Be It Resolved by the Common Council of the City of Indianapolis, Indiana:

First. That the sum of Five Thousand Dollars (\$5,000.00) or so much thereof as may be necessary is hereby appropriated for expenditure by said Board of Health for the purposes above stated, said expenses to be incurred and accounted for by said Board of Health upon requisitions and vouchers directed to the office of the Controller to be paid out of said appropriated amount as in similar cases made and provided.

Second. This resolution shall become effective immediately upon its passage and approval by the Mayor.

By Street Commissioner:

RESOLUTION 9, 1929

WHEREAS, the Board of Public Works by and through its Street Commissioner's Department, after thorough investigation and consideration, does recommend to the City Council that there is immediate necessity for additional funds to be used by said Board of Public Works by and through its Street Commissioner's Department in the employment and use of methods and measures to clean up and remove the heavy snow now on the streets of the City of Indianapolis; and

WHEREAS, it is necessary for said Board of Public Works to expend sums of money not anticipated at the time of the adoption of the budget for said Board of Public Works and Street Commissioner's Department for the fiscal year of 1929; and

WHEREAS, the Mayor of said city and City Controller have and do now recommend to this Council that there is immediate necessity for the appropriation and authorization of the use of a sum not exceeding four thousand five hundred fifty dollars (\$4,550.00) now in Fund No. 2-26, Reserve for Contingencies, in the Department of Finance.

NOW, THEREFORE,

Be It Resolved by the Common Council of the City of Indianapolis, Indiana;

(1) That the sum of Four Thousand Five Hundred Fifty Dollars (\$4,550.00), or so much thereof as may be necessary, is hereby authorized to be expended by said Board of Public Works by and through its Street Commissioner's Department for the purposes above stated, said expenses to be incurred and accounted for by said Board of Public Works by and through its Street Commissioner's Department upon requisitions and vouchers directed to the office of the Controller of said city, to be paid out of said Fund No. 2-26 heretofore appropriated as in similar cases made and provided.

(2) This resolution shall become effective immediately upon its passage and approval by the Mayor.
