AN ORDINANCE, transferring moneys from certain numbered

WHEREAS, there is a deficit in certain numbered funds and surplus in other numbered funds of the Department of Public Health and Charities of the City of Indianapolis, and

WHEREAS, as extraordinary emergency exists for the transfer and re-appropriation of the funds hereinafter described for the proper carrying on of the necessary functions and duties of the Department of Public Health and Charities of said city.

Be It Ordained by the Common Council of the City of Indianapolis, Indiana:

Section 1. That the sum of nineteen hundred dollars (\$1,900.00) now in Tuberculosis Industrial Hygiene Fund No. 11 of the Department of Public Health and Charities be, and the same is hereby transferred therefrom and reappropriated to the following numbered funds of said department: five hundred dollars (\$500.00) thereof to Tuberculosis Fund No. 11; twelve hundred dollars (\$1,200.00) thereof to Tuberculosis Fund No. 12; two hundred dollars (\$200.00) thereof to Tuberculosis Fund No. 343.

Section 5. That the sum of one hundred dollars (\$100.00) now in Tuberculosis Industrial Hygiene Fund No. 333 of the Department of Public Health and Charities be, and the same is hereby transferred therefrom and reappropriated to Tuberculosis Fund No. 36 of said department.

Section 6. That the sum of three hundred dollars (\$300.00) now in Prenatal and Dental Fund No. 3431 of the Department of Public Health and Charities be, and the same is hereby transferred therefrom and reappropriated to Child Hygiene Fund No. 316 of said department.

Section 7. Section 18. That the sum of seven hundred (\$700.00) dollars, now in City Hospital Laboratory Fund No. 343 of the Department of Public Health and Charities, be, and the same is hereby, transferred therefrom and reappropriated to City Hospital General Fund No. 317, of said department.

Section 19. This ordinance shall take effect from and after legal publication, passage and approval by the mayor.
