PROCEEDINGS OF BOARD OF EQUALIZATION.

THIRD SESSION—August 30, 1879.

The Common Council and Board of Aldermen of the City of Indianapolis, together with the City Clerk and City Assessor, met as a Board of Equalization, in the Council Chamber, on Saturday evening, August 30th, A. D. 1879, at eight o'clock, pursuant to adjournment.

- PRESENT—His Honor, John Caven, Mayor, and, ex officio, President of the Common Council, in the chair; Benj. C. Wright, City Clerk; William Hadley, City As-sessor; Aldermen Chandler, Drew, Mussmann, Newman, Piel, and President Ridenour; and Councilmen Bieler, Brown, Carey, Dowling, Hamilton, Kahn, King, Lamb, Morrison, McKay, O'Connor, Rooker, Shilling, VanVorhis, and Wiese-24.
- ABSENT-Aldermen Coburn, Grubbs, Layman, and Seibert; and Councilmen Bermann, Bryce, Downey, Harmening, McGinty, Pearson, Prier, Sheppard, Tucker, and Wood-14.

His Honor, Chairman Caven, read section 59 of the City Charter, in which is defined the powers and duties of the Board of Equalization, and also the following section from "An Act supplementary to 'An Act to repeal all General Laws now in force for the Incorporation of Cities, prescribing their Powers and Rights, and the manner in which they shall exercise the same, and to regulate such other matters as pertain thereto (approved March 5th, 1877)," viz. :

SEC. 9. In such city, all the powers and duties of the Common Council, as defined in previous Acts of the General Assembly of the State of Indiana, shall be exercised by the joint action of the Common Council and the Board of Aldermen.

And then held, that there being a majority of the joint membership of the Common Council and Board of Aldermen in attendance, the necessary quorum was present, and the Board of Equalization was competent to enter upon the transaction of business.

The select committee appointed by this Board at its first session, held on the 20th instant, submitted the following report; which was duly approved:

To His Honor, the Mayor, Members of the Common Council and Board of Aldermen of Indianapolis, in joint session assembled as a Board of Equalization:

Alderman Chandler moved to substitute "seventy-seven (77) cents"; which motion was also defeated by the following vote:

- NAYS, 11-viz. Alderman Drew; and Councilmen Brown, Dowling, Hamilton, Kahn, King, Morrison, McKay, O'Connor, Rooker, and VanVorhis.

Councilman Hamilton moved to substitute "seventy-two (72) cents"; upon which motion no vote was taken, the next highest sum to the one which last failed of adoption being named in the original resolution.

The general tax-levy for 1879 was then fixed at seventy-five (75) cents by the following vote:

The original resolution was then duly adopted by the following vote:
