# INTRODUCTION OF GENERAL ORDINANCES

#### GENERAL ORDINANCE No. 67, 1930

AN ORDINANCE to amend General Ordinance No. 114, 1922, and amendments thereto, and fixing a time when the same shall take effect.

# BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the U3 or business district and the A4 or 1,200 square foot area district and the H1 or 50 foot height district be and the same are hereby amended, supplemented and extended so as to include the following described territory:

Beginning at a point on the west property line of Illinois street at a point 230 feet north of the north property line of 38th street; thence north on and along the west property line of Illinois street a distance of 240.2 feet to the south property line of 39th street; thence west on and along the south property line of 39th street a distance of 132 feet to the east property line of the first alley west of Illinois street; thence south on and along the east property line of said alley a distance of 239.94 feet to a point; thence east a distance of 132 feet to the point or place of beginning.

Sec. 2. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor and publication according to law.

AN ORDINANCE amending General Ordinance No. 114, 1922, and amendments thereto, commonly known as the Zoning Ordinance.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the U3 or business district, the A3 or 2,400 square foot area district, and the H1 or 50 foot height district, be and the same are hereby amended, supplemented and extended so as to include the following described territory:

Beginning on the south line of 49th street as now laid out at the northeast corner of lot twenty-eight (28) in Hinesley's Fairview Park addition to the City of Indianapolis, as per plat thereof recorded in plat book 16, page 25, in the office of the Recorder of Marion County, Indiana; thence west along the north lines of lots twenty-eight (28) and twenty-seven (27) in said Hinesley's Fairview Park addition a distance of two hundred and ninety-four and fifty-six hundredths (294.56) feet to the east line of Rookwood avenue in said City of Indianapolis, said point also being the northwest corner of lot twenty-seven (27) in said Hinesley's Fairview Park addition; thence south along the west lines of lots twentyseven (27) and twenty-six (26) in the aforesaid addition a distance of ninety-seven and ninety-four hundredths (97.94) feet to the south line of lot twenty-six (26) in said Hinesley's Fairview Park addition; thence east along the south line of said lot twenty-six (26) extended east one hundred and fifty-four (154) feet to the southwest corner of lot twenty-nine (29) in said Hinesley's Fairview Park addition; thence south along the west line of lot thirty (30) in said addition, forty-nine (49) feet to a point in the southwest corner of said lot thirty (30); thence east along the south line of said lot thirty (30) one hundred and forty-one and four hundredths (141.04) feet to the west line of Hinesley avenue; thence north along and with the west line of Hinesley avenue one hundred and forty-six and ninety-four hundredths (146.94) feet to the place of beginning.

Sec. 2. This ordinance shall take effect from and after its passage, approval by the Mayor and publication according to law.

Hensley, doing business under the firm name and style of James W. Hensley & Company, and fixing a time when the same shall take effect.

# BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the contract heretofore entered into by and between the City of Indianapolis, by and through its Board of Public Works and the Superintendent of its Municipal Airport and with the approval of its Mayor, and James W. Hensley, doing business under the firm name and style of James W. Hensley & Company, which contract provides for the installation of a ten-inch (10") well at the Municipal Airport, a copy of which contract is hereto attached, made a part hereof and marked "Exhibit A", be and it is hereby in all things ratified, confirmed and approved.

Sec. 2. This ordinance shall take effect from and after its passage and approval by the Mayor.

#### EXHIBIT A

THIS AGREEMENT, made and entered into this 4th day of August, 1930, by and between the City of Indianapolis, Marion County, Indiana, by and through its Board of Public Works and the Superintendent of its Municipal Airport, with the approval of its Mayor, party of the first part, and James W. Hensley, doing business under the firm name and style of James W. Hensley & Company, party of the second part, WITNESSETH:

In consideration of the covenants and agreements herein contained, the parties hereto agree as follows:

(1) Party of the second part agrees to construct, drive and install a ten-inch (10'') driven well on the site of the Municipal Airport of the City of Indianapolis, and to furnish all labor and material necessary to complete said work, for the sum of Eight Dollars (\$8.00) per lineal foot. Said well to be encased with a ten-inch (10'') standard well casing and to be equipped with one or more strainers, as may be necessary to secure sufficient flow of water from the different strata of not less than forty (40) gallons of potable water per minute, said flow to continue for a period of twenty-four (24) hours. Said water to be tested by a competent chemist to be selected by the party of the first part.

(2) The party of the second part further agrees that in the event he is unable to secure a flow of forty (40) gallons of potable water

per minute from said well as herein provided, then in that event the price for the work herein provided for shall be Four Dollars (\$4.00) per lineal foot. No payment shall be due or made to the party of the second part until it is shown to the satisfaction of the party of the first part that said well when completed will furnish the amount of potable water as stated above.

(3) Party of the second part agrees to commence work immediately upon receipt of notice from the party of the first part, and to continue the work herein provided until ordered to discontinue by party of the first part.

(4) Party of the second part further agrees to provide a bond in the penal sum of \$2,000.00, with sufficient surety to the approval of the party of the first part, conditioned upon the faithful performance of all the terms and provisions of this agreement. Party of the second part further agrees to carry compensation and public liability insurance and to indemnify the party of the first part against any and all loss or damage to persons or property resulting from the installation and construction of said well.

(5) It is understood by the parties hereto that the price herein agreed to be paid for the installation and construction of said well shall not become due and payable to said party of the second part until said well is completed and accepted by the party of the first part.
