Dear Sir:

In checking over the budgets under the Department of Public Safety we find that the balance remaining in several funds in the dog pound and East Market budgets is insufficient to carry the department through the remainder of the year for actual necessities. Some of the funds are entirely depleted, thus crippling the operation of the department very materially; therefore, we are respectfully requesting you to prepare an ordinance to present to the Common Council asking for transfers to these various funds as follows:

Transfer Four Hundred and Seventy-five Dollars (\$475.00) from the Building Department Budget—Fund No. 11—Salaries—Smoke Inspector, and reappropriate as follows:

Two Hundred Fifty Dollars (\$250.00) to Market Fund No. 25-Repairs.

Fifty Dollars (\$50.00) to Market Fund No. 34-Institutional and Medical.

One Hundred Twenty-five Dollars (\$125.00) to Market Fund No. 38-General Supplies.

Fifty Dollars (\$50.00) to Market Fund No. 41-Building Materials.

Transfer Three Hundred Eighty Dollars (\$380.00) from the Building Department Budget—Fund No. 11—Salaries—Smoke Inspector, and reappropriate as follows:

Fifty Dollars (\$50.00) to Dog Pound Fund No. 25-Repairs.

One Hundred Twenty Dollars (\$120.00) to Dog Pound Fund No. 31-Food.
