INTRODUCTION OF GENERAL ORDINANCES

AN ORDINANCE to require the Cleveland, Cincinnati, Chicago & St. Louis Railway Company to establish, maintain and operate flash lights at certain grade street crossings on its lines in the City of Indianapolis, providing penalties for a violation of this ordinance, repealing conflicting ordinances, and declaring a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY. OF INDIANAPOLIS, INDIANA:

Section 1. That the Cleveland, Cincinnati, Chicago & St. Louis Railway Company shall, within ninety (90) days from the passage of this ordinance, establish, maintain and operate for twenty-four (24) hours each day flash lights at the respective intersections of its lines and the following streets at grade in the City of Indianapolis, Indiana, to wit: Sherman Drive near its intersection with Massachusetts Avenue, Avondale Place, Olney Street, Rural Street, Keystone Avenue, Fletcher Avenue, English Avenue and State Street, the same to take the place of other protection now maintained at such crossings.

- Sec. 2. That all ordinances in conflict with this ordinance shall be and are hereby repealed.
- Sec. 3. Any person failing to comply with this ordinance or any of its provisions, or violating any of the provisions thereof, shall, on con-

viction thereof, be fined in any sum not exceeding One Hundred Dollars (\$100.00), and each day's violation shall constitute a separate offense.

Sec. 4. This ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
