APPROPRIATION ORDINANCE NO. 6, 1963

An Ordinance, appropriating, transferring, reappropriating,

and reallocating the sum of Fifteen Hundred Dollars (\$1,500.00), from certain specific, designated items and funds in the Board of Flood Control Commissioners, to certain other items and funds in the same department, created by virtue of the 1963 Budget, General Ordinance No. 62, 1962, declaring an emergency and fixing a time when the same shall take effect.

GENERAL ORDINANCE NO. 36, 1963

An Ordinance to amend the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, and more particularly Title 4, Chapter 4 thereof, by the addition of subsections to Section 4-403 altering prima facia speed limits on certain streets, providing a penalty for the violation of same and fixing a time when said amendment shall take effect.

GENERAL ORDINANCE NO. 37, 1963

An Ordinance to amend the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, and more particularly Title 4, Chapter 6 thereof, by the addition of a subsection to Section 4-602 providing for one-way vehicular traffic on certain streets, providing a penalty for the violation of same and fixing a time when said amendment shall take effect.

GENERAL ORDINANCE NO. 38, 1963

An Ordinance to amend the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, and more particularly Title 4, Chapter 9 thereof, by the addition of a subsection to Section 4-929, creating and establishing two hour parking meter zones, providing a penalty for the violation of same and fixing a time when said amendment shall take effect.

GENERAL ORDINANCE NO. 39, 1963 (AS AMENDED)

An Ordinance authorizing the City of Indianapolis to make Temporary Loans in amounts totaling Three Million Nine Hundred Thousand Dollars (\$3,900,000.00) for the use of the General Fund of the City of Indianapolis at specified times and

for specified amounts, during the six months period beginning July 1, 1963 and ending no later than December 31, 1963, in anticipation of current taxes of the City of Indianapolis actually levied and in the course of collection for the fiscal year in which said loan is made payable; providing for the interest to be charged therefor; empowering the controller to issue tax anticipation warrants to evidence such loan at such time and amount and for such duration as needed, providing for the legal notice of sale, and the time when said loan shall mature; and fixing a time when this ordinance shall take effect.

GENERAL ORDINANCE NO. 40, 1963

An Ordinance authorizing the City of Indianapolis to make temporary loans in the amounts totaling Three Hundred Thousand Dollars (\$300,000.00), for the use of the Board of Trustees of the Indianapolis Firemen's Pension Fund of the City of Indianapolis, in anticipation of and payable out of the current taxes for the Indianapolis Firemen's Pension Fund actually levied for said fund, and in the course of collection for the fiscal year in which said loan is made payable; to be borrowed at such times and in such amounts as is needed during said period; and fixing a time when this ordinance shall take effect.

GENERAL ORDINANCE NO. 41, 1963

An Ordinance authorizing the City of Indianapolis to make temporary loans in amounts totaling Three Hundred Sixty Thousand Dollars (\$360,000.00) for the use of the Board of Trustees of the Indianapolis Police Pension Fund of the City of Indianapolis, at specified times and in specified amounts in anticipation of and payable out of the current taxes for the Indianapolis Police Pension Fund actually levied for said fund, and in the course of collection for the fiscal year in which said loan is made payable; to be borrowed at such times and in such amounts as is needed during said period and fixing a time when this ordinance shall take effect.

GENERAL ORDINANCE NO. 42, 1963

Section 2. That said loading zone is hereby declared to be subject to all existing traffic and parking regulations, and to any later ordinances and regulations as may be applicable.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor and publication as required by law.

Section 2. That said loading zone is hereby declared to be subject to all existing traffic and parking regulations, and to any later ordinances and regulations as may be applicable.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and compliance with all laws pertaining thereto.

GENERAL ORDINANCE NO. 49, 1963

AN ORDINANCE, creating a new position of Personnel Supervisor for the Indianapolis Police Department, and transferring funds for payment of salary, setting out qualifications and giving job description.

SECTION 1. The following position created and established under General Ordinance No. 66, 1962, as amended (Budget Ordinance of the City of Indianapolis), is hereby eliminated.

11. Salaries and Wages—Regular
1 First Grade Patrolmen _____\$4,800.00

SECTION 2. The following position is established and the annual salary therefor is fixed as follows:

1. SERVICES—PERSONAL

11. Salaries and Wages-Regular

CIVILIAN EMPLOYEES

1 Personnel Supervisor _____\$9,000.00

SECTION 3. The salary heretofore appropriated for the position eliminated, is hereby made available and transferred to the new position by this ordinance created, and the same shall be available for such purpose, from and after the passage of this ordinance.

SECTION 4. The transfer and the use of funds involved in the elimination of said position and the creation of the other, constitute a shift of funds within one budget item and involve no additional experditure, requires no additional appropriation, and accordingly does not affect the existing budget or tax rate by requiring any increase therein.

SECTION 5: The funds now provided for one (1) First- Grade Patrolman will be unused during 1963, due to the fact that the number of First Grade Patrolmen do not equal the number budgeted in General Ordinance No. 66, 1962. The amount of \$4,800.00 will be sufficient to pay the salary of the Personnel Supervisor of the Indianapolis Police Department for the remainder of the year 1963.

SECTION 6. The Personnel Supervisor of the Indianapolis Police Department shall have the following prerequisite qualifications:

- (a) An undergraduate university or college degree with reasonable course work in the substantive aspects of personnel management.
- (b) A minimum of two (2) years experience in personnel work. in either a governmental position or in private business.

SECTION 7. The duties of the Personnel Supervisor of the Indianapolis Police Department within said Police Department are as follows:

- 1. To develop and maintain a continuous program of recruitment to insure that high standards of selection are maintained.
- 2. To select in close co-operation with line commanders tests which select those best qualified for police work and to conduct such tests for the purpose of screening applicants.
- 3. To provide technical assistance in developing and administering a promotional system designed to select and promote the most qualified to positions of increased responsibility.
- 4. To provide guidance in setting up and conducting disciplinary hearings and assisting the line commander in preparing his case for presentation.
- 5. To conduct terminal interviews to determine why persons leave the department.
- 6. To develop and supervise the maintenance of adequate system of personnel records.
- 7. To provide technical guidance in developing and administering a merit rating system within the department.
- 8. To conduct continuing studies into such matter as:
 - (a) What characteristics must individuals possess to become good police officers.
 - (b) Development of criteria for specialized jobs in the department.

SECTION 8. This Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

Which was read for the first time and referred to the Committee on Finance.
