INITIAL MEETING

Wednesday, January 1, 1964 1:00 o'clock, P.M.

The Common Council of the City of Indianapolis met in the Council Chamber in the City-County Building, Wednesday, January 1, 1964 at 12:00 P.M. CST.

The newly elected City Clerk Angeline Allstatt, temporarily sitting in the President's chair in the Common Council chambers in the City-County Building in the City of Indianapolis, announced that following the City General Election of November 5, 1963, the Election Canvassing Board had issued election certificates to the following successful candidates:

John J. Barton: Mayor.

Max E. Brydenthal, James L. Cummings, Albert O. Deluse, R. Thomas McGill, Daniel P. Moriarty and Joseph C. Wallace, majority members, and Harold J. Egenes, Thomas C. Hasbrook and Rufus C. Kuykendall, minority members of the Indianapolis City Council:

Angeline Allstatt, City Clerk.

The City Clerk then announced that John J. Barton as Mayor had filed his certificate of election and had taken the oath endorsed thereon and had assumed his duties as Mayor of the City and that she, as City Clerk, had done likewise, and that it was now in order for the duly elected members of the Common Council to assume their offices, they like-

wise having filed their certificates of election and taken the oath endorsed thereon. Mrs. Allstatt stated the following call had been given to the newly elected members of the Council.

The Chairman called the meeting to order.

The Deputy Clerk called the roll.

Present Mr. Brydenthal, Mr. Cummings, Mr. Deluse, Mr. Egenes, Mr. Hasbrook, Mr. Kuykendall, Mr. McGill, Mr. Moriarty and Mr. Wallace.

The Clerk announced that pursuant to the rules of the Common Council heretofore ordained, the first order of business would be for the organization of the Council and the election of Council Officers and asked for the nominations for President of the Council.

Mr. Deluse made a motion to nominate Mr. Wallace. The motion was seconded by Mr. Kuykendall.

Mr. McGill made a motion that the nominations be closed. Mr. Cummings seconded this motion.

Mr. McGill made a motion that the Acting Clerk be instructed to cast the unanimous vote of those present for Mr. Wallace. The motion was seconded by Mr. Deluse.

The vote was cast as directed and the acting chairman announced the election of Mr. Wallace as President of the Council for the year 1964. On invitation of Mrs. Allstatt, Mr. Wallace took the chair.

President Wallace asked for nominations for the office of Vice-President.

Mr. McGill placed the name of Mr. Moriarty in nomination for Vice-President. The nomination was seconded by Mr. Deluse. Mr. Hasbrook moved that the nominations be closed and that the clerk be instructed to cast a unanimous ballot for Mr. Moriarty.

The motion was seconded by Mr. Kuykendall.

The vote was cast by the Clerk as directed and President Wallace announced the election of Mr. Moriarty as Vice-President of the Council.

On motion of Mr. Egenes seconded by Mr. Deluse the Common Council adjourned at 1:20 P.M.
