INTRODUCTION OF RESOLUTIONS

RESOLUTION NO. 1, 1964

A RESOLUTION authorizing expenditure of funds by the City Board of Works for a Metropolitan Transportation Engineering Study and Survey, as approved under General Ordinance No. 92, 1963.

BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. This Council has heretofore approved (under General Ordinance No. 92, 1963), the Metropolitan Transportation Engineering Study and Survey as being vitally necessary for the future development of transportation, public and private, and for all future use and location of thoroughfares and interstate highways in this City of Indianapolis and County of Marion.

Section 2. This Council had some reservation as to the source of financing of the City's portion of the cost of such study, but now resolves the same.

Section 3. It is accordingly finally RESOLVED by this Common Council that the City's position of the cost of this Study \$63,000.00 is approved, if the same be paid out of budgeted funds duly appropriated and authorized; but if payable out of any other available funds only with the written approval of the State Board of Accounts directed to the attention of the City Controller.

Ellsworth Maxwell, Executive Secretary, of the Board of Works asked that Resolution No. 1, be made a special order of business.

Councilman McGill, moved that Resolution No. 1, not be considered until the next Council Meeting.

This was seconded by Councilman Moriarty.

Councilman Deluse made a motion that President Joseph C. Wallace again be elected to represent the Common Council as its member on the Metropolitan Plan Commission of Marion County. The motion was seconded by Councilman Moriarty and carried unanimously.

President Wallace, introduced a large group of students from Miss Nancy Adams' class on U. S. Government of Howe High School who attended the meeting.

On motion of Mr. Hasbrook seconded by Mr. Deluse the Common Council adjourned at 8:20 P.M., EST.
