Section 2. The Lender shall make available to the Indianapolis Firemen's Pension Fund, the following specific sums on the date indicated.

The Board of Trustees of the Firemen's Pension Fund of the City of Indianapolis shall upon issuing of a time warrant for said amount of funds herein specified, be entitled to borrow the amount set out in said warrant, the total of said warrants for such period not however to exceed the sum of Three Hundred Thousand Dollars. Said loans may be repaid on and after November 1, 1964, and not beyond December 31, 1964. The City Controller is hereby empowered to insert the interest as computed and the loan and maturity dates for such warrants.

Section 3. That for the repayment of the principal amount of the temporary loan herein authorized by this ordinance there is hereby appropriated to Firemen's Pension Fund No. 63 — Payment of Temporary Loans (hereby created), out of current revenues and taxes, for the year 1963, payable in the year 1964, for the Firemen's Pension Fund of the City of Indianapolis, the sum of Three Hundred Thousand Dollars (\$300,000.00); and for the payment of interest thereon there is hereby payable out of the amount appropriated to Firemen's Pension Fund No. 61—Interest on Temporary Loans, either out of said appropriated fund or out of the above designated revenues, and taxes, or both, the sum of not to exceed the amount of interest bid by the successful bidder.

Section 4. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and compliance with all laws pertaining thereto.
