INTRODUCTON OF GENERAL ORDINANCES

GENERAL ORDINANCE NO. 106, 1964

Introduced by Councilman Brydenthal

AN ORDINANCE to amend the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, and more particularly Title 4, Chapter 9, thereof, by the deletion and repeal of certain subsections of Section 4-928, providing for one hour parking meter zones on a certain portion of Michigan Street, and fixing a time when said amendment shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That Title 4, Chapter 9, Section 4-928 of the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, be amended by the deletion and repeal thereof, of the following sub-sections, as follows:

- (a) The North side of Michigan Street from the first Alley West of Tremont Street to Holmes Avenue.
- (b) The South side of Michigan Street from Holmes Avenue to Tremont Street, excluding the bus loading zone at Tremont and Michigan Streets.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor, compliance with all laws pertaining thereto and publication, as required by law.

Which was read for the first time and referred to the Committee on Parks.

GENERAL ORDINANCE NO. 107, 1964

Introduced by Councilman Egenes

AN ORDINANCE to amend the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, and more particularly Title 4, Chapter 6, thereof, by the deletion and repeal of a subsection of Section 4-602, providing for one-way traffic on Woodland Avenue, and fixing a time when said amendment shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That Title 4, Chapter 6, Section 4-602, of the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, be amended by the deletion and repeal thereof, of the following sub-section, as follows:

No.STREETFROMTO68Woodland AvenueFairfield AvenueThirty-Eighth (38th) Street

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor, compliance with all laws pertaining thereto and publication, as required by law.

Which was read for the first time and referred to the Committee on Elections.

GENERAL ORDINANCE NO. 108, 1964

Introduced by Councilman Egenes

AN ORDINANCE establishing a certain passenger and/or loading zone in the City of Indianapolis, pursuant to the provisions of the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA

Section 1. That for the purpose of providing the owners or occupants of certain premises fronting on certain public streets in the City of Indianapolis, with ingress and egress for passengers, materials and merchandise coming to or going from such premises, such owners or occupants having complied with the provisions of the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as Amended, Section 4-1001, and the Board of Public Safety, after due investigation, having recommended the establishment of same, the following passenger and/or loading zone be and the same is, hereby established in the City of Indianapolis, to-wit:

Beginning at a point in the west curb line of Olney Street, 32' south of the intersecting south curb line of Nowland Street, as presently established, and extending south a distance of 25 feet.

Section 2. That said loading zone is hereby declared to be subject to all existing traffic and parking regulations and to any later ordinances and regulations as may be applicable.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and compliance with all laws pertaining thereto. Which was read for the first time and referred to the Committee on Elections.

INTRODUCTION OF SPECIAL RESOLUTION

SPECIAL RESOLUTION NO. 11, 1964

Introduced by Councilman Cummings
