SPECIAL RESOLUTION NO. 10, 1966

A Special Resolution requesting that the Sanitary Board of the City of Indianapolis prepare and present to the Mayor, Common Council, and City Controller, certain information regarding sanitary sewer service rendered to non-residents of the City of Indianapolis.

GENERAL ORDINANCE NO. 141, 1966

An Ordinance to amend the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, and more particularly Title 4, Chapter 6 thereof, by the addition of a subsection to Section 4-602, designating streets as one-way streets and prohibiting vehicular movement in the opposite direction thereon, providing a penalty for the violation of same and fixing a time when said amendment shall take effect.

GENERAL ORDINANCE NO. 144, 1966

An Ordinance to amend the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, and more particularly Title 4, Chapter 8 thereof, by the addition of a subsection to Section 4-834-2 prohibiting parking, stopping or standing between 6:00 A.M. and 9:00 A.M., inclusive and 3:00 P.M. and 6:00 P.M., inclusive except on Sundays, on certain streets, providing a penalty for the violation of same, and fixing a time when said amendment shall take effect.

ORDINANCES ON SECOND READING

Mr. Moriarty called for a second reading of General Ordinance No. 88, 1966.

The Clerk read the Ordinance for a second time.

Mr. Moriarty moved that General Ordinance No. 88, 1966 be stricken from the files. The motion was seconded by Mr. Deluse and passed on the following roll call:

Mr. Moriarty called for a second reading of General Ordinance No. 110, 1966.

Mr. Hasbrook presented the following Amendment.

Indianapolis, Ind., December 19, 1966

Mr. President:

I move that General Ordinance No. 115, 1966 be amended by adding at the end of Section 1, and excluding shopping centers of 20

acres or more and excluding establishments licensed and inspected by the Health and Hospital Corporation of Marion County. Except those places whose principal business is as a restaurant or a food market.

- 2. Delete word "place" in Section 3, Paragraph 4, Line 9, adding new parking lot.
- 3. Adding after the words "parking place" in the last line of Section 3, The insurance should provide \$5,000.00 property damage and \$25,000.00 public liability as a minimum for lots where fees are charged for parking. A business liability policy may be shown as proof for lots on which no parking fee is charged.
- 4. Delete in Section 6 the word "January" and insert June 1, 1967.

The motion to amend was seconded by Mr. Egenes but failed to pass on the following roll call:

Ayes 2, viz: Mr. Hasbrook and Mr. Egenes.

Noes 6, viz: Mr. Brydenthal, Mr. Deluse, Mr. McGill, Mr. Moriarty, Mr. Sleet and President Wallace.

Mr. Moriarty moved that General Ordinance No. 115, 1966 be stricken from the records.

Mr. McGill seconded the motion and the motion passed on the following roll call:

Ayes 6, viz: Mr. Brydenthal, Mr. Deluse, Mr. McGill, Mr. Moriarty, Mr. Sleet and President Wallace.

Noes 2, viz: Mr. Egenes and Mr. Hasbrook.

General Ordinance No. 115, 1966 was stricken from the records.

Mr. Egenes called for a second reading of General Ordinance No. 84, 1966, As Amended.

The Clerk read the Ordinance, As Amended, for a second time.

Upon motion of Mr. Egenes, seconded by Mr. McGill, General Ordinance No. 84, 1966, As Amended, be ordered engrossed, read a third time and placed upon its passage.

The Clerk read the Ordinance for a third time, As Amended, and it passed on the following roll call:

Ayes 7, viz: Mr. Brydenthal, Mr. Deluse, Mr. Egenes, Mr. Hasbrook, Mr. McGill, Mr. Moriarty and Mr. Sleet.

Noes 1, viz: President Wallace.

The Council voted unanimously, by voice vote, to hold the next meeting on Wednesday, January 4, 1967 at 7:30 P.M., because of the City-County Building being closed January 2, 1967 for New Year's Day.

Upon motion of Mr. Deluse, seconded by Mr. Sleet, the Council adjourned at 8:30 P.M. upon unanimous voice vote.
