The report from the Committee on Streets and Alleys, in relation to the claim of August Richter, for benefits paid (see page 51, *ante*), was read, and the action of the Common Council concurred in.

The following motions (see pages 56, 57 and 60, *ante*), were read, and concurrently adopted.

That the Citizens' Street Railroad Company be forbidden to scrape the mud, etc., from their tracks and left on crossings, to the great injury of footmen; but that they be required to clean off all crossings where said mud, etc., is placed by such scraping.

That the Street Commissioner be, and is hereby, directed to put a broken stone crossing on the west side of Illinois street across Ray street.

That the Street Commissioner be, and is hereby, directed to put in a broken stone crossing on the west side of Meridian street across Wisconsin street.

That fire-alarm box No. 73 be removed to the corner of Lexington avenue and Linden street, under the direction of the Chief Fire Engineer.

That the Chief of Police be ordered to station an officer at the Illinois street tunnel.

The following resolution (see page 59, ante), was read:

*Resolved*, That the first street west of Munson street, running south from Sanders street, be hereafter known as Eagle street, as the same was not named when the plat was accepted by the city.

Gentlemen:-Your Committee on Railroads, to whom sundry papers were referred, would report:

1st. "WHEREAS, The ordinance vacating a portion of south Illinois street, and granting the same to the Indianapolis Union Railroad Company, provides for the construction, by said company, of a ten-foot passage way on one side of Illinois street; and whereas, the said Indianapolis Union Railway Company has not pro-vided such passage, and has closed Illinois street by illegally placing gates and other obstructions across the same;

Resolved, That the Street Commissioner be, and is hereby, instructed, under the direction and advice of the City Attorney, to remove such obstructions without delay, and that the City Attorney be instructed to give the matter immediate attention. We recommend said resolution be adopted.

"That the Street Commissioner be, and is hereby, ordered to at once comply 2d. with the orders from this body, to remove the unused street car tracks on Noble street, between Michigan street and Massachusetts avenue."

Recommend said motiou be adopted.

Gentlemen:-Your Committee on Streets and Alleys, to whom was referred certain resolutions and motions desire to report:

1st. Is a resolution "That the petition of Mary C. Leser, Abram Richhart and others, praying for the opening of a ten-foot alley running west from West street to Dakota street, south of Morris street, be referred to the Board of City Commissioners, with instructions to assess benefits and damages, and to make due report to the Common Council and Board of Aldermen; the said Commissioners to return all papers and notices. The City Clerk is ordered to issue the proper notices, and the Superintendent of the Metropolitan Police Force is instructed to serve all notices on the said Commissioners and property holders: *Provided*, That before the City Clerk issue any notice, a bond shall be filed in his office, to the approval of the Mayor, guaranteeing the payment of all costs and charges in this matter."

Recommend its adoption.

2d. Is a resolution "That the petition of J. L. Spaulding and others, asking for the opening and extension, to a width of forty (40) feet, the first alley north of the I., B. & W. Railroad, and three hundred and eight (308) feet east of Miley avenue, from Beacon street to the first street north thereof, as prayed for in said petition, and as shown on the plat accompanying the same, be referred to the Board of City

Commissioners, with instructions to assess benefits and damages, and to make due report to the Common Council and Board of Aldermen; the said Commissioners to return all petitions and notices. The City Clerk is hereby instructed to issue the proper notices, and the Superintendent of the Metropolitan Police Force is hereby directed to serve said notices on said Board of City Commissioners and upon the property owners: *Provided*, That before the Clerk issue the said notices to the City Commissioners, a bond shall be filed with said City Clerk, to the approval of the Mayor, guaranteeing the payment of all costs and charges of said Commissioners in this matter."

Recommend its adoption.

3d. Is a resolution "That the petition of Mary C. Leser, Abraham Richart, George C. Eberhard and others, praying for the vacation of the alley 7.58 feet wide, extending from Morris street to the first alley south of Morris street, between West and Dakota streets, be referred to the Board of City Commissioners, together with the plat accompanying the same, with instructions to assess benefits and damages caused by such vacation, and to make due report to the Common Council and Board of Aldermen, the said Board of City Commissioners to return all plats, petitions and notices. The City Clerk is hereby required to issue, and the Superintendent of the Metropolitan Police Force to serve, the proper notices on said Commissioners and interested property owners: *Provided*, That before the City Clerk issues the said notice to the said Commissioners, a bond shall be filed with the said City Clerk, to the approval of the Mayor, guaranteeing the payment of fifty dollars (\$50.00) to the city, in addition to the payment of all costs and charges of said City Commissioners in this matter."

Recommend it be not passed.

4th. Is a motion "That C. M. St. Clair be given permission to construct a driveway across the sidewalk in front of his residence on North street; work to be done at his own expense, under the direction of the City Civil Engineer."

Recommend its passage.

5th. Is a motion calling for stone crossings on Alabama street, on the north side of Wabash street. Recommend it be not passed.

6th. Is a motion granting Geo. Kessler the right to lay a brick driveway acros the sidewalk in front of 119 west Washington street.

Recommend it be not passed.
