

PROCEEDINGS OF BOARD OF ALDERMEN.

REGULAR SESSION—MAY 27, 1889.

The Board of Aldermen of the City of Indianapolis met in the Aldermanic Chamber, Monday evening, May 27th, A. D. 1889, at eight o'clock, in regular session.

MESSAGES AND PAPERS FROM THE COMMON COUNCIL.

That the Street Commissioner is hereby directed to repair the west end of Hanway street, at the J., M. & I. Railroad tracks.

That the Street Commissioner be, and is hereby, directed to put the crossing at Harrison and Noble streets in a passable condition, as the crossing is in a dangerous condition.

That permission be granted Peter Oslon to erect a stand pipe and build platform for street sprinkling on Woodlawn avenue, the consent of the residents having first been obtained.

The report of the Board of City Commissioners, and the following resolution accompanying the same, (see pages 321, 322 and 323, *ante*), was read, and referred to the Committee on Streets and Alleys :

Resolved by the Common Council and Board of Aldermen of the City of Indianapolis, That the report of the Board of City Commissioners in the matter of opening and extending to a width of forty (40) feet, the first alley north of the I., B. & W. Railroad, and three hundred and eighty feet east of Miley avenue, from Beacon street to the first street north thereof, be, and the same is hereby, adopted and approved, and that said street be opened and extended as therein provided, and the land therein described be appropriated: *Provided*, That before the aforesaid alley is opened to the public, the expenses of the Board of City Commissioners herein, and also the amount of benefits assessed over damages, be paid to the County Treasurer, for the city. The City Clerk is hereby directed to certify to the Treasurer of Marion county, Indiana, so much of such report as assesses benefits and damages upon the real estate, giving description thereof, which said benefits he is hereby ordered to collect at once.

The report of the East Market Master, in relation to the sale of Stalls, (see pages 323 and 324, *ante*), was read and received.

The report from the Committee on Public Light (see page 324, *ante*), was read, and the action of the Common Council thereon, concurred in.

The report from the Committee on Public Property, in relation to expenditures in Garfield Park, (see page 324, *ante*), was read, and the action of the Common Council thereon, concurred in.

The following resolution (see page 325, *ante*), was read, and referred to the Committee on Public Property:

Resolved, That the Committee on Public Property be authorized to advertise for bids for the erection of a dam across Pleasant Run, in Garfield Park.

The report from the Committee on Public Property, in relation to the improvement of the Blind Asylum Park (see page 324, *ante*), was read, and referred to the Committee on Public Property.

The report from the Committee on Streets and Alleys, in relation to sundry matters referred to them (see page 325, *ante*), was read, and the action of the Common Council thereon, concurred in.

The communication from H. J. Milligan, Trustee, in relation to the purchase of a tract of ground lying between Brookside and Pendleton avenues (see page 328, *ante*), was read, and the action of the Common Council thereon, concurred in.

The following motions (see pages 327, 328, 330, 331 and 332, *ante*), were read and concurrently adopted:

That the City Civil Engineer be, and is hereby, instructed to re-advertise S. O. No. 107, of 1887.

Moved, That the following recommendation of the Committee on Contracts of March 18th, 1889, be concurred in:

To the Mayor, Common Council and Board of Aldermen:

Gentlemen.—Your Committee on Contracts, to whom was referred the proposals received December 17, 1888, have examined the same, and find them to be as follows:

For grading and graveling the first alley north of Louisiana street, from East street to New Jersey street.

Being a tie bid, and the same being low, we recommend the contract be awarded to Cooper & Haywood.

That Jacob Woessner be granted permission to lay a bowldered driveway in front of his property at 541 Virginia avenue, at his own expense, under the direction of the City Civil Engineer.

That the Board of Public Improvements and Street Commissioner be directed to confer with the County Commissioners and learn what arrangement can be made for the city to take the broken stone, so as to keep the prisoners at work, and the city use the stone in repairing the streets, and whether a vacant piece of ground could not be leased cheap for dumping the broken stone on by the car load, so as to be convenient for the Street Commissioner to distribute.

That the Committee on Public Health be directed to investigate the Public Bath House management, complaint being made that the place has become a public nuisance, and a disgrace to citizens living in that vicinity, nude men being reported as exposing themselves to the outside public, and cursing and swearing being heard most all times during the day.

The following resolution (see page 327, *ante*), was read :

Resolved by the Common Council and Board of Aldermen of the City of Indianapolis, That it is deemed necessary to improve Morton street, from East street to Gray street, by grading and graveling the roadway and sidewalks, in accordance with the profile and specifications on file in the office of the City Civil Engineer. The total cost of said improvement shall be assessed per lineal foot upon the real estate abutting on said Morton street, between East street and Gray street, (except the proportion thereof occupied by street and alley crossings, which shall be assessed against the City of Indianapolis.) Said assessments, if deferred, to be paid in ten installments. A bond or bonds shall be issued in anticipation of the collection of said assessments, unless the property owners pay said assessments before said bond or bonds are issued, all as provided for by an Act of the General Assembly of Indiana, approved March 8th, 1889. And the City Clerk be, and he is hereby, ordered to give the required legal notice to the property owners along the line of said proposed improvement, and the time and place when and where objections can be made to the necessity for such improvement.

That the Committee on Streets and Alleys and City Attorney be directed to select two citizens to add to their committee, and that said committee, when so constituted, be requested to inform themselves thoroughly as to what plans will be best for building a viaduct over the railroad track on Virginia avenue; what the railroad companies will do towards its erection, and the probable cost of such a construction. Also, that said committee be authorized to cause an appraisement to be made by competent persons, as to the probable damages that may have to be paid to property owners on the line, the cost of making said appraisement not to exceed one hundred dollars (\$100.00,) and that when they have fully informed themselves, they report to this Council.

The Committee on Public Property, through Alderman Laut, submitted the following report; which was read and received:

Indianapolis, May 27th, 1889.

To the Mayor, City Council and Board of Aldermen:

Gentlemen:—The Committee on Public Property, to whom was referred the improvement of Garfield Park, respectfully report the progress of the work, and the expenditures made for the following purposes:

A large amount of grading and graveling has been done upon the walks and drives, and is being rapidly completed.

An upright board fence, six feet high, with posts and rails new, and with old boards from the amphitheater and sheds, has been put up eighty rods in length, on the south line of the Park, at a cost, for new lumber, \$109.28; nails, \$4.40; labor, \$73.96. Total..... \$ 187 54

On the west and north lines of the Park, adjoining the garden of the Bose heirs—which is at the northwest corner of the Park—an upright board fence has been constructed, twenty rods in length, of old boards and posts, at a cost for labor and nails..... 32 20

A wooden wagon bridge over Bean Creek has been constructed out of old lumber and timber, at a cost of..... 54 18

A wooden foot bridge has also been built out of old lumber and timber, over Bean Creek, at a cost of..... 45 00

An iron bridge has been completed over Pleasant Run—cost..... 1,591 10

The stone abutments at a cost of..... 985 49

An iron fence on the north end, with two carriage gates and four small gates, of the Cleveland patent, is contracted for, and about completed, at a cost of..... 435 00

Two water-gates on Pleasant Run have been made out of old lumber; cost..... 20 00

The barn has been repaired, at a cost of..... 12 00

Four privies have been built, mainly of old lumber, at a cost of..... 32 00

A large number of trees—fourteen hundred and seventy-nine (1,479)—have been purchased and planted out at various places on the Park, such as a double row across the north end; a row on each side of each of the walks and drives, where there were none, in all parts of the Park; also, a row along the east side, and various clumps and groups at suitable points, at a cost of \$355.39. In addition, six hundred and fifty small trees have been purchased, at a cost of \$22.50, and planted in a nursery, for future transplanting—making the entire number of trees purchased and planted out, twenty-one hundred and twenty-nine (2,129). These trees have been well set out, and are now doing well; only a few have so far failed to leaf out. The cost of these trees has been the sum of..... 377 89

In addition, the Park has been presented with fifty-eight trees by Gamaliel Scott, Esq., who carefully planted them with his own hands.

Senator David Turpie also presented several trees and plants from the Congressional Gardens.

Edward Teas, Esq., of Dunreith, Indiana, also presented six hundred and fifty-four small trees, consisting of 500 Catalpa Spiera, 134 Spiera Billardi, and 20 Strawberry trees—all of which are planted in nursery rows.

Your Committee thus publicly thank these gentlemen. By this it will be seen that the whole number of trees set out this spring, is 2,852. The greater part of the nursery trees and shrubs will be fit to be transplanted in one and two years.

This report does not cover the amounts expended for labor in grading, graveling, sodding, and in planting trees, nor expenditures for tools, implements, lumber, and other minor matters, which will be set forth in a future report. The heaviest expenditure has been for labor.




