REPORTS, ETC., FROM STANDING COMMITTEES.

The following report from the Chief Fire Engineer was read, and referred to the Committee on Fire Department:

Indianapolis, June 3d, 1889.

To His Honor, the Mayor, Common Council and Board of Aldermen:

Gentlemen:—The recently purchased Aerial Hook and Ladder Truck has been received and accepted by the Fire Committee and myself, and is now ready to be placed in service. In order to supply proper protection to the north and north-eastern portion of the city, I have arranged quarters for the Truck now stationed at Headquarters, adjoining Engine House No. 5, the work having been accomplished by the members of the Department, at a comparatively nominal cost; and in order to carry such to the proper standing, it will require an addition to the membership of the Department. Also, to plank the switch track in the alley just north of Ninth street; and in case they fail to do so in five days, then the Street Commissioner is directed to do the work, and collect the cost off of said railroad company.
