MESSAGES AND PAPERS FROM THE COMMON COUNCIL.

Gentlemen:—The matter of the remonstrance against the improvement of Market street, from Missouri street to Blackford street, having been referred to us, we see no reason why the ordinance providing for said improvement should not be passed, as in our opinion it is a public necessity. We therefore recommend the passage of said ordinance.

The following motion was read; and the action of the Common Council in referring the said motion with instructions (see page 900, ante) was concurred in:

That the Street Commissioner be instructed to immediately attend to the filling up of a man trzp, in the shape of an old well or cistern, that is gaping open under the sidewalk on the southwest corner of Delaware and South streets.

The following motions were read; and the operation of a certain resolution, requiring motions for the extension of time to be accompanied with certain recommendations, was suspended unanimously, and the motions (adopted by the Council—see pages 900 and 901, ante) were concurrently adopted:

That J. L. Spaulding be granted ninety (90) days additional time to complete his contract for the improvement of King street, from Pennsylvania street to Delaware street.

That contractor Henry Clay be given sixty days more time in which to finish his contract on Columbia avenue.

That contractor Henry Clay be given sixty days more time in which to finish his contract on the first alley north of Prospect street, from Spruce street.

The following motions (adopted by the Common Council—see page 902, ante) were concurrently adopted:

That the Street Commissioner be, and is hereby, ordered to furnish for the use of the City Sexton the lumber necessary for the proper protection of the roadways at the entrance to Greenlawn Cemetery.

That the Street Commissioner be, and is hereby, ordered to extend with brick the sidewalks at the crossings in and along the improved portion of Mississippi street, where the sidewalks were improved with brick before the new improvement was made on said street.

The following resolution was read; and referred to the Committee on Streets and Alleys:

Resolved, That the name of Wilson street, from Hill avenue to Brookside avenue, be changed to Newman street, and the street east of lots 10 and 17, Albert E. Fletcher's first addition, running from Brookside avenue to Clifford avenue, be named Newman street.

The following motion (adopted by the Common Council—see page 904, ante) was read, and concurrently adopted:

WHEREAS, By the terms of a certain lease, dated August 8th, 1878, the City of Indianapolis, agrees to pay all taxes and assessments for the term of five years, including the taxes for 1878, on lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 12, 18, 14, 15, 16, 17 and 18 in Metzger and Robinius' subdivision of lots 1, 2 and 3, in square 70 (the West Market space); and,

WHEREAS, On February 13, 1879, lots 1, 2, 3 and 4 of the foregoing lots were sold for State and county taxes, to Josiah Locke, for the taxes of 1877 and 1878,

and were sold for \$161.03; therefore,

Moved, That the City Attorney be, and is hereby, instructed to report to this body, at its next regular meeting, on what terms the city can redeem the aforesaid

The following entitled ordinance was read the first time:

S. O. I56, 1880—An Ordinance to provide for grading and paving with brick the west sidewalk of Park avenue, between Cherry street and Gregg street.

The following entitled ordinance was read the first time; and referred to the Committee on Public Light:

S. O. 157, 1880—An Ordinance to provide for the erection of lamp posts, lamps and fixtures (complete to burn gas, except the service pipes) on West street, between Kentucky avenue and Georgia street.

The following entitled ordinance was read the first time:

S. O. 1, 1881—An ordinance to provide for bowldering the gutters and curbing with stone the sidewalks of Market street, from Missouri street to Blackford street.

REPORTS, ETC., FROM COMMITTEES.

The Committee on Public Charities, through Alderman Hamilton, submitted the following report; which was concurred in:

To the President and Board of Aldermen:

Gentlemen: - Your Committee on Public Charities, to whom was referred the matter relative to the street improvement assessment against the Orphan Asylum property, would report:

On examination, we find that in former assessments made against said property for street improvements, the city has paid the assessment, viz: August 18th, 1873, for block pavement and sidewalk on Tennessee street, \$861.00; also, November 1st, 1875, for grading and graveling Lawrence street, in front of Oak Hill property, \$288.45. Also find that the city has paid assessments against other charitable institutions, viz: Home of Friendless Women, on North Tennessee street, block pavement, September 1st, 1873, \$1,017.41.

In view of the fact that the Orphan Asylum is a charitable institution, supported and maintained by the public, and in all other cases where assessments have been made against the property for street improvements, the city has paid them, we recommend that the action of the Common Council in ordering precepts against

said property be not concurred in.

Recommend that the amount due the contractor be paid by the city, and placed in appropriate ordinance.

Gentlemen:—The undersigned, owners of real estate fronting on Market and Highland streets, respectfully ask your honorable body to concur in the action of the Common Council, in adopting the plan submitted by the Board of Public Improvements, December 6th, 1880, for improving the above named streets.

Fred Knefler, 317½ feet on Market and 333½ feet on Highland st.; Chas. Aldag, 133 feet on Market st.; Henry Latham and Chas. Latham, 301 feet on Market and 333½ feet on Highland st.; C. Zimmerman, 144 feet on Market st.

Om motion, the above remonstrance and petition was referred to the Board of Public Improvements, Joint Judiciary Committee, City Civil Engineer and City Attorney.

Alderman Newman offered the following motion; which was adopted;

That the Board of Public Improvements be instructed to examine Shelby street opposite the Shelby House, as the street is cut by water.

PENDING ORDINANCES.

The following entitled ordinance was read the second and third times:

G. O. 44, 1880—An Ordinance to amend section twenty-four (24) of an Ordinance entitled, "An Ordinance declaring that all vehicles (except Street Railway cars) used in the transporting of persons and articles within the City of Indianapolis for hire or pay, shall be deemed 'public vehicles'; establishing rules and regulations for the government of the owners, lessees and drivers thereof; and prescribing fines and punishments for violations of its provisions."

And it was passed by the following vote:

AYES, 5—viz. Aldermen Layman, Mussman, Newman, Seibert and Tucker.
NAYS, 1—viz. Aldermen Hamilton.
