## Proceedings of Board of Aldermen.

## REGULAR SESSION—October 28, 1889.

The Board of Aldermen of the City of Indianapolis, met in the Aldermanic Chamber, Monday evening, October 28th, A. D. 1889, at eight o'clock, in regular session.

PRESENT—Hon. Granville S. Wright, President of the Board of Aldermen, in the Chair, and Aldermen Connett, Laut, Rail, Reinecke, Reynolds, Smith, and Tousey—8.

ABSENT, 2-viz: Alderman Clark, and Taylor.

The Proceedings of the Board of Aldermen for the regular session held October 14th, 1889, having been printed and placed on the desks of the Aldermen, said Journals were approved as published.

MESSAGES AND PAPERS FROM THE COMMON COUNCIL.

The following estimate resolution (see page 779, ante), was read:

Resolved by the Common Council and Board of Aldermen of the City of Indianapolis, That the accompanying first and final estimate in behalf of The Western Paving & Supply Company, for grading and paving with Filbert Vulcanite Asphaltic Pavement, the roadway of Pennsylvania street, bowldering between the tracks of the Citizens' Street Railroad, eurbing with stone the sidewalks thereof, from the north line of Washington street to the south line of Ohio street, be, and the same is hereby, adopted as the estimate of the Common Council and Board of Aldermen of said city; and that the property owners are hereby required to pay the sums set opposite their respective names.

And it was concurrently adopted by the following vote:

The communication from W. N. McKeen, in reference to the construction of the viaduct across the Uhion tracks, (see page 779, ante), was read.

That in the opinion of the Council, the foregoing letter is not a satisfactory compliance with the resolution adopted September 16th, 1889, and the promise made by said McKeen to the Mayor and City Attorney, the forepart of the present month, as orally reported by them; and that the City Attorney be, and is hereby, instructed to proceed to carry out said resolution.

The report from the Committee on Contracts, awarding certain contracts, (see page 776, ante), was read, and the action of the Common Council thereon, concurred in.

The report from the Board of Public Improvements and Street Commissioner, reporting expenditures for the month of September, 1889, (see pages 779 and 780, ante), was read and received.

The reports from the Committee on Streets and Alleys, and the following resolutions accompanying the same (see pages 780, 781 and 782, ante), were read and referred to the Committee on Streets and Alleys:

To the Mayor and Common Council:

Gentlemen:—Your Committee on Streets and Alleys, to whom was referred the potition of A. R. Baker, Secretary of the School Board, and others, asking for the vacation of the first alley north of McCarty street, extending from West street to Chadwick street, recommend that the prayer of the petitioners be granted and said alley vacated, on the condition that said School Board cause an alley of like width to be opened along the north line of the second lot north of said vacated alley, as agreed to in their petition, and that the accompanying resolution be adopted.

That L. C. Turner be permitted to open the block pavement on north Meridian street in front of his property, to make connection with water mains. Work to be done under the supervision of the Street Commissioner.

That the Chief Fire Engineer be authorized to fill the cistern at the German Orphan Asylum, by using the engine and hose of Company No. 3.

The communication from the Society of Indiana Florists, in reference to the erection of electric lights in Tomlinson Hall, (see page 754, ante), was read, and the action of the Common Council thereon, concurred in.

The following motion (see page 785, ante), was read, and referred to the Committee on Finance:

That His Honor, the Mayor, be directed to procure twenty-five copies of "Picturesque Indianapolis" for presentation to the South American Delegates on the occasion of their visit to the city, as said work is a good advertisement of the city.

The following entitled ordinances, (passed by the Common Council,) were severally read the first time:

- G. O. 49, 1889—An ordinance requiring the Lake Erie & Western Railroad Company, and the Louisville, New Albany & Chicago Railway Company to station and maintain one flagman at the intersection of said companies' tracks with Lincoln avenue; one flagman at the intersection of said companies' tracks with Seventh street; one flagman at Eighth street, and one flagman at Ninth street.
- S. O. 162, 1889—An ordinance to provide for grading and paving with brick the north sidewalk of Morris street, from Meridian street to West street, and the costs thereof

On motion by Alderman Rail, the Rules were suspended for the purpose of placing G. O. 49, and S. O. 162, 1889, of the foregoing entitled ordinances, on their final passage, by the following vote:

Sewall, et al., for the vacation of a seven-foot alley extending from Park avenue to the first alley east thereof.

Sewall, Susanna Goepper and others, praying for the vacation of the alley running from Park avenue to the first alley east thereof, and lying between Lincoln avenue and Seventh street—said alley being about seven feet and six inches wide at Park avenue, and about six feet and nine inches wide at the east end thereof—be referred to the Board of City Commissioners, together with the plat accompanying the same, with instructions to assess benefits and damages caused by such vacation, and to make due report to the Common Council and Board of Aldermen; the said Board of City Commissioners to return all petitions, plats and notices.
