# PROCEEDINGS OF COMMON COUNCIL.

REGULAR SESSION-DECEMBER 2, 1880.

The Common Council of the City of Indianapolis, met in the Council Chamber, Monday evening, December 2d, A. D. 1889, at 7:30 o'clock, in regular session.

## REPORTS, ETC., FROM CITY OFFICERS.

## The City Attorney submitted the following report; which was read and received:

To the Mayor and Common Council:

Gentlemen:-Since the last meeting of the Council, the following cases have been disposed of:

First, is the case of Melissa A. Ralston et al., vs. Thomas Taggart, Auditor, City of Indianapolis, et al., involving the question of recoupment of taxes charged to have been illegally collected. It was to be made a test for several cases of its class; but after the case was practically put at issue, the court dismissed the entire case at plaintiff's cost.

Second, is the action of Lowe Carey against The City of Indianapolis, Consumers' Gas Trust Company and the Citizens' Street Railroad Company, in which he demanded \$200 00 damages for injuries alleged to have been suffered by him by reason of a horse stepping through a hole over a gas trench between the street railroad tracks at the intersection of Central avenue and Eighth street. Upon trial the court found in favor of all the defendants, including the city, and rendered judgment accordingly. Respectfully submitted,

The City Attorney submitted the following report; which was concurred in:

To the Mayor and Common Council:

Gentlemen:—I have examined the claim of Marion County against the city, for \$8,911.34 on account of the city's portion of the assessment of property for the year ending January 1, 1889, and report that on investigation made by the Auditor and myself, the Auditor struck out one claim of \$871.90, being the item for publishing the delinquent tax list, and \$45.00 for advertising. Furthermore a correction was made in the basis of calculating the city's portion of said assessment, and the Auditor added the total of West Indianapolis, Brightwood and Woodruff Place to the total assessment for Center Township, and this further reduces the city's portion of the total cost of assessing the property in Center Township, and leaves the amount due from the City of Indianapolis to Marion County, \$8,129.66—being a reduction of about \$800.00 on the bill as first presented, and being a few dollars less than the bill for last year's assessment.

I submit herewith a corrected statement from the Auditor, and recommend it be spread of record, so that hereafter it may be used as a proper basis for computing the city's share of such expense. I have caused the same to be placed in the appropriation ordinance, and recommend its payment.

That the Finance Committee and City Clerk be, and they are hereby, directed to prepare and submit to the Council at the next regular meeting, a full and complete statement of the assets and liabilities of the city, together with the amount of the contracts awarded and not paid for.

Councilman Pearson presented the following petition; which was referred to the Committee on Judiciary and City Attorney:
