Gentlemen:—Your Committee on Streets and Alleys, to whom was referred the resolution regarding the vacation of the first alley south of Home avenue, running east from Ash street to the first alley east of Ash street, report that a remonstrance against said vacation has been filed, and recommend that said resolution be not adopted. Gentlemen:—Your Committee on Public Light, to whom was referred the reports of the Committee on Public Light of the Common Council, recommending the erection of electric lights at the following points, viz: one at the intersection of South and Tennessee streets; one at the corner of Noble and Market streets; one at the corner of Noble and Ohio streets; one at the O., I. & W. crossing on west Washington street; one at the intersection of Meek and Cruse streets; one at the corner of Ray and West streets, and one at the corner of Washington and Blackford streets, recommend that the action of the Common Council be concurred in, and said lights located according to contract.

Gentlemen:-Your Committee on Railroads, to whom was referred the following:

" To the Common Council and Board of Aldermen:

Gentlemen: — Your Cammittee to whom was referred an ordinance to prevent the closing of Meridian street, as per G. O. 36, 1886, would report that we held a public meeting in this room Saturday evening, November 16th. It was well attended. Petitions and remonstrances were presented, and much was said bearing upon the closing of Meridian street and building of a viaduct. After giving due consideration to all facts, we are of the opinion that the city officers should persist in their efforts to have the viadvet constructed without delay, and that no action be taken by this body to delay or hinder in the construction of the sume.

We would further recommend, in the event that the Union Railway Company, through the courts, should evade the liability of having to construct the viaduct as contemplated, then, and in that event, said Union Railway Company be compelled to remove all tracks laid across Meridian street since the passage of G. O. 36, 1886. We would also recommend that G. O. 36, 1889, be stricken from the files.
