## REGULAR SESSION-MAY 30, 1881.

Inasmuch as the President of the Union Railway Company did not favor this Council with a report stating the intention of said company to erect or not erect the safety-gates at the Virginia avenue crossing of Union Railway tracks, as directed by this Common Council; therefore

Resolved, That the Street Commissioner be, and is hereby, directed to erect safety-gates at the above crossing, under the direction of the Board of Public Improvements; and that the expense of erecting said gates be charged and collected from said Union Railway Company, unless said gates be erected within thirty days from June 1st, 1881, by the above Union Railway Co.

And it was adopted by the following vote:

AYES, 15—viz. Councilmen Bedford, Bryce, Cole, Dean, Dowling, Egger, Harrold, Hartmann, Koller, Pearson, Pritchard, Stout, Thalman, Ward, and Yoke.

NAYS, 2-viz. Councilmen Morrison, and Weaver.

Councilman Yoke offered the following motion; which was referred to the Committee on Public Property and Board of Public Improvements:

That the Committee on Public Property be, and are hereby, directed to employ a competent person, who shall be qualified to perform the duties of a landscape gardner, and who shall have police powers, at a salary not to exceed \$60.00 per month, who shall superintend the work and labor in the improvement of the Southern Park, under the direction and according to the plans furnished by the City Civil Engineer.

Councilman Yoke offered the following motions; which were adopted:

That the Street Commissioner be, and is hereby, instructed to repave in front of Engine House No 3.

62That the Street Commissioner be, and is hereby, instructed to take up the blocks and repave with blocks in front of Engine House No. 3.

Councilman Dowling offered the following motions; which were adopted:

That the City Marshal be directed to notify the Union Railway Company to erect safety gates across Tennessee, Pennsylvania, Delaware and New Jersey streets within thirty days; and, if not done in said time, said gates be erected by the Street Commissioner, at the expense of said Union Railway Company.

That the Street Commissioner be, and is hereby, directed to lay a plank crossing on the east side of Tennessee street crossing Louisiana street, across the Union Railway Company's track, and crossing also the track of the Indianapolis Rolling Mill Company; and charge, and collect, the cost of said work to each of said corporations in proportion to the amount of labor and cost of material done and placed over their respective tracks.

Councilman Bedford offered the following motion; which was adopted:

That the City Marshal notify the property owners to remove the bridge over the gutters on Massachusetts avenue, across the street from the No. 2 Engine House, as it obstructs the flow of water, and is a nuisance; and, if not done in ten days, the Street Commissioner remove the same and collect off of the property owner.

#### PENDING ORDINANCES.

On motion, S. O. 68 and S. O. 69, 1881, was referred to the Committee on Public Light.

Councilman Fultz was excused for the remainder of this session.

On motion, S. O. 67, 1881, was stricken from the files.

The following entitled ordinance was read the second time, and referred to the Committee on Streets and Alleys:

S. O. 13, 1881—An Ordinance to provide for grading and graveling the first alley east of Laurel street, from the first alley south of Prospect street to Orange street.

The following entitled ordinance was read the second time, ordered engrossed, and read the third time:

S. O. 64, 1881—An Ordinance to provide for grading and graveling the first alley east of the intersection of South street and Virginia avenue, from South street to Virginia avenue.

And it was passed by the following vote:

AYES, 19—viz. Councilmen Bedford, Brundage, Bryce, Caylor, Cole, Coy, Dean, Dowling, Egger, Harrold, Hartmann, Koller, Morrison, Pearson, Pritchard, Thalman, Ward, Wenver, and Yoke.

NAYS-None.

The following entitled ordinance was read the second time, ordered engrossed, and read the third time:

S. O. 66, 1881—An Ordinance to provide for improving New York street, from Delaware street to New Jersey street, by widening the sidewalks, curbing with stone the outer edges thereof, and bowldering the gutters.

And it was passed by the following vote:

AYES 19--viz: Councilmen Bedford, Brundage, Bryce, Caylor, Cole, Coy, Dean, Dowling, Egger, Harrold, Hartmann, Koller, Morrison, Pearson, Pritchard, Thalman, Ward, Weaver, and Yoke.

NAYS-None.

S. O. 71 and 72, 1881, were read the second time, and referred to the Committee on Streets and Alleys.

The following entitled ordinance was read the second time, ordered engrossed, and read the third time:

G. O. 17, 1881—An Ordinance to prohibit geese from running at large within the City of Indianapolis; and prescribing penalties for the violation thereof.

And it was passed by the following vote:

AYES, 12—viz. Councilmen Bedford, Brundage, Bryce, Caylor, Cole, Coy, Dean, Pearson, Pritchard, Thalman, Weaver, and Yoke.

NAYS, 7—viz. Councilmen Dowling, Egger, Harrold, Hartmann, Koller, Morrison, and Ward.

On motion, the Common Council then adjourned.
