## ADJOURNED SESSION-JULY 8, 1881.

The Common Council of the City of Indianapolis met in the Council Chamber on Monday evening, July 8th, A. D. 1881, at eight o'clock, in adjourned session.

#### REPORTS, ETC., FROM CITY OFFICERS.

The City Civil Engineer submitted the following report; which was concurred in, and the City Attorney directed to bring suit against Wm. Kown and his bondsmen, compelling them to complete their contract;

#### REPORTS, ETC., FROM OFFICIAL BOARDS.

The Fire Board, through Councilman Thalman, submitted the following report: which was received, and the several recommendations concurred in:

Indianapolis, July 8th, 1881.

To the Board of Aldermen and Common Council of the City of Indianapolis:

Gentlemen:--Your motions, referred to us for our action, we have carefully considered, and would report as follows:

1st. Is a motion to place a bell and striker on Engine House No. 9. As this will incur an expenditure of some \$1,200, we recommend that it be not concurred in, as it is not essential to the putting out of fires.

2d. Is a motion to locate two 2000-barrel cisterns in the vicinity of Sarven Wheel Works.

We recommend that one cistern be located there, with a capacity of 2000 barrels; such cistern to be located in such place as the Chief Fire Engineer may select.

We have also ordered two extra hydrants located in that vicinity, which we consider will give sufficient protection.

3d. Is a motion to build one 1200-barrel cistern at the intersection of Caven and East streets.

We recommend that this be not built, as we have been unable to locate Caven street.

4th. Is a motion to place a fire-alarm box on the corner of South and Meridian streets.

In this we recommend not to concur, as there are two (2) boxes within two squares of this location.

#### To the Mayor and Common Council:

Gentlemen:—Your Committee on Public Light have had under consideration the question of making a new contract with the Indianapolis Gas Light and Coke Company, to furnish light for the year beginning August 1st, 1881, and terminating July 31st, 1882. In view of the fact that the present contract with the Indianapolis Gas Light and Coke Company has, so far as we have been able to ascertain, been favorable and satisfactory to the citizens generally, your committee recommend the continuance of the same contract for the year ending July 31st, 1882; and we herewith transmit the contract of the Indianapolis Gas Light and Coke Company for your consideration, and which we recommend be accepted, and the Mayor be authorized to execute the same.

The following contract, submitted with the above report, was referred to the Committees on Public Light, Judiciary, and City Attorney:

THIS AGREEMENT, made this — day of \_\_\_\_\_, 1881, by and between the City of Indianapolis, party of the first part, and the Indianapolis Gas Light and Coke Company, party of the second part,

Witnesseth, That whereas, on the 22d day of July, 1876, said parties entered into a contract in writing, whereby the party of the second part undertook and agreed for a period of five years from August 1st, 1876, to furnish gas to light the public lamps of said city, upon the terms therein stated; and

Whereas, On the 2d day of August, 1878, the same parties made a provisional agreement for the furnishing of gas by the party of the second part to the party of the first part, which contract expired August 1st, 1879; and

Whereas, On the 24th day of July, 1879, the same parties made another provisional contract for the furnishing of gas by the party of the second part to the party of the first part, which contract will expire July 31st, 1880; and

Whereas, The same parties made another provisional contract for the furnishing of gas by the party of the second part to the party of the first part on the 2d day of August, 1880, which contract will expire on the 1st day of August, 1881:

Now Therefore, The parties hereto make this provisional agreement for the term of one year from the first day of August, 1881, to-wit:

The said party of the second part agrees to furnish gas to the said party of the first part, of the quality and kind provided for in the third section of the ordinance of the Common Council of said city, enacted March 19th, 1866, for Twenty-four hundred and nineteen (2419) lamps, all of which are now in a serviceable condition in and upon the streets of said city, said lamps to be lighted upon time-tables to be furnished by the said city which tables shall provide for Twenty-five hundred (2500) hours per year for each and every lamp, and the burners thereof shall be of the capacity of not less than four cubic feet per hour for each and every lamp. Said party of the second part also agrees at proper and regular times to light and extinguish said lamps clean and in repair; and if said party of the second part shall fail or neglect to keep the same clean and in repair, the said party of the first part shall have the right to do so and deduct the cost thereof from any sum due said Gas Company.

It is further agreed that the party of the first part shall have the right to deduct from any amount due the said party of the second part the sum of fifteen (15) cents for each and every post for each and every night that it is not lighted and kept lighted during the time provided in the time-table; *provided*, that this provision shall not apply to cases of failure to light and keep lighted that are caused by frost, over which said party of the second part has no control, but said party of the second part agrees to use the utmost reasonable dispatch in thawing out such posts.

The city and her officers shall have the right at any time to test both the quality of the gas furnished and the capacity of the burners on the street lamps. The aforesaid Twenty-four hundred and nineteen (2419) posts shall be such as shall be selected and designated by the proper committee or committees of the Common Council and Board of Aldermen and a representative committee of said Gas Company; and the said party of the second part also agrees to furnish gas for all offices occupied by City Officers, for all Engine Houses, for the Council Chamber, for all Tunnels, Bridges and Station Houses, and all other places where gas is required for the use of said city in her corporate capacity, at the price of two dollars per thousand cubic feet.

In consideration of the foregoing agreements of said party of the second part, the said party of the first part agrees to pay said party of the second part for each and every street lamp of said city to which gas is supplied, the sum of twenty-five (\$25) dollars per annum, or the sum of Sixty thousand four hundred and seventyfive dollars (\$60, 475.00) for said Twenty-four hundred and nineteen (2419) posts; said sum to be full compensation for all gas furnished, and for cleaning, lighting, and keeping in repair and in order for service, such lamps and posts as above undertaken and agreed by the party of the second part. And the party of the first part further does agree to pay for gas furnished said city in her corporate capacity, except street lamps, the price of two dollars per thousand cubic feet, as above mentioned.

The compensation herein agreed to be paid shall be paid by the party of the first part in equal monthly installments at the end of each and every month, and City Warrants or Orders shall be received at par in such payments.

And the party of the first part further agrees with the party of the second part that during the continuance of this contract all fines and damages collected by the said city from persons for breaking or damaging said street lamps or posts, shall be paid, when collected, to said party of the second part

And said party of the second part also agrees that if the city should at any time require a greater number of lamp-posts lighted than above mentioned, the said party of the second part will furnish gas, light and keep the same in repair in the same manner as the said twenty-four hundred and nineteen (2419) lamps above mentioned, and at the same rate; provided, that when new posts shall be crected along lines where new mains are to be laid, then such work shall be performed according to the terms and requirements of section six (6) of said Gas Company's charter of March 19th, 1866; and said party of the second part does further agree to dismantle any gas lamps now erected and re-light in lieu thereof any lamp-posts now erected or that may hereafter be erected upon the lines of existing mains when so ordered by the Common Council and Board of Aldermen during the existence of the present contract and due notice being given by the City Civil Engineer, without any cost to said city.

This contract to take effect from and including the first day of August, 1881, and be and remain in force for the period of one year. After the expiration of the term of this contract the parties hereto are to be remitted to whatever rights they or either of them may have under the contract of March 19th, 1866, the same as if this contract or any other modifying contract had not been made.

In Witness Whereof, The parties hereto, by their proper officers, have hereunto signed their corporate names and caused their corporate seals to be affixed.

9th. For improving New York street, from Delaware street to New Jersey street, by widening the sidewalks, curbing with stone the outer edges thereof, and bowldering the gutters.

- Dunning & Hudson, 99 cents for curbing, and 65 cents for bowldering, per lineal foot front on each side.
- Richard Carr, 90 cents for curbing, and 60 cents for bowldering, per lineal foot front on each side.
- James Mahoney, 45 cents for curbing, and 70 cents for bowldering, per lineal foot front on each side.
- Hefgen & Bernauer, \$1.15 per lineal foot front on each side for curbing and bowldering.
- S. W. Patterson, 40 cents for curbing, and 69 cents for bowldering, per lineal foot front on each side.

The stone curbing for this improvement appears to be of a peculiar "extra finish," adding double the cost of the old style of curbing, which a number of contractors have misunderstood in their bids, and which would create a hardship to property owners having to pay for same, and add nothing, in our opinion, to the durability of the improvement. We recommend that the matter be re-advertised, and the City Civil Engineer be directed to make all his specifications in future for the old style curbing, unless the property owners petition for the "extra finish."

### INTRODUCTION OF MISCELLANEOUS BUSINESS.

WHEREAS, It is currently reported that certain foremen and teams in the employ of the city, have been used for the purpose of building an embankment for private parties, and while engaged in building such embankment, were paid by the city for such work; therefore

Moved, That a special committee of three be appointed to investigate the alleged misdoings of certain employes who work under the supervision of the Board of Public Improvements.

Councilman Egger offered the following motion; which was referred to the Fire Board:

That a two thousand barrel fire cistern be built at the intersection of south East street and Lincoln lane.

Councilman Hartmann offered the following motion; which was referred to the Board of Public Improvements:

To amend ordinance S. O. 81, by striking out the words and curbing with stone.

Councilman Morrison offered the following motion; which was adopted, and Councilmen Morrison, and Hartmann appointed as such committee:

The Hospital Board having reported that the present Hospital is inadequate for the purpose for which it is intended, and that the building is a discredit to the city and should be condemned—accompanying said report is a recommendation that the county and city build a Hospital jointly.

Resolved, That the Chair appoint a committee of five (5), said committee to include the members of the Hospital Board, for the purpose of having a consultation with the County Commissioners, and report what can be done looking to the erection and maintainance of a Hospital by the city and county in a more suitable location, and one that will be a Hospital in fact as well as name.

Councilman Reichwein offered the following motions; which were referred to the Board of Public Improvements;

That the Street Commissioner be, and is hereby, directed to clean gutters on Wabash street, between East and Noble streets.

That the Street Commissioner be directed to put a coat of gravel on Ohio street, between East and Noble streets, to put the same in good order, the gutters having recently been bowldered and curbed.

Councilman Stout offered the following motion; which was referred to the Board of Public Improvements:

That the Street Commissioner be, and is hereby, directed to fill the chuck-holes on Christian avenue, between College avenue and Bellefountain avenues.

Councilman Stout offered the following motion; which was adopted:

That the City Marshal, R. S. Coulter, be, and is hereby, granted leave of absence to visit Europe.

Councilman Thalman offered the following motion; which was adopted:

That the committee to whom was referred the Meridian street ordinance, be directed to amend as follows:

That the crossings of New York street be laid with white cedar blocks; the crossing of Vermont street with red cedar blocks, and the crossing of Michigan street with white pine blocks.

Councilman Yoke offered the following motions; which were adopted:

That Michael Staley be allowed to erect and light a lamp-post, at the corner of Cedar street and Virginia avenue, at his own expense.

That the Committee on Office Fixtures and Supplies, be, and are hereby, instructed to purchase and place in the Mayor's office a suitable book case, for the purpose of preserving the reports of this and other cities, for the use of present and future Councils and Boards.

That the City Marshal be, and is hereby, instructed to enforce the order in regard to removing the present occupant of the Southern Park.

Councilman Ward offered the following motion; which was referred to the Board of Public Improvements:

That the Street Commissioner be directed to fill the chuck-holes on Alabama street, between Michigan and St. Clair streets.

On motion, the Common Council then adjourned.
