COMMUNICATIONS, ETC., FROM THE MAYOR.

Gentlemen:—At a meeting of the Trades Assembly of this city, held on Monday, September 12th, 1881, the following resolutions were adopted; and such action is requested as to your honorable bodies may seem necessary and proper.

Resolved, That the President appoint a Committee on Insecure Buildings, whose duty it shall be to co-operate with the Chief Fire Engineer, or other officers delegated by the city authorities, in the inspection of any and all structures that may properly come under the head of insecure buildings.

Resolved, That said committee shall report from time to time their investigations to this Assembly, that the result of their labors may go into the proceedings of the Assembly as a matter of record.

Resolved, That a copy of these resolutions be furnished to the Mayor of the City of Indianapolis, to be by him submitted to the Board of Aldermen and Council, with the request that they decide upon such action as may be necessary to accomplish the ends herein desired.

REPORTS, ETC., FROM OFFICIAL BOARDS.

The Board of Public Improvements, through Councilman Dean, submitted the following report; which was received and the several recommendations concurred in:

'To the Mayor and Common Council:

Gentlemen:-The Board of Public Improvements, to whom sundry papers were referred, would report thereon as follows:

1st. Is a motion that the Street Commissioner be directed to repair the south Tennessee and Illinois street bridges across Pogues Run; and build approaches to the south Tennessee street bridge over the gutters on both sides of the bridge, as the said bridge is in a dangerous condition, owing to the heighth of the gutters.

Recommend the approaches be built; replanking all ready ordered.

2d. Is a motion that the Street Commissioner be, and is hereby, directed to clean the gutters of Madison avenue, between Merrill and McCarty streets.

Recommend the work be done-

3d. Is a motion that the Street Commissioner be instructed to repair the sidewalks around the East Market.

Recommend that the Committee on Markets have this work done.

4th. Is a motion that the Street Commissioner be, and is hereby, directed to place a double stone crossing across McCarty street, on the east side of Illinois street.

Recommend the work be done.

5th. Is a motion that the Street Commissioner be directed to repair Howard street, from Second street north to Fifth street, by placing a coat of gravel thereon.

Recommend the chuck-holes be filled only.

6th. Is a motion that the Street Commissioner be directed to remove the gutter pipes on Illinois street, at the intersection of Fifth and Sixth streets, and place in lieu thereof bowldered gutters.

Recommend the work be done.

7th. Is a motion that the Street Commissioner be directed to repair the old wooden bridge across the canal near Sixth street, placing the same in good and safe condition.

The work has been done.

8th. Is a motion that the Street Commissioner be, and is hereby, directed to fill chuck-holes on north Alabama street, between Morrison and Seventh streets.

Recommend the work be done.

9th. Is a motion that Mr. Morris be granted the right to put down a sink in the alley in the rear of his house, No. 244 Bellefontaine avenue.

Recommend the permit be not granted.

10th. Is a motion that the Street Commissioner be, and is hereby, directed to place a culvert at the intersection of the first alley east of Virginia avenue and South street, so that alley may be used.

Recommend the work be done.

11th. Is a motion that the Board of Public Improvements be requested to make their report on the motion referred to them in reference to correcting the grade of the gútters of Massachusetts avenue, between Liberty and Noble streets.

We see no remedy for these gutters until a sewer is made in this locality. A part of the trouble comes from pumps on the sidewalks.

12th. Is a motion that the City Civil Engineer be instructed to make a survey and prepare plat of Sullivan street and surrounding territory, showing width of said street.

Recommend that the City Civil Engineer be directed to do the work.

13th. Is the matter of placing safety gates on streets at the crossings of the Union Railway Company's tracks.

We have been informed by the Superintendent of said company that arrangements have been made for the purchase of said gates for the several crossings.

We, the undersigned members of the Board of Public Improvements of the City of Indianapolis, would most respectfully enter our protest against what we deem the unwarranted reduction in the estimate made by this board for the Street Repair Department by the Committee on Finance. The reduction made by said committee in this case was much larger than in any other department of the city government; and, in the opinion of this board, the citizens and tax-payers of this city do not approve of such reduction, and are now, and have been, demanding that the streets of this city be maintained in a better manner than can be done by the amount allowed by the committee. And we now ask that this Council make the amount of said estimate not less than the amount expended last year, which amount will be a reduction on what this board estimated should be expended of over ten thousand dollars.

To the Mayor, Common Council and Board of Aldermen:

Gentlemen:-Your Committee on Printing, to whom was referred the matter relative to the city advertising and the delinquent list for the year ending May 31st, 1882, would respectfully report that we have advertised for bids for the same, and the following bids were received:

Saturday Review, 28 cents per square for advertising, and 25 cents for each description.

Indianapolis Times, 25 cents per square, and 15 cents per description.

Indianapolis Journal, 21 cents per square, and 20 cents per description. Saturday Herald, 15 cents per square, and 12 cents per description. The People, 8 cents per square, and 9 cents per description. Indianapolis Republican, 5 cents per square, and 8 cents per description.

Previous to the opening of bids, the following motion was unanimously adopted by the committee:

"That the committee do not award the contract to any paper with a less circulation than 4,000."

The circulation of the People and Republican being less than 4,000, their bids were not entertained. The Herald and Review did not certify to their circulation, and their bids could not be entertained. The circulation of the Times being 6,500 and the Journal 7,000, the committee are of the opinion that the Journal is the lowest and best. We recommend that it be awarded the contract.

At the same time bids were also received for bill posting, Harbison & Abrams and John Edwards being the only bidders.

Harbison & Abrams being the lowest and best bidders, we recommend they be awarded the contract.

The following message was read; and, on motion, the amendments, with the ordinance, were referred to the Committee on Public Light:

INTRODUCTION OF GENERAL AND SPECIAL ORDINANCES.

Under this order of business the following entitled ordinances were read the first time:

By Councilman Cole:

G. O. 52, 1881—An Ordinance to provide for the re-organization of the Police Board, Fire Board, Hospital Board, Dispensary Board, and Board of Public Improvements, of the City of Indianapolis.

By Councilman Dowling;

G. O. 51, 1881—An Ordinance for the protection of travelers, passengers and baggage, and for the preservation of order in and about the Union Depot, in the City of Indianapolis, Indiana.

By Councilman Fultz:

S. O. 148, 1881—An Ordinance to provide for grading and paving with brick, and curbing with stone (where not already paved and curbed), the east sidewalk of West street, from Merrill street to McCarty street.

By Councilman Koller:

G. O. 54, 1881-An Ordinance requiring the Cleveland, Columbus, Cincinnati & Indianapolis Railway Company, and Indianapolis, Peru & Chicago Railway Company, to employ and station a flagman at the point where the tracks of said companies cross east Market street.

INTRODUCTION OF MISCELLANEOUS BUSINESS.

Councilman Caylor offered the following motion; which was laid on the table:

That this Council pass no more street improvement ordinances unless accompanied by a majority of property owners petitioning for said work.

Councilman Caylor offered the following motion; which was referred to the Board of Public Improvements:

That the Street Commissioner be directed to clean the gutters on Blake street, between Elizabeth and North streets. September 19, 1881.]

Councilman Cole offered the following motion; which was referred to the Committee on Public Light:

That the City Civil Engineer be instructed to re-light lamp-post on northeast corner of Noble and Vermont streets.

Councilman Dean offered the following motion; which was adopted :

That Messrs. Johnson & Erwin have permission to lay a double stone crossing across south Meridian street, in front of their place of business, work to be done at their own expense, and under the direction of the City Civil Engineer.

Councilman Dowling offered the following motion; which was referred to the Board of Public Improvements, with power to act:

That the City Civil Engineer be, and is hereby, directed to set the grade stakes, and the Street Commissioner be directed to do the work, and again grade and gravel Garden street, between Eddy and Tennessee streets; said street having been graded and graveled two years ago by ordinance, and stakes set by the City Civil Engineer, and now Eddy street has been bowldered and is much higher than Garden street.

Councilman Egger offered the following motion; which was adopted:

That the Street Commissioner notify the Citizens Street Railway Company to fill the center of their tracks on Virgina avenue, from South street to its southern terminus, so as to conform to the established grade of the street; if the said work is not done in thirty days, that the Street Commissioner proceed to do the work, and collect the cost thereof from said railway company.

Councilman Fultz offered the following motion; which was referred to the Committee on Public Light:

That the City Civil Engineer be, and is hereby, instructed to re-advertise for bids for laying gas mains and erection of posts on Morris street, from Meridian street to Dacotah street, and to continue to advertise until bids are received for doing the work.

Councilman Fultz offered the following motion; which was adopted :

28That F. H. Rosch be permitted to pave with brick the sidewalk in front of his place of business, at Nos. 333 and 331, on the corner of Mørris and Decotah streets; the work to be done according to stakes set by the City Civil Engineer.

Councilman Koller offered the following motion; which was referred to the Board of Public Improvements:

That the Street Commissioner be, and is hereby, directed to clean the gutters of New York street, between Noble and Pine streets.

Councilman Morrison offered the following motion; which was laid on the table:

That the Street Commissioner be directed to re-grade east Georgia street, between Pennsylvania and Delaware streets. Councilman Pearson offered the following motion; which was referred to the Board of Public Improvements:

That the Street Commissioner place six-inch drain pipe in the gutter on north side of St. Clair street, between Illinois street and the first alley west, and connect the same with the sewer.

Councilman Pearson offered the following motion; which was adopted:

That A. G. Craft be granted permission to re-pave the sidewalk in front of her property on the west side of Tennessee street, between Pratt and First streets; the same to be done at her own expense under the direction of the City Civil Engineer.

Councilman Reichwein offered the following motion; which was referred to the Board of Public Improvements;

That the Street Commissioner be instructed to clean the gutters of north New Jersey street, from Wabash street to Ohio street.

Councilman Reichwein presented the following petition; which was received, the prayer of the petition granted, and the petitioner instructed to comply with all ordinances on this subject:

Yo the Mayor, Common Council and Board of Aldermen of the City of Indianapolis:

Gentlemen:—The undersigned, owner of the real estate situate at the corner East and Washington streets, in the City of Indianapolis, would show to your honorable bodies that he is desirous of putting down a driven well in front of his said premises on East street, in the sidewalk. The well, when put down, will be of great benefit and advantage, not only to the occupants of said premises, who have no other means of supply, but to the public as well, by furnishing an abundant supply of pure water. He therefore prays you honorable bodies to grant him the necessary permission to at once proceed in the construction and maintenance of said well. JAMES JOHNSON.

Councilman Stout offered the following motion; which was adopted :

That the Fire Board be directed to have Delaware and Alabama streets sprinkled from Washington street to the Exposition grounds, during the week of the State Fair, without any expense to the city.

Councilman Thalman presented the following petition; which was referred to the Committee on Streets and Alleys:

To the Members of the City Council, and Board of Aldermen:

Gentlemen:—The undersigned pray you to vacate that part of Madison street adjoining lots 28 and 31 inclusive, and so much of the first alley north of Madison street as adjoins lots 1, 2, 3, 28, 29 and 30, all in Hanna heirs' addition to the City of Indianapolis. The part desired vacated is marked in green on the accompanying plat, and has never been used as a thoroughfare, nor is it required for public convenience. This vacation is asked so that the surrounding ground may be used for manufacturing purposes.

F. M. Churchman, S. J. Fletcher, J. F. Holt.

Councilman Thalman presented the following remonstrance; which was referred to the Board of Public Improvements, with the ordinance, S. O. 143, 1881:

To the Mayor, Common Council, and Board of Aldermen of the City of Indianapolis:

Gentlemen:—The undersigned, owners of over one-half the real estate on Eng-lish avenue between Dillon and Linden streets, respectfully remonstrate against the passage of the pending ordinance for the paving with brick of the sidewalk and the bowldering of the gutters of said avenue. It is only a few years since the said street and sidewalks were graded and graveled, and until the question of sew-age of that street and vicinity is settled, no such permanent improvement as that contemplated by the pending ordinance should be made. To grant permission to James A. Mitchel to lay a plank crossing over the sidewalk on the west side of Columbia avenue, near Home avenue.

Councilman Weaver offered the following motion:

That the Street Commissioner be directed to repair the road-bed of Brookside. aveune with wooden blocks, where the chuck-holes have made the road unsafe for travel.

Councilman Weaver moved that the above motion be adopted.

Which motion failed of adoption by the following vote:

- Aves, 8-viz. Councilmen Dowling, Fultz, Hartmann, Knodell, Koller, Reichwein, Stout, and Weaver.
- NAYS, 9--viz. Councilmen Bedford, Brundage, Caylor, Cole, Harrold, Mauer, Morrison, Pearson, and Thalman.

The motion was then referred to the Board of Public Improvements.

Councilman Weaver offered the following motion; which was referred to the Board of Public Improvements:

That the City Marshall notify Mr. Lewis Nicoli to cut down a dead forest tree on lot 13, Butler's addition, as it endangers the dwelling house directly south of said lot.

PENDING ORDINANCES.

The following entitled ordinance was read the second time :

G. O. 50, 1881-An Ordinance to repeal an ordinance granting to M. H. Wright the privilege of erecting and maintaining a slaughtering and grease rendering establishment on the west side of White River, being General Ordinance No. 4, 1881.

Regular Session

Councilman Dean moved to refer the above ordinance to the Board of Health.

Councilman Dowling moved to lay Councilman Dean's motion on the table.

Which motion, to lay on the table, was adopted by the following vote:

Councilman Morrison moved to refer the ordinance to the Committee on Public Health and City Attorney.

Which motion to refer was adopted by the following vote:

Aves, 10-viz. Councilmen Bedford, Brundage, Caylor, Cole, Dean, Harrold, Morrison, Pearson, Stout, and Thalman.

NAYS, 9--viz. Councilmen Dowling, Egger, Fultz, Hartmann, Knodel, Koller, Mauer, Reichwein, Weaver.

On motion, the Common Council then adjourned.
