INTRODUCTION OF GENERAL AND SPECIAL ORDINANCES.

By City Controller:

General Ordinance No. 21—1913: An ordinance providing for the transfer of \$300.00 from a certain fund to a certain fund in and for the use of the Department of Public Safety and fixing a time when the same shall take effect.

Section 1. Be it ordained by the Common Council of the City of Indianapolis, Indiana, that the sum of three hundred dollars (\$300.00) be, and the same is hereby transferred from the fund known as "Printing and Stationery" to a fund known as "Electrical Department." All to and for the use of the Department of Public Safety.

Section 2. This ordinance shall take effect and be in force from and after its passage.

Which was read a first time and referred to the Committee on Finance.

By Mr. McCarthy:

General Ordinance No. 22-1913: An ordinance providing for the muzzling of dogs, fixing a penalty for the violation thereof and fixing a time when the same shall take effect.

Section 1. Be it ordained by the Common Council of the City of Indianapolis, Indiana. That it shall be unlawful for any person, firm or corporation who owns or harbors any dog or dogs to permit or allow said dog or dogs to run at large upon any of the streets, alleys or public places of the City of Indianapolis without said dog or dogs being securely muzzled in such a manner so as to prevent said dog or dogs from snapping or biting any person using any of the streets, alleys or public places of said city. It shall likewise be unlawful for any person to lead any dog by means of rope, strap, chain, tether or other contrivance without said dog being muzzled as above provided for. Provided, however, that nothing in this ordinance shall be construed to require dogs to be muzzled that are kept in enclosed premises.

Section 2. All ordinances and parts of ordinances in conflict with

the provisions of this ordinance are hereby repealed.

Section 3. Any person violating any of the provisions of this ordinance, shall, upon conviction, be fined in any sum not less than five

dollars (\$5.00) nor more than fifty dollars (\$50.00).

Section 4. This ordinance shall be in full force and effect from and after its passage and publication once each week for two consecutive weeks in the Indianapolis Commercial, a daily newspaper of general circulation printed and published in the City of Indianapolis, Indiana.

Which was read a first time and referred to the Committee on Elections.

By Mr. Owen:

General Ordinance No. 23-1913: An ordinance concerning certain occupations and practices, fixing penalties for the violation thereof, and fixing the time when the same shall take effect.

Section 1. Be it ordained by the Common Council of the City of Indianapolis, Indiana, that it shall be unlawful for any person, firm or corporation, to conduct, carry on, practice or transact the business, art, profession or occupation, for the purpose of gain, palmistry, lifereading, clairvoyance, clairaudience, fortune-telling, crystal-gazing, mediumship, prophecy, augury, divination, necromancy, charm-giving. charm-selling, charm-working, psycomancy or psycography, within the city of Indianapolis, Indiana.

Provided, however, that the provisions of this ordinance shall not apply to any person, firm or corporation, who shall carry on the business of mediumship, psychomancy, psycography, clairvoyance, clairaudience or psychic readings, as provided in section two of this ordi-

Section 2. Any person, firm or corporation who shall, after the taking effect of this ordinance, carry on or practice the business or occupation of clairaudiat, clairvoyance, mediumship, psychomancy, psychography or psychic readings within such city, for any gain or pecuniary profit, either by donation or otherwise, shall first submit to an examination before the president of a regular organized religious society, or before a committee of such society, and shall procure a written certificate of endorsement and recommendation, which shall be signed by the president of such religious society, and which certificate shall be under the corporate seal of said society. And, provided, further, that this ordinance shall not apply to any person, firm or corporation carrying on the business mentioned in this section in such church, and during the services thereof.

Section 3. Any person, firm or corporation who shall fail or refuse to produce or exhibit a written certificate of the kind and character mentioned in section two, of this ordinance, to any Police Officer or any other person investigating the business conducted, when called upon so to do, shall be deemed guilty of a violation of section one of this

ordinance.

Section 4. The written certificate of endorsement and recommendation of the society or societies mentioned in section two of this ordiance shall be revoked by the court or by the president of any religious society issuing the same, upon complaint being made and satisfactory proof showing such person, firm or corporation holding the same had been guilty of fraud in conducting the business mentioned in section two of this ordinance, or in the procurement of said certificate, or in advertising such business.

Section 5. Any person, firm or corporation who shall solicit patronage in conducting any of the business or occupations mentioned in section one of this ordinance, by advertising the same in any newspaper, periodical, placard or in any other manner, without first having procured a certificate as provided in section two of this ordinance, shall be deemed guilty of violating the provisions of this ordinance, and such advertisement shall be prima facia evidence of such violation.

Section 6. Any person, firm or corporaton who shall violate any of the provisions of this ordinance shall be fined in any sum not less than fifty dollars (\$50.00) nor more than one hundred dollars (\$100.00), to which may be added imprisonment for any determinate period, not exceeding, however, the term of six months.

Section 7. All ordinances and parts of ordinances in conflict with

the provisions of this ordinance are hereby repealed.

Section 8. This ordinance shall be in full force and effect from and after its passage and publication once each week for two consecutive weeks in the Indianapolis Commercial, a daily newspaper of general circulation printed and published in the City of Indianapolis, Indiana.

Which was read a first time and referred to the Committee on Public Works.

By Mr. McCarthy:

General Ordinance No. 24-1913: An ordinance fixing the salary of the record clerk in the office of the Board of Public Works, repealing all ordinances in conflict herewith, and fixing a time when the same shall take effect.

Section 1. Be it ordained by the Common Council of the City of Indianapolis, Indiana, That the clerk known as the record clerk in the office of the Board of Public Works shall receive a salary at the rate of one thousand dollars (\$1,000.00) per annum, payable out of any money in the general fund in the hands of the Treasurer not otherwise appropriated; such salary to be paid at the same time and in the same manner as other city officers and employes are, being paid at the time of the taking effect of this ordinance.

Section 2. All ordinances or parts of ordinances in conflict here-

with are now hereby repealed.

Section 3. This ordinance shall be in force and effect from and after its passage.

Which was read a first time and referred to the Committae on Public Works.

By Mr. Stilz:

General Ordinance No. 25-1913: An ordinance concerning the salary of inspector of scales, weights and measures, and fixing a time when the same shall take effect.

Section 1. Be it ordained by the Common Council of the City of Indianapolis, Indiana, That the salary of the inspector of scales, weights and measures as heretofore appointed by the Board of Public Safety of the City of Indianapolis, Indiana, be and the same is now fixed at the sum of eighteen hundred dollars (\$1,800.00) per annum, payable semimonthly, payable out of any funds in the hands of the city not otherwise appropriated for other purposes.

Section 2. All ordinances and parts of ordinances in conflict here-

with are hereby repealed.

Section 3. Whereas, an emergency exists for the immediate taking effect of this ordinance, the same is declared to be in full force and effect from and after its passage.

PRESIDENT: On account of the extremely dirty condition of the public streets and alleys of the City of Indianapolis, I move that the President immediately appoint a committee of three members of this Council under the authority of and with the powers vested by section 54 of the City Charter, said committee to act under the following instructions:

First. To investigate, the condition of the public highways of the City as to cleanliness.

Second. To investigate the organization, expense and general efficiency of the department and the officers and employes thereof charged with the duty of cleaning the public highways, including the methods of keeping expense accounts and time records and systems of checking efficiency of employes.

Third. To report back to this body as early as possible, its findings and conclusions and any recommendations, of any action that this body might take legally to better the present conditions in regard to the cleanliness of such highways.
