Commencing in the center line of Tenth Street at its intersection with the center line of Beville Avenue; thence south with the center line of Beville Avenue to the center line of Michigan Street; thence west with the center line of Michigan Street to the center line of Beville Avenue; thence south with the center line of Beville Avenue to the center line of New York Street; thence west with the center line of New York Street to the center line of Randolph Street; thence north with the center line of Randolph Street to the center line of Michigan Street; thence east with the center line of Michigan Street to the center line of Tecumseh Street; thence north with the center line of Tecumseh Street to the center line of Pratt Street; thence west with the center line of Pratt Street to the center line of the first alley west of Tecumseh Street; thence north with the center line of the first alley west of Tecumseh Street to the center line of Tenth Street; thence east with the center line of Tenth Street to the center line of Beville Avenue, the place of beginning, shall constitute the Fifth Precinct of the Ninth Ward, in the City of Indianapolis.

SECTION 2. All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.

SECTION 3. This ordinance shall be in full force and effect from and after its passage.
