"The bond of said County Treasurer, ex officio City Treasurer, shall be in such sum and with such sureties as the Common Council may by ordinance determine, to the approval of such Common Council," and

Whereas, Carl Von Hake was at the general election held in the County of Marion, State of Indiana, Nevember 5, 1912, duly elected to the office of Treasurer of the County of Marion, Indiana, ex officio Treasurer of the City of Indianapolis, and

Whereas, he has executed a certain bond in favor of the City of Indianapolis in the penal sum of three hundred thousand dollars (\$300,000.00) with the National Surety Company of New York City, New York, a corporation, as surety, and has tendered same to the Common Council of said City for its approval.

Be it ordained by the Common Council of the City of Indianapolis as

follows:

SECTION 1. Be it ordained by the Common Council of the City of Indianapolis, That the amount of the bond of the County Treasurer acting ex officio in the capacity of the City Treasurer of the City of Indianapolis, is hereby fixed for a period not to exceed two (2) years from January 1, 1914, in the penal sum of three hundred thousand dollars, payable to the City of Indianapolis.

SECTION 2. Be it ordained by the Common Council of the City of Indianapolis, That the bond of Carl von Hake in the penal sum of three hundred thousand dollars (\$300,000.00) as above, with the National Surety Company of New York City, New York, a corporation, as surety, is hereby in all things confirmed and approved. Said bond shall be filed with the City Controller as provided by law.
