CALLED SESSION.

CHAMBER OF THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, FRIDAY, AUGUST 16, 1867, 7½ O'CLOCK, P. M.

The Common Council met pursuant to the following call:

To the Members of the Common Council of the City of Indianapolis:

Gentlemen:—A special meeting of the Council will be held this evening in the Council Chamber at 8 o'clock, for the transaction of such busines as may come before it.

Present—His Honor, the Mayor, Daniel Macauley, in the chair, and the following members:

Councilmen Coburn, Cottrell, Geisel, Goddard, Henschen, Jameson, Loomis, Seidensticker, Stanton and Woodburn—10.

Absent—Councilmen Brown, Burgess, Colley, Davis, Kappes, MacArthur and Schmidt—7.

Mr. Seidensticker offered the following resolutions:

WHEREAS, The City Marshal has failed to give legal notice of the election heretofore ordered in the Fifth Ward, to fill the vacancy in Council, caused by the removal of Mr. Grosvenor; and

WHEREAS, There ought to be no doubt of the legality of such special elec-

tion; and

WHEREAS, All legal electors ought to have full notice of such elections taking place; therefore be it

Resolved, 1. That the resolution ordering a special election in the Fifth Ward for Councilman, on the 17th of August, be, and is hereby rescinded.

2 That a special election for Councilman in the Fifth Ward, to fill the vacancy caused by the removal of Mr. Grosvenor, be ordered to be held in the school house of said ward, on the 27th day of August, 1867.

3. That Pherson Park and W. W. Smith be, and the same are hereby ap-

3. That Pherson Park and W. W. Smith be, and the same are hereby appointed to act as Judges of said election, to act with G. W. Alred as Inspector, and the other registers of said ward, as clerks.

4 That the Marshal be instructed to give notice, by publication and hand bills, of said election.

The question being on the passage of the resolution, those who voted in the affirmative were Councilmen Coburn Goddard, Henschen, Jameson, Loomis, Seidensticker, Stanton and Woodburn—8.

Those who voted in the negative were Councilmen Cottrell and Geisel—2.

So the resolution was adopted.

On motion by Mr. Seidensticker, the Council adjourned.
