The Common Council of the City of Indianapolis met in joint session with the Marion County Council, in the Public Assembly Room of the City-County Building, on Monday, January 6, 1969, at 5:00 P.M.

County Council President SerVaas presided.

President SerVaas explained that the purpose of the meeting was to review the projected plans for the Community Action Against Poverty program for Marion County and the City of Indianapolis for the coming year.

President SerVaas introduced Mr. John Walls, who gave the Councils an idea as to what has transpired since he took office as President of the Board of the C.A.A.P. program.

Mr. Walls introduced Dr. John Liell, the Director of the C.A.A.P. program. Dr. Liell distributed charts showing the various agencies within C.A.A.P. and their functions, giving the Councilmen a brief recap of the services and the liaison work with the agencies of the County. He discussed the budget of the agency for the coming

year and of the contracts with other service agencies related to the C.A.A.P. program. Mr. Juan Solomon was introduced and concurred with Dr. Liell on the problems facing the continuance of the C.A.A.P. program. There was a brief question and answer session with the Council members and the representatives of the C.A.A.P., on their budget and personnel problems.

On motion of Mr. Leak, seconded by Mr. Byrum, the Council adjourned at 6:30 P.M.

REGULAR MEETING

Monday, January 6, 1969, 7:30 P.M.

The regular meeting of the Common Council of the City of Indianapolis convened in the Council Chambers of the City-County Building at 7:30 P.M. on Monday, January 6, 1969.

President Hasbrook in the chair.

The Clerk called the roll:

Present: Mr. Broderick, Mr. Egenes, Mr. Forestal, Mr. Gorham, Mr. Leak, Mr. Moriarty, Mr. McPherson, Rev. Williams and President Hasbrook.

Mr. Moriarty moved, seconded by Mr. McPherson, to dispense with the reading of the Journal of the previous meeting.

ELECTION OF COUNCIL OFFICERS FOR 1969

President Hasbrook announced the election of officers of the Council for the year 1969.

President Hasbrook asked Mrs. Marjorie O'Laughlin, City Clerk, to take the chair.

Mrs. O'Laughlin called for nominations for the office of President.

Mr. Egenes nominated Mr. Thomas C. Hasbrook for re-election as President.

The nomination was seconded by Rev. Williams.

Mr. Moriarty moved that the nominations be closed and the Clerk be instructed to cast a unanimous ballot for Mr. Thomas C. Hasbrook, for President. The motion was seconded by Mr. Gorham.

NEW ORDINANCES

GENERAL ORDINANCE 1, 1969

Introduced by Councilman Moriarty:

AN ORDINANCE to withdraw authority for the transfer of powers

- by the City of Indianapolis to the Mass Transportation Authority of Greater Indianapolis and to terminate a certain inter-governmental agreement between the City of Indianapolis and the Mass Transportation Authority of Greater Indianapolis entered into pursuant to General Ordinance No. 14, 1968.
- WHEREAS, the City of Indianapolis entered into inter-governmental agreement with the Mass Transportation Authority of Greater Indianapolis pursuant to authority granted by General Ordinance No. 14, 1968; and
- WHEREAS, such agreement may by its terms be terminated by the City of Indianapolis on three (3) months written notice to the Mass Transportation Authority of Greater Indianapolis.

NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. The City of Indianapolis shall rescind its transfer of power to the Mass Transportation Authority of Greater Indianapolis, and the Mayor and the Clerk of the City of Indianapolis are authorized to give notice to the Mass Transportation Authority of Greater Indianapolis that the City of Indianapolis will terminate the intergovernmental agreement entered into between said City and said Authority on April 16, 1968, such notice of termination to be effective three (3) months after the date of such notice.

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval by the Mayor and compliance with all laws pertaining thereto.

Which was read for the first time and referred to the Committee on Finance.

I move that General Ordinance No. 43, 1968 be amended by adding immediately after Section 7-401, as follows:

POOL ROOM. The term "pool or billiard room" as used in this chapter shall mean and include any room, public place, or place of public accommodation located within the City of Indianapolis wherein there is located two (2) or more pool or billiard tables for which a license is required by the terms of this chapter.

Upon appeal from the Board's finding, the decision of the Mayor shall be final."

(on page 1) line 1 in the amended section 7-401; lines 1, 4, 8, 10 and 13 in the amended section 7-402(1);

(on page 2) lines 2, 6 and 9 in the amended section 7-402(2); line 1 in the amended section 7-403; lines 2, 4, 9, and 12 in the amended section 7-403(2), and line 2 in the amended section 7-404;

(on page 3) lines 4, 5, 7, 15 and 18 of amended section 7-404; lines 2, 4, 6, 7, 9, 10, 13, 14 and 15 of amended section 7-405;

(on page 4) line 2 of amended section 7-406 and line 4 of the amendment of section 7-406 dated December 16, 1968; lines 2, 5, 6, 7 and 9 of amended section 7-407; lines 2 and 3 of amended section 7-408, lines 1 and 7 of amended section 7-409.

I further move that General Ordinance 43, 1968, be amended by inserting the word "daytime' at the end of line 2 of amended section 7-406 after the word "the" and before the word "hours."
