#### SPECIAL RESOLUTION NO. 20, 1969

## SPECIAL ORDINANCES

#### SPECIAL ORDINANCE NO. 17, 1969

Introduced by Councilman Egenes:

AN ORDINANCE annexing certain contiguous territory to the City of Indianapolis, and fixing a time when the same shall take effect.

#### BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

SECTION 1. That the City of Indianapolis, Indiana, be and the same is hereby extended so as to include the following described territory commonly known as 7229 East Washington Street, which is hereby annexed to and made part of the territory constituting the City of Indianapolis, Indiana, said territory being a part of the East Half of the Southwest Quarter, Section 1, Township 15 North, Range 4 East of the 2nd Principal Meridian in Marion County, Indiana, being more particularly described as follows:

Beginning in the center line of the National Road (U.S. 40), as said highway is now established and located, at a point 356 feet 4 inches east of the west line of the East half of said Southwest quarter of Section 1, thence south, parallel to the west line of the East half of the said Southwest quarter of Section 1, 255 feet to a point; thence east, parallel to the center line of said National Road, 234 feet to a point: thence north, parallel to the west line of the East half of the said Southwest quarter of Section 1, 255 feet to a point in the center line of the National Road; thence west along the center line of the said National Road, 234 feet to the point or place of beginning;

Excepting therefrom, right-of-way for U.S. Highway No. 40, a

strip 55 feet in width off the north side of the above described property, containing approximately 0.98 acres.

SECTION 2. This Ordinance shall be in full force and effect from and after its passage, approval by the Mayor and publication according to law.

Which was read for the first time and referred to the Committee on Public Safety.
