CHAMBER OF THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, Monday, April 6th, 1868, 7¹/₂ o'clock, p. m.

The Common Council met in regular session.

Present-His Honor, the Mayor, Daniel Macauley, in the chair, and the following members:

Councilmen Brown, Coburn, Davis, Foster, Goddard, Jameson, Kappes, MacArthur, Seidensticker and Woodburn-10.

Absent-Councilmen Burgess, Colley, Cottrell, Geisel, Henschen, Loomis, Schmidt and Stanton-8.

The proceedings of the regular session held March 30th, 1868, were read and approved.

Business was resumed in the order in which it was left off at last regular meeting, viz:

ORDINANCES ON SECOND READING.

Mr. Goddard called up general ordinance No. 123, providing for the establishment of the office of City Measurer.

Which was read the second time and ordered to be engrossed.

Mr. Goddard called up special ordinance No. 10-1868.

Which was read the second time and ordered to be engrossed.

Mr. Brown called up special ordinance No. 12-1868.

Which was read the second time and ordered to be engrossed.

Dr. Jameson called up general ordinance No. 127.

Which was read the second time and ordered to be engrossed.

ORDINANCES ON THIRD READING.

Mr. Foster called up special ordinance No. 7-1868, entitled :

AN ORDINANCE to provide for grading and graveling Merrill street and sidewalks, between the east side of West street and the west side of Missouri street.

Which was read the third time and placed upon its passage.

The question being, shall the ordinance pass? those who voted in the affirmative were Councilmen Brown, Coburn, Davis, Foster, Goddard, Jameson, Kappes, MacArthur, Seidensticker and Woodburn -10.

No Councilman voting in the negative.

So the ordinance passed.

Dr. Jameson called up general ordinance No. 127, entitled:

AN ORDINANCE in relation to the payment of City Bonds issued by the City of Indianapolis on the 1st day of October, 1866, and payable on the 1st day of April, 1868.

Which was read the third time and placed upon its passage.

No Councilman voting in the negative.

So the ordinance passed.

Mr. Goddard callen up general ordinance No. 123, entitled :

AN ORDINANCE to establish the office of City Measurer and regulate the busithereof.

Which was read the third time and placed upon its passage.

The question being, shall the ordinance pass? those who voted in the affirmative were Councilmen Brown, Coburn, Foster, Goddard, Jameson, Kappes, MacArthur, Seidensticker and Woodburn -9.

Councilman Davis voting in the negative.

So the ordinance passed.

Mr. Seidensticker called up general ordinance No. 128, entitled :

AN ORDINANCE requiring a flagman to be stationed at the intersection of Alabama and Louisiana streets.

Which was read the third time and placed upon its passage.

The question being, shall the ordinance pass? those who voted in the affirmative were Councilmen Brown, Coburn, Davis, Foster, Goddard, Jameson, Kappes, MacArthur, Seidensticker and Woodburn—10.

No Councilman voting in the negative.

So the ordinance passed.

Mr. Brown called up special appropriation ordinance No. 19-1868, entitled:

AN ORDINANCE appropriating money for the building and repairing of wooden culverts over gutters at crossings or intersections of streets and alleys.

Which was read the third time and placed upon its passage.

The question being, shall the ordinance pass? those who voted in the affirmative were Councilmen Brown, Coburn, Davis, Foster,

Goddard, Jameson, Kappes, MacArthur, Seidensticker and Woodburn-10.

No Councilman voting in the negative.

So the ordinance passed.

REGULAR ORDER OF BUSINESS.

Mr. Brown offered the following motion:

That Frederick Klare be allowed to gravel the sidewalk on Morris street on the side of his lot, and that the Civil Engineer be directed to set the stakes for the grade, and that he be allowed a credit hereafter for such improvement on any assessment that may be made for improving such sidewalk.

Which was adopted.

Mr. Coburn offered the following motion :

That the Street Commissioner is ordered to remove the old telegraph poles between Glenns' Block and Masonic Hall, on Washington street, as the same is not now in use.

Which was adopted.

Mr. Foster offered the following motion:

That the City Civil Engineer be directed to advertise for proposals for building a foot bridge over Pogue s Run at McCarty street, and that he notify the owners or lessees of the ground known as Moses' Skating Park to remove the fences which cross McCarty street on both sides of Pogue's Run.

Mr. MacArthur moved to lay the motion on the table.

Mr. Foster called for the ayes and noes.

The question being to lay the motion on the table, those who voted in the affirmative were Councilmen Coburn, Davis, Goddard, Jameson, Kappes, MacArthur, Seidensticker and Woodburn—8.

Those who voted in the negative were Councilmen Brown and Foster-2.

So the motion to lay on the table was adopted.

Mr. Goddard offered the following motion :

That the Civil Engineer notify the Indianapolis and Vincennes Railroad Company to raise their track so as to conform to the grade of the street on Kentucky Avenue.

Which was referred to the Committee on Streets and Alleys.

Dr. Jameson offered the following motion :

That the Street Commissioner be directed to place a wooden culvert at the crossing of Massachusetts Avenue and New Jersey street, and do the necessary filling.

Which was adopted.

Dr. Jameson introduced general ordinance No. 131, entitled:

AN ORDINANCE appropriating money for the payment of the Bank Loan and interest due April 10, 1868.

Which was read the first and second times and ordered to be engrossed.

Mr. Kappes presented the following petition:

INDIANAPOLIS, April 6, 1868.

To the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN:—I would respectfully ask for permission from your honorable body to pave the sidewalk in front of my property, on Massachusetts Avenue, with brick; my property is situated between Chatham and St. Clair streets, on Massachusetts Avenue, and is 170 feet front on the Avenue.

That H. Bates be permitted to erect a stone wall on both sides of Pogue's Run where the same crosses out lots sixty-seven and sixty-eight, walls to be 30 feet apart.

Which was adopted.

Dr. Woodburn offered the following motion :

That H. Bates be permitted to place a stone flagging on sidewalks in front and on side of Bates House, and that the Engineer set the necessary stakes at the grade heretofore established.

Which was adopted.

Dr. Woodburn presented the following remonstrance :

INDIANAPOLIS, April 6, 1868.

To the Mayor and Common Council of the City of Indianapolis:

The Citizens' Street Railway Company respectfully represents that the use of the north half of Louisiana street, between Illinois and Tennessee streets,

REPORTS FROM COMMITTEES.

Mr. Coburn, from the Committee on Accounts and Claims reported back special appropriation ordinance No. 18-1868.

Which was read the second time and ordered to be engrossed.

Mr. Seidensticker, from the Committee on Revision of Ordinances, introduced the following general ordinance No. 132:

AN ORDINANCE to prohibit the running at large, in the City of Indianapolis, of any swine, boar, sow or barrow, and to regulate the erection and keeping of pig styes and stables.

SECTION 1. Be it ordained by the Common Council of the city of Indianapolis, That from and after the passage of this ordinance it shall be unlawful for any person to have any swine boar, sow or barrow running at large within the limits of the City of Indianapolis, and any person violating the provisions of this section shall, on conviction before the City Judge, be fined in any sum not exceeding ten dollars.

SEC. 2. Any swine, boar, sow or barrow, running at large within the limits of the City of Indianapolis, in violation of the above section, may be taken up and impounded by the Marshal or any Police Officer of said city, of which impounding the Marshal or officer shall give immediate notice, in writing, posted at each Market House and the City Judge's office, describing said swine, boar, sow or barrow; and if the owner of said impounded animal is unknown or fails to claim the same within twenty-four hours after such notice has been posted, the Marshal or officer shall sell the same to the highest bidder, and the Marshal or Police Officer shall be entitled to receive a fee of fifty cents for each animal impounded by him, and an additional fee of twenty-five cents for each animal sold by him in accordance to the provisions of this ordinance, and the overplus of such sale over such expenses shall be paid to the City Treasurer, who, upon proof, shall return the same to the owner, but otherwise, shall return it into the City Treasury.

SEC. 3. It shall be unlawful, within the limits of the City of Indianapolis, to erect, build, maintain, or use any pig stye or stable for the keeping of any swine, boar, sow or barrow, at a less distance than thirty feet from any dwelling house on the same or any adjoining lot, or to keep such stye or stable in such a manner as to create or cause offensive or noxious smell or odor; and any person violating the provisions of this ordinance shall be deemed guilty of a public nuisance, and shall, upon conviction before the City Judge, be fined in any sum not exceeding twenty dollars. SEC. 4. This ordinance shall take effect and be in force from and after its

SEC. 4. This ordinance shall take effect and be in force from and after its publication for two successive weeks, one day each week, in the Indianapolis Daily Journal.

Which was read the first time and ordered to be printed in the proceedings.

GENTLEMEN:—The Committee on Fire Department would report that the No. 3 Engine, the J. W. Davis, has been returned from Seneca Falls where she has been thoroughly rebuilt by H. C. Silsby, the contractor for the Engine lately purchased by the city from him. We are satisfied that the work has been done in a thorough and complete manner. The Engine has been tried and found to work well. There is a bill of extra work of \$328.26 cents, a greater part of it being ordered by the Chief Fire Engineer as necessary. We would recommend its payment. We would also recommend that the Chief Fire Engineer and your committee have the Latta Engine repaired, and that only such repairs be made as is necessary to put it in thorough order.

REPORTS FROM CITY OFFICERS.

The City Gas Inspector made the following report:

INDIANAPOLIS, April 6, 1868.

To the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN:—On Thursday, the 2d instant, I assisted, as required by your ordinance, in taking the statements of the four meters attached to the street lamps, and now report to you the amount of gas consumed in lighting the city, as from them estimated:

Meter lamp on South Pennsylvania street, 625 cubic feet. Meter lamp on North Pennsylvania street, 600 cubic feet. Meter lamp on East Washington street, 575 cubic feet. Total for the three lamps, 1,800 cubic feet.

Multiplying the average of these three lamps, 600 cubic feet, by 743 lamps, the number extinguished at twelve o'clock, and we have an aggregate consumption of 445,800 cubic feet of gas. The meter lamp on West Washington street burned 1,050 feet, which, multiplied by 102 lamps, gives an aggregate consumption of 107,100 cubic feet.

The full Time Table for the month of March was 179 hours; the lamps extinguished at midnight burned 934 hours.

Burners, tested to consume an average of four feet per hour, under a pressure of 15-10ths, were used during the entire month on the 102 lamps burned according to full Time Table.

The following summary presents a portion of the items of the bill the Gas Light and Coke Company will expect me to certify to, and I ask your honorable body to consider the same, giving orders to me, your officer, as shall seem to you just:

I would call your attention to the fact that, at considerable expense, you procured and had tested, burners for 102 lamps, with the hope and positive intention of restricting the consumption of gas by said lamps to four cubic feet per hour, and yet the experience of the past month demonstrates that they can be made to burn 50 per cent. more gas than you had decided upon, or fully 1.87 cubic feet per hour more than is necessary to well and satisfactorily light our streets.

The explanation of this excess of 1.87 cubic feet must resolve itself down to these propositions:

1. A greater average pressure over the city than 15.10ths.

2. An undue local pressure at the meter-lamp, caused by elevation, reduction of main, or other causes.

3. Inaccuracy of meter attached to post.

4. Tampering with lamp, by allowing gas to flow through when not lighted.

The Charter of the Gas Light and Coke Company requires them to measure their gas to the city. If the statements of some of the Company's employes can be relied upon, it proposes to adhere to measurement by meter. The inaccuracy and injustice of that method of measurement, or rather of *estimating* the gas consumed, is clearly and simply shown by the bill of the

102, full time, four feet burner lamps for the past month. In my judgment, even if meter lamps were largely increased, (which the Company would, no doubt, willingly do, and as willingly claim from the city, *under its charter*, " the actual expense of setting each meter" used for this purpose,) there would continue to be dissatisfaction on the part of your honorable body, and an unpleasant monthly contest for your Gas Inspector.

I do not believe that the gas can be so justly measured to the city by this system of meter lamps as by burners tested under a pressure more nearly the average, and consequently greater than 15-10ths. The Washington street lamps this month indicate a pressure of fully 22-10ths. If that, or less, is the proposed extreme, let burners be so adjusted, and placed on the street lamps, and let the Gas Company thus measure gas to the city by the post, and not be allowed to do so by meters attached to one lamp in two hundred, or one in twenty-five even. This burner method is just, and works no wrong to the Gas Company; the meter plan is cause for suspicion and dispute.

I now close this communication, with the request that you, this evening, decide as to the propriety of my certifying such an account as the facts above set forth indicate.
