REGULAR SESSION.

CHAMBER OF THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, Monday, July 19th, 1869, 7½ O'CLOCK, P. M.

The Common Council met in regular session.

Present—His Honor, the Mayor, Daniel Macauley, in the chair, and the following members:

Councilmen Brown, Cottrell, Gimber, Harrison, Heckman, Kahn, Kennington, Marsee, Newman, Pyle, Shepherd, Thalman, Thoms, Weaver, Whitsit, Wiles and Woodburn-17.

Absent-Councilmen Locke-1.

The proceedings of the adjourned session held July 15, 1869, were read and approved.

Business was resumed in the order in which it was left off at last meeting, viz:

ORDINANCES ON SECOND READING.

On motion, general ordinance No. 35-1869, entitled :

AN ORDINANCE supplementary to an ordinance entitled "An ordinance regulating the erection of public lamps and providing for lighting the streets and alleys of the City of Indianapolis with gas."

Was read the second time.

[Regular Session

Mr. Newman moved to amend by striking out the second section and called for the ayes and noes.

The question being to strike out,

Those who voted in the affirmative were Councilmen Brown, Newman, Shepherd, Pyle, Thalman and Whitsit-6.

Those who voted in the negative were Councilmen Cottrell, Gimber, Harrison, Heckman, Kahn, Kennington, Marsee, Thoms, Weaver, Wiles and Woodburn-11.

So the motion to strike out was lost.

The ordinance was then ordered engrossed.

On motion, general ordinance No. 37-1869, entitled:

AN ORDINANCE amendatory of an ordinance entitled "An ordinance creat ing the office of City Gas Inspector. defining his duties and fixing his sal ary," passed February 17, 1868.

Was read the second time and referred to the Committee on Gas.

On motion, general ordinance No. 38-1869, entitled:

AN ORDINANCE appropriating money for charitable purposes in the City o Indianapolis.

Was read the second time and referred to the Committee on Finance.

Dr. Woodburn arose to a question of privilege in relation to the motion of censure offered by His Honor, the Mayor, at last meeting of Council, and offered the following preamble and resolution, proposing to withdraw the same should Mr. Cottrell see fit to offer an acceptable apology or explanation for his conduct and language upor that occasion.

- WHEREAS, Thomas Cottrell, a member of this Common Council, did, at an adjourned session of this body, held Thursday evening last, speak disre spectfully concerning a certain member thereof, and did also impugn the motives of other members of said body:
- AND WHEREAS, Did refuse to obey on being called to order by the Mayor, as President of this Council, and did also use offensive language towards that officer:
- AND WHEREAS, The conduct and language of said Thomas Cottrell, in the above particular, were disgraceful, ungentlemanly and reprehensible:-Therefore,

Resolved, That this Common Council does hereby censure and reprimand the said Thomas Cottrell for the said objectionable and offensive words and actions.

His Honor, the Mayor, called Mr. Newman to the Chair, and asked leave to withdraw the motion of censure offered by him.

Which was granted.

Mr. Cottrell declining to offer any other apology or explanation than the withdrawal of a portion of the offensive language referred to.

The resolution, after considerable discussion, participated in by nearly all the members present, was adopted by the following vote :

Mr. Brown introduced special ordinance No. 72-1869, entitled :

AN ORDINANCE to provide for the erection of lamp-posts, lamps and fixtures complete to burn gas, except the service pipe, on Maryland street, between Alabama and West streets, except such portions of such street as are already provided with public lamp-posts, lamps and fixtures.

Mr. Heckman introduced general ordinance No. 39—1869, entitled:

AN ORDINANCE in relation to the vacation of streets and alleys in the City of Indianapolis.

Which was read the first time by its title.

Mr. Heckman introduced special ordinance No. 74-1869, entitled:

AN ORDINANCE to provide for the erection of lamp-posts, lamps and fixtures complete to burn gas, except the service pipe, on East street, between Washington street and Pogue Run.

Which was read the first time by its title.

Mr. Heckman offered the following resolutions:

Resolved, That the Indianapolis and Cincinnati Railroad Company be, and is hereby, required to improve Louisiana street between East and Noble sts., by grading and graveling said street between the limits aforesaid, as required by ordinances granting said Company right of way upon and along said street, ordained April 20, 1852, and June 15, 1852, the terms of which were acted upon and accepted by said Company. That said Company be required to enter upon said work within thirty days.

Resolved, That the Clerk issue to the Marshal two certified copies of these resolutions, one of which he shall lawfully serve upon the proper officer or officers of said Company, and the other he shall duly return to the Clerk within three days after receipt thereof, with his proceedings properly endorsed thereon, and of such return he shall make prompt report to this body.

The question being on the adoption of the resolution,

That the Street Commissioner be, and he is hereby, instructed to properly fill the alley south of the old Second Ward School House, so as to clear the same of the mud and stagnant water standing thereon.

That the Street Commissioner be, and he is hereby, instructed to repair the gutter on the south side of Pennsylvania street, between St. Clair and St. Joseph streets.

Which were adopted.

Mr. Harrison, also, offered the following motion :

That the Committee on Streets and Alleys be instructed to inquire into the expediency of the passage of an ordinance to provide for garbage wagons, or some other method by which garbage, kitchen offal, slops, &c., may be daily removed from the residences of such citizens as may desire the same to be done.

Which was referred to the Board of Health.

Mr. Harrison introduced general ordinance No. 40-1869, entitled:

AN ORDINANCE to prevent the throwing of stones or other missiles at birds, and to prevent the obstructing of the track of the Citizens' Street Railway Company.

Which was read the first time by its title.

Mr. Harrison presented the following petitions:

That the City Attorney commence suit against James Stewart and his security, William Enners, the said Stewart having failed to complete his contract for grading and graveling Vine street and sidewalks, between Jackson and Ash streets, the time for completion of the said work having expired on the first day of April, 1869.

Mr. Wiles presented the following communication :

INDIANAPOLIS, July 19, 1869.

To the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN:—The undersigned, property holders on Vine street, between Jackson and Ash streets, would represent that on the 21st of last December, a contract to grade and gravel the street and sidewalks of the above named street was let to James Stewart for 64½ cents per lineal foot each side, and that James Stewart has gone ahead and graveled a portion of the sidewalk and partly graded the street. We see by the last proceedings of the Council that Samuel Lefever is awarded a contract for the same street for 78½ cents per foot front, without the Council ever declaring the contract of Stewart forfeited. We ask that nothing be done by the Council that will relieve Stewart from his contract, but that he be compelled to complete the street at the earliest possible moment. The bond of Samuel Lefever should therefore be not approved.

Washington and Court streets, is a public or a private one; the contract for the bowldering of said alley has been let, and the contractor desires to know what to do in the premises.

Mr. Marsee offered the following resolution:

Resolved, That the owners of the following described real estate, to-wit: Lot No. 23, in Roset's second subdivision of out-lot No. 108, be, and they are hereby, required to fill and drain the same, as, in the opinion of this Council, there is a hole or excavation thereon, in which water has or may become so stagnant and noxious as to be a nuisance and injurious to the health and comfort of said city and of the inhabitants thereof, and that the Street Commissioner be, and he is hereby, required to notify the owners thereof, as provided by an ordinance passed April 23d, 1866, entitled "An ordinance providing for the drainage and filling up of ponds, excavations and holes, and prescribing penalties for the failure to fill up or drain the same," and that in case of the failure of the owners thereof to fill or drain the same, the Street Commissioner proceed to drain or fill said excavation, as provided in said ordinance, and provided that the cost thereof shall not exceed ten per cent. of the value of the aforesaid real estate as assessed upon the tax duplicate for city purposes.

GENTLEMEN:—The undersigned, property holders on Maryland and South Meridian streets, and otherwise interested in the wholesale business of the city, earnestly protest against the erection of a City Prison on Maryland st., between Meridian and Pennsylvania streets. That portion of Maryland street is now rapidly improving in the erection of large and substantial accommodations for the wholesal trade, and would be seriously injured by the location of the Prison in the center of a business square.

We therefore respectfully urge the Council to dispose of the lot and erect the prison elsewhere.

Resolved, That the owners of the following described real estate, to-wit: Lot No. 8, in out-lot No. 181, be, and they are hereby, required to fill and drain the same, as, in the opinion of this Council, there is a hole or excavation thereon, in which water has or may become so stagnant and noxious as to be a nuisance and injurious to the health and comfort of said city and of the inhabitants thereof, and that the Street Commissioner be, and he is hereby, required to notify the owners thereof, as provided by an ordinance passed April 23d, 1866, entitled "An ordinance providing for the drainage and filling up of ponds, excavations and holes, and prescribing penalties for the failure to fill up or drain the same," and that in case of the failure of the owners thereof to fill or drain the same, the Street Commissioner proceed to drain or fill said excavation, as provided in said ordinance, provided the cost thereof shall not exceed ten per cent. of the value of the aforesaid real estate as assessed upon the tax duplicate for city purposes.

The question being on the adoption of the resolution,

Those who voted in the affirmative were Councilmen Brown, Gimber, Harrison, Heckman, Kennington, Marsee, Newman, Pyle, Thalman, Thoms, Weaver, Wiles and Woodburn—13.

No Councilman voting in the negative.

So the resolution was adopted.

The undersigned would respectfully represent unto your honorable body that they are severally property owners of and in out-lot No. 178 in said City, and own loss therein fronting on New Jersey street. They further say that said New Jersey street, on the east side thereof, along the west front of said entre out-lot, was opened and used for more than twenty years to the full width of the said street south of said block, thereby making the east half of said street, including the sidewalk, along the said west front of said out-lot forty-five feet; that the said city, and the public generally, and the owners of lots on and along said street, had thereby acquired and had in fact and in law a right of way in and to said street to the full width aforesaid; but they say that John W. Brown, Andrew Turner, George Wilson and William

C. Ewing have, within eighteen months last passed, removed their fences fronting on the said street, and on the west side of said block, so as to enclose five feet of the said sidewalk of said street in and along said west side of said block; that they are not advised of the grounds upon which said enclosure has taken place, or the authority under which the gentlemen named have acted in making the same; but they do say that such enclosure is an encroachment upon the rights of the city and the public generally, and a great wrong to your petitioners as lot owners fronting on said street and in the said out-lot. Ewing may, by an ordinance of your honorable body, be directed and compelled to replace their fences on the old line of said street, as the same had been known and used by the public for more than 20 years before said gentlemen set their fences out as aforesaid.

Mr. Thalman, from the Committee on Streets and Alleys, made the following report:

INDIANAPOLIS, July 19, 1869.

Committee.

To the Mayor and Common Council of the City of Indianapolis:

The Committee on Streets and Alleys, to whom was referred sundry proposals for street improvements, have examined the same and would recommend that contracts be awarded as follows. to wit:

For the improvement of Illinois street, from the north side of St. 1. Clair street to the north side of North street, Hanway and Lefever, at $59\frac{1}{2}$ cents per lineal foot for bowldering the gutters, bowldering the crossing of streets and alleys, $76\frac{1}{2}$ cents per superficial yard, graveling and grading per lineal foot front, \$171.

2. For the improvement of Illinois street, from the north side of St. Clair to First streets, to Hanway & Lefever, for bowldering gutters per lineal foot 59¹/₂ cents, grading and graveling per lineal foot front \$1.35, bowldering the crossings of alleys and streets $76\frac{1}{2}$ cents per lineal foot front on each side.

For repairing Illinois street from Ohio to the north side of North 3. street, Patterson & Dunning, bowldering gutters per lineal foot 56 cents, bowldering crossings of streets and alleys 72 cents per lineal foot front on each side, pit gravel 95 cents per cubic yard, screened river gravel \$1.35 per cubic yard for grading and graveling the alley running east and west through out lot 85, between lots 4 and 5, and 16 and 17, in said out lot, to August Richter, at 32 cents per lineal foot on each side.

For grading and graveling Arch street and sidewalks, between Broadway and Plum streets, to Hanway & Lefever, at \$1.60 per lineal foot on each side of the line improved.

For grading and graveling New Jersey street and sidewalks from 5.Merrill street to the north side of the first alley north of Merrill street, to Lefever & Hanway, at 86½ cts. per lineal foot on each side of the line improved.

For grading and graveling the alley lying between Daugherty and Coburn streets from East to Wright streets, to Huffington & Foust, at $86\frac{1}{2}$ cents per lineal foct on each side of line improved.

7. For grading and paving the north sidewalk on Indiana avenue, and curbing the outside edge with white oak plank from West to St. Clair street, to R. P. Dunning, at 60 cents per lineal foot front for paving, and 18 cents per lineal foot front for curbing.

8. For grading, paving, with brick and curbing, the outside edge of the sidewalk with white oak plank, the west sidewalk on Mississippi street from Washington to Market streets, to R. P. Dunning, at 63 cents per lineal foot front for paving, at 17 cents per lineal foot front for curbing

9 A petition was referred to your committee, signed by Levi Marshall and James Breen, in regard to water standing between the northern terminus of Winston and St. Clair streets, and as the same will cost considerable money, that an ordinance be passed to relieve them of the stagnant water complained of.

10 A remonstrance was also referred to your committee by the property owners on Illinois street, between Ray and Morris streets, in regard to the kind of gravel being placed on said street. We have examined the gravel and find it fair creek gravel taken from the bed of the tail race of the canal near Underhill's mill. The Civil Engineer has taken the matter in hand and will see that the proper material is furnished.

11. A petition was referred to your committee, from Frederick Jasper, Samuel Moore and others, asking for the vacation of three feet off the east side, of the first alley west of Virginia avenue, between Stevens street and Merrill street, fronting on Stevens street. We recommend that the prayer of the petitioners be granted and the vacation ordered JOHN MARSEE,

9. Contract and bond of Charles Rooney to pave, with brick, the sidewalks on Tennessee street, from Indiana avenue to North street.

10. Contract and bond of Charles Rooney to pave, with brick, the west sidewalk on Illinois street, and curb the outside edge, with white oak plank, from South street to Pogue's run.

11. Contract and bond of Deloss Root and Jerome B. Root for erecting lamp posts, lamps and fixtures complete to burn gas, except the service pipe on Alabama street, from Washington street to Pogue's run.

2 12. Contract and bond of Orlando Link for the removal of dead animals dying within the city, giving as security John P. Frenzell.

13. Contract and bond of Rich'd Carr for grading and graveling Chestnut street, and west sidewalk from Ray to Morris street.
