REGULAR SESSION.

CHAMBER OF THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, Monday, October 4th, 1869, 7 o'clock, p. m.

The Common Council met in regular session.

Present—His Honor, the Mayor, Daniel Macauley, in the chair, and the following members:

Councilmen Brown, Cottrell, Gimber, Harrison, Heckman, Kahn, Kennington, Locke, Marsee, Newman, Pyle, Shepherd, Thoms, Weaver, Whitsit, Wiles and Woodburn—17.

Absent-Councilman Thalman-1.

The proceedings of the regular session held Sept. 27, 1869, were read and approved.

Sealed proposals for public work were opened and read and referred to the Committee on Contracts.

Mr. Wiles, from the Committee on Contracts, made the following report:

INDIANAPOLIS, Oct. 4, 1869.

To the Mayor and Common Council of the Crty of Indianapolis:

lst. For grading and graveling Cumberland street and sidewalks, from Missouri to West streets, to James Mahoney, at thirty-five cents per lineal foot on each side of the line improved.

2d. For grading and graveling Muskingum alley from Pratt to First streets, to Newton Kowan, at thirty-five cents per lineal foot on each side of the line improved.

3d. For grading and graveling Severn alley and sidewalks, between Saint Clair and Pratt streets, to William Kowan, at thirty-five cents on each side of the line improved.

4th. For grading, paving with brick, and curbing the outside edge with white oak plank, the south sidewalk on Indiana Avenue, from Mississippi to West streets, to Charles Roney, at 68 cents per foot front for paving, and 20 cents for curbing.

5th. The contract for grading and graveling Maryland street and side walks from West to Helen street, was awarded to John Schier on the 20th of September, at 66½ cents per lineal foot front on each side of the line improved. Mr. Schier has informed the Clerk that he made a mistake in his bid. He says that he bid with the understanding that the gravel was to be 25 feet wide, instead of 35 feet, in the center. There were three other bidders, which were as follows: James Mahoney, \$1.00; Hiram Seibert, \$1.20; and Hanway & Lefever, 99 cents. Hanway & Lefever being the next lowest bidders, we would recommend that they be awarded the contract.

6th. For the improvement of St. Joseph street, from Meridian to Illinois street, there was only one bid presented, and that was by James Mahoney, at \$1.75 per foot front on each side of the line to be improved. We would recommend that the City Clerk re-advertise for proposals to improve said street.

Resolved, That the Common Council of the City of Indianapolis will, as soon as the requisite ordinance can be passed, appropriate the sum of one thousand dollars for the benevolent object named, to be distributed as aforesaid.

That the Mayor appoint a select committee to inquire whether more suitable rooms cannot be secured for the City Offices, Mayor's Court, and for the Council Chamber, and to report the result of their investigation to the Common Council; also, in case of a change of rooms, whether the existing lease for rooms in Glenns' Block can be surrendered or not without cost.

Mr. Brown introduced special appropriation ordinance No. 42-1869, entitled:

AN ORDINANCE appropriating one thousand dollars for the relief of the sufferers by the late explosion at the Fair.

Mr. Heckman introduced special ordinance No. 116-1869, entitled:

AN ORDINANCE to provide for the erection of lamp-posts, lamps and fixtures complete to burn gas, except the service pipe, on South street, between East and Noble streets.

Which was read the first time.

Mr. Harrison offered the following motion :

That permission is hereby granted to Henry Severin to grade and pave with brick the sidewalk in front of his property, Nos. 153 and 155 on Ft. Wayne Avenue, the same to be done at his own expense, and according to the grade stakes to be set by the City Civil Engineer.

Which was adopted.

Mr. Kennington offered the following motion :

That the Street Commissioner is directed to repair the culvert on Delaware street at the crossing of the Central Railroad track.

Which was adopted.

Mr. Locke offered the following motion :

That the Street Commissioner be instructed to build plank crossings over the gutters on Michigan and Blackford streets, near the Fourth Ward School House; also, to raise with gravel the sidewalk on Michigan street to grade, in front of said School House.

Which was adopted.

Mr. Marsee offered the following motion:

That the Committee on Public Buildings be authorized to employ a competent Architect to furnish plans for a Station House, not to cost more than (\$8,060) eight thousand dollars, said plans to be submitted to this Council when complete.

The question being on the adoption of the motion,

Those who voted in the affirmative were Councilmen Brown, Gimber, Heckman, Marsee, Shepherd and Whitsit-6.

Those who voted in the negative were Councilmen Harrison, Kahn, Locke, Newman, Pyle, Thoms, Wiles and Woodburn-8.

So the motion was lost.

Mr. Shepherd offered the following motion :

That the City Clerk re-advertise for proposals for the purchase of the City lot on Maryland street, and that in such advertisement the terms of purchase be stated to be one-third in cash, one-third in one year, and one-third in two years.

Mr. Marsee offered the following motion:

That the Committee on Streets and Alleys, with the Civil Engineer and Street Commissioner, be authorized to make two culverts at street crossings with the cement drain-pipe made by the Indianapolis Cement Works—said Company to receive no pay for the pipe in case it fails to make a good and permanent culvert.

Which was adopted.

Mr. Whitsit introduced special ordinance No. 117-1869, entitled :

AN ORDINANCE to provide for the erection of lamp-posts, lamps and fixtures complete to burn gas, except the service pipe, on Noble street, between Washington street and Virginia Avenue.

Which was read the first time.

Dr. Woodburn offered the following resolution :

Resolved, That an estimate of the cost of constructing the Sewer on South street be made, and that the cost thereof be assessed against the owners of such lots or lands as are benefited thereby, in such equitable proportions as may be deemed just, and that all the lots and lands in the corporate limits of said city, lying south of Pogue Run, are benefited thereby, and that for the purpose of determining what the proportion of benefits to each lot is, a meeting be held on ————— the ————— day of ————, 1869, and that the cost of the construction of said Sewer be estimated against the property owners within the limits aforesaid : *Provided*, That not more than ten per cent. of the value of any of such lots or lands shall be assessed against the same in any one year.

Mr. Marsee, from the Committee on Streets and Alleys, made the following report :

INDIANAPOLIS, Oct. 4, 1869.

To the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN:—The Committee on Streets and Alleys, to whom was referred a petition signed by Julia A. Brown, R. M. Cosby and others, asking the Council to vacate Railroad street from Massachusetts Avenue to Saint Clair street; and also a remonstrance against vacating said street, signed by Robt. F. Bence, John Coburn, Andrew Wallace, John L. Hanna and others, report againt the vacation of said street, and that the Street Commissioner be directed to notify R. M. Cosby to remove all obstructions placed by him at the nº

intersection of Railroad street and Massachusetts Avenue, and on failure to do so within five days from time of notice, that the City Attorney take legal steps to compel him to do so.

2d. A statement was also referred to your Committee, made by the Civil Engineer, in regard to work done by Thomas Wren on Tennessee street. It appears by said statement that Thomas Wren has been paid for all the work done by him, and that the report of the Civil Engineer, in regard to said work, be received and concurred in by the Council, Mr. Wren having been paid, as the Engineer states, for the embankment, which was the largest, and therefore Mr. Wren is not entitled to cut and fill both and should not be paid for it.

3d. We would recommend that the Street Commissioner be directed to complete the culvert on the west side of Delaware street, north of the Union Railway track, and that he also be directed to fill with gravel or cinders the curve in the track of the Citizens' Street Railway Company, at the corner of New Jersey street and Fort Wayne Avenue.

4th. A communication was presented to your Committee from Andrew Wallace, Esq, stating that hc had, at his own expense, bowldered the gutter and curbed the outside edge of the sidewalk with stone in front of his property on Maryland steet, between Virginia Avenue and Pennsylvania street, and claiming that he will be entitled to a credit for the same, which we think is so, and would refer the Council to section 69 of the City Charter, page 34.

To the Mayor and Common Council of the City of Indianapolis:

The undersigned, Commissioners for the opening of Streets and Alleys, to whom was referred the petition of F. A. Lehr and others, property owners in out-lot number one hundred and seventy eight, in the City of Indianapolis, and fronting on New Jersey street, beg leave to report that in pursuance of notice given by the City Clerk they met at the City Clerk's office on the 13th,

14th and 15th days of September, 1869, and proceeded to view the ground petitioners ask vacated, to wit, so much of the former sidewalk as has been inclosed in the front fences of John W. Brown, Andrew Turner, Geo. Wilson and William C. Ewing, being five feet deep by the frontage of their respective lots, so as to make the sidewalk from St. Clair street to Gregg street uniform with the same walk south of St. Clair street. A majority of the Commissioners have determined as follows:

1st. That no damages should be assessed against the City of Indianapolis.

2d. That the vacating of said afore specified ground would not damage the afore mentioned Brown, Turner, Wilson and Ewing.

1st. That no part of the damages occasioned by the opening of said street should be assessed against the City of Indianapolis.
