REGULAR SESSION.

CHAMBER OF THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, Monday, FEBRUARY 7, 1870, 7 o'CLOCK P. M.

The Common Council met in regular session.

Present—His Honor, the Mayor, Daniel Macauley, in the chair, and the following members:

Councilmen Brown, Cottrell, Gimber, Harrison, Heckman, Kahn, Kennington, Locke, Marsee, Newman, Pyle, Shepherd, Thalman, Thoms, Weaver, Whitsit, Wiles and Woodburn-18.

Absent-None.

The proceedings of the regular session held January 31, 1870, were read and approved.

Mr. Brown moved to take up the report of the special committee proposing to lease Cottrell & Knight's building for the use of the City Officers, made to Council December 7, 1870.

The said report was read.

Dr. Woodburn moved to postpone the consideration of said report for one week, in order that other committees might report on the same subject.

The question being on postponement.

Those who voted in the affirmative were Councilmen Harrison, Kahn, Locke, Pyle, Thalman, Wcaver, Wiles and Woodburn-8.

Those who voted in the negative were Councilmen Brown, Gimber, Heckman, Kennington, Marsee, Shepherd, Thoms and Whitsit--8.

There being a tie vote, his Honor, the Mayor, voted in the affirmative.

So the motion to postpone was adopted.

CALL OF THE ROLL.

Mr. Brown offered the following motion :

That the proprietors of competing engines who were invited to leave their engines for a three month's trial, by a motion of the Council on the 29th day of January, 1870, be required to deliver their engines here by the 15th of March next.

Which was adopted.

Mr. Brown introduced General ordinance No. 7, 1870, entitled:

AN ORDINANCE providing for the inspection of steam boilers.

Which was read the first time.

Mr. Cottrell introduced Special ordinance No. 15, 1870, entitled :

AN ORDINANCE to provide for the crection of lamp posts, lamps and fixtures complete to burn gas, except the service pipe, on New Jersey street, from Merrill street to Bicking street.

Which was read the first time.

Mr. Cottrell introduced Special ordinance No. 16, 1870, entitled :

An Ordinance to provide for the erection of lamp posts, lamps and fixtures complete to burn gas, except the service pipe, on East street, from South to Dougherty street.

Which was read the first time.

Mr. Cottrell offered the following motions:

That the Street Commissioner be instructed to open the gutter on the east side of Delaware street, between Merrill and Bicking street.

That the street Commissioner be instructed to repair the east sidewalk of Alabama street, between Merrill street and the first alley south, the same now being in a dangerous condition.

That permission be given to the property holders to grade the alley (at their own expense) running north and south through out-lot No. 105, to the first alley south of Merrill street, and that the Civil Engineer be directed to set the necessary grade stakes.

Which were adopted.

Mr. Cottrell offered the following resolution :

Resolved, That a resolution passed by the Common Council on 7th day of January, 1870, in reference to contractors, be and is hereby reconsidered.

The question being on the adoption of the resolution.

Those who voted in the affirmative were Councilmen Brown, Gimber, Heckman, Locke, Shepherd, Whitsit and Woodburn-8.

Those who voted in the negative were Councilmen Harrison, Kennington, Marsee, Newman, Pyle, Thalman, Thoms, Weaver and Wiles-9.

So the resolution was not adopted.

Mr. Harrison offered the following motion:

That permission be and is hereby granted to Thomas McHugh, to grade and gravel the sidewalk in front of his property, on the east side of Plum street, from Cherry street to the first alley north of Cherry street; the same to be done at his own expense, and according to grade stakes to be set by the City Civil Engineer.

Which was adopted.

Mr. Harrison presented the following remonstrance:

INDIANAPOLIS, Feb. 7, 1870.

To the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN:—The undersigned would respectfully remonstrate against the passage of the ordinance now pending before your honorable body, for the grading and graveling of Chesapeake street and sidewalks, from West street to the first alley east of West street, between Georgia and Maryland streets. Your petitioner is the owner of 125 feet fronting on said street, and does not deem said improvement necessary at the present time, and especially if the same is not made through to Missouri street. It would neither be just nor beneficial to improve the street to said alley only, and not clear through to Missouri street.

Which was referred to the Committee on Streets and Alleys.

Mr. Kennington offered the following motion :

That the City Civil Engineer be directed to advertise for proposals for building a bridge across the new channel of Pogues run, on Tennessee street, according to plans and specifications for the same, to be prepared by the City Civil Engineer.

Which was adopted.

Mr. Kennington introduced Special ordinance No. 17, 1870, entitled:

AN ORDINANCE to provide for the erection of lamp posts, lamps and fixtures complete to burn gas, except the service pipe, on Tennessee street, from Pogues run to Ray street.

Which was read the first time.

Mr. Kennington introduced General ordinance No. 8, 1870, entitled:

AN ORDINANCE establishing and bounding the wards of the city of Indianapolis.

Which was read the first time.

Mr. Locke presented an injunction or restraining order against the further prosecution of the work of straightening Pogues run, until Friday, February 11, 1870.

Mr. Cottrell moved to lay on the table, and called for the ayes and noes.

The question being on the adoption of the motion to lay on the table.

Those who voted in the affirmative were Councilmen Brown, Cottrell, Gimber, Kennington, Marsee, Shepherd and Thalman-7. Those who voted in the negative were Councilmen Harrison, Heckman, Locke, Newman, Pyle, Thoms, Weaver, Whitsit, Wiles and Woodburn-10.

So the motion to lay on the table was lost.

On motion by Mr. Brown the City Attorney was instructed to defend the injunction suit, and the Contractor directed to proceed with that part of the work not enjoined.

Mr. Pyle presented the following petition :

INDIANAPOLIS, Feb. 7, 1870.

To the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN: - The undersigned, resident freeholders of the city of Indianapolis, would respectfully petition your honorable body to open a street fifty feet wide, to connect Meridian and Illinois streets; the said street to commence on the west side of Meridian street, on the east line of lot No. 12 in St. Clair's addition to the city of Indianapolis, about two hundred and thirteen feet north of the southcast corner of said lot, to run thence west paralel with the south line of said lot, and on the line dividing the lands of J. D. Condit and William Henderson, to the west line of said lot twelve (12); thence west on the same parallel line and through block No. 20 in Drake's addition to Illinois street. The said street, when opened, will run through the lands of Wm. Henderson, J. D. Condit, E. B. Martindale and John A. Hoagland.

GENTLEMEN:—The select committee, to whom was referred the proposals for erecting a Station House, have examined the same, and find that James Maloney is the lowest bidder on both plans, as furnished by Messrs. Enos & Huebner, and Messrs. Daggett & Roth; his price under the plan of Enos & Huebner being \$8,130 86, and under the plans prepared by Daggett & Roth, \$8,754 75; the bid under Enos & Huebner's plan being \$623 89 less than under the plan of Daggett & Roth. The committee would respectfully report the same to the Council for their decision—which plan had better be adopted.
