Special Appropriation Ordinance No. 36, 1870, entitled :

AN ORDINANCE appropriating money for the payment of sundry claims against the city of Indianapolis.

Was read the second time and ordered to be engressed.

The ordinance was then read the third time and placed upon its passage.

The question being, shall the ordinance pass?

INDIANAPOLIS, July 18, 1870.

.To the Mayor and Common Council of the City of Indianapolis :

GENTLEMEN:—The Select Committee appointed by order of the Common Council made on the 24th of March, 1870, beg leave to submit a report, setting forth the advantages of Indianapolis as a Manufacturing City, which your committee recommend be published in pamphlet form for general circulation.

Your Committee called to its aid in preparing the report, the services of Prof. R. T. Brown, who furnished much valuable information on the Geology of the State; of Ignatius Brown, Esq, who prepared the maps and collated

most of the facts contained in the report, and of Barton D. Jones, who compiled the statistics which are referred to therein. Your committee recommend allowances to these gentleman, as follows: Prof. R. T. Brown, \$50; Barton D. Jones, \$100; Ignatius Brown, \$200 for services, and \$30 for expenses, to Chicago and return.

Your committee contracted for, and had engraved, twenty five thousand maps, showing the railroads centering at and leading from Indianapolis, and. also, obtained an electrotype of a correct geological map of the State, the whole expense of the same being \$434 30, which your committee ask be allowed Luther R. Martin, who has advanced the money to pay the same.

Your committee suggest that the letter press of the pamphlet be stereotyped, and that an edition of twenty-five thousand copies be printed for general circulation.

INDIANAPOLIS, July 18, 1870.

C. E. Whitset, Esq., Councilman:

DEAR SIR:—You ask an answer to this question: "Can the Common Council after a contract has been duly awarded, and the contract and bond duly executed and approved, reconsider their action and set the contract aside?"

I have no hesitancy in answering that the Common Council cannot, under such circumstances, legally annul the contract.

GENTLEMEN:—The undersigned, your petitioner, represents to you that he is the administrator of the estate of Rudolph Rogge deceased, that as such administrator, he has paid to the Treasurer of the city of Indianapolis, as tax on the personal property and real estate belonging to the said estate, and poll tax against said Rogge, the sum of forty-two dollars and ninety-three cents, (\$42 93) and the said personal property was assessed at the sum and value of twenty-five hundred and fifty (\$2,550) dollars, that the actual value of said personal property was not to exceeed twelve hundred dollars on the 1st day of January, 1869; that said Rogge, at the time said assessment was made, was in a condition of habitual and beastly intoxication, and incapable of understanding the ordinary business affairs connected with his own estate, or estimating the value thereof; that the Assessor of the city of Indianapolis represents that he believes the said valuation to be excessive; wherefore, your petitioner prays your honorable body that an equitable proportion of the said tax paid, be refunded.

AN ORDINANCE to provide for grading and bouldering the gutters on the west side of New Jersey street, and curbing the outside edge of the sidewalk with white eak curbing, from the south line of lot number six, in outlot 22, to south end of lots one, two and three, in out-lot 19.

Mr. Cottrell offered the following motion:

That the Street Commissioner fill up with gravel, the low places on New Jersey street, immediately south of South street, and also to remove the large boulder stones laying on said street.

Which was adopted.

Also, the following motion :

That the Street Commissioner notify the Citizens Street Railway Company to so place their track, at the corner of Tinker and Illinois streets, as to conform to section 9 of their charter.

Which was adopted.

Also, the following motion :

That the Street Commissioner notify the Indianapolis, Cincinnati and Lafayette Railroad Company, to raise the planking to the top of the tracks at the crossing of Louisiana street with Virginia avenue; and, also, to plank the same at the crossing of the first alley west of New Jersey street on Louisiana street, and on failure of said Railroad Company to do so, after ten days notice, the said officer is hereby directed to do the work, and collect the cost of same from said Company.

Which was adopted.

Also, the following motion :

That the City Marshal give written notice to the Indianapolis Starch Company to cease running their slop into Pogue's Run, and on their failure to do so, to enforce the ordinance in regard to persons or corporations committing nuisances.

Which was referred to the Board of Health.

Mr. Cottrell offered the following resolution :

Resolved, That the City Marshal shall have the control of the Station House when the the some shall have been completed.

Which was referred to the Board of Police.

Mr. Harrison offered the following motion :

That permission be and the same is hereby granted, to Joanna Kessler, the owner of lot No. 1, in Young's subdivision, to pave with brick the sidewalk in front of her said property, on St. Clair street, on Massachusetts avenue, and on Plum street; the same to be done at her own expense, and under the direction of the City Civil Engineer.

Which was adopted.

Also, the following motion :

That the City Gas Inspector be and he is hereby instructed to change the location of the lamp posts on North street, between Delaware and Alabama street, so as to light the alleys, in conformity to the existing ordinance on ^the subject.

Which was adopted.

Mr. Harrison presented the following petition:

INDIANAPOLIS, July 18, 1870.

To the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN: — The undersigned respectfully request you to vacate so much of the first alley west of Jackson street or Park avenue, as lies between lots 28 and 29, in out-lot 180, and lot 67, in out-lot 181, being that part of said alley that extends from the first alley south of Cherry street, and east of East street, o the second alley south of Cherry street, and east of East street.

We ask this, because the part of said alley which we desire vacated, is not, and never can be, of any available use to the public, or to any adjancent property holders; inasmuch as, that, precisely the same convenience for ingress and egress to and from all the lots lying on said alley, (except the three lots above specified,) will still remain after said vacation as now exist; and because that part of said alley which we desire vacated, is, and must ever remain, (if kept open,) a source of inconvenience and expense to the parties who may own and occupy the three lots above specified, inasmuch as it will compel them to maintain two fences instead one. For further particulars, you are referred to the accompanying plat.

GENTLEMEN: —Your petitioner would respectfully represent that the firm of Harding, Morton & Finch, of which he was a member, are charged with a tax of \$44 for the year 1868, upon the property held by them in the *Daily Evening Mirror*, which upon misinformation as to what was properly taxable,, was estimated by John R. Morton, to be of the value of \$4,000. The property belong to the firm at that time consisted wholly of type, printing material and office furniture, and was worth less than one thousand dollars. Mr. Morton estimated the value of the unearned business on the books when he made the return, and hence the discrepancy.

That the Indiana Central Railway Company and the Junction Railroad Company, be respectively notified to improve and extend the planking at the crossing of Michigan Road and sidewalk; Orient street and sidewalks; South Arsenal avenue and sidewalks, and State avenue and sidewalks, in accordance with the provisions of the grants of right-of-way from the city to said companies, and that said companies without delay, make such improvements.

Also, the following motion :

That Christian Brand be and is hereby, permitted to plank or boulder the crossing of the sidewalk on Michigan Road, and the intersection of Wash^w_s ington and Orient street.

Which was adopted.

Also, the following motion:

That the City Engineer be and he is hereby instructed to lay out and establish the grade of South Arsenal avenue from Washington street to Michigan Road, snd, also, East Willard street from Washington street to north side of Central Railway track; also, Blake alley from South Arsenal avenue to State avenue on east Corporation line, and that J. M. Ridenour be allowed to grade said streets so laid out and established, at his own expense, so far as the same are laid on the plat of ground owned by him.

That John Knight, appointed by the Common Council to superintend the laying of the wooden block pavement on Delaware street, be and is hereby empowered to employ one or more persons, (not exceeding two,) to assist him in superintending said work, at a cost not exceeding two dollars each per day.

Which was adopted.

Also, the following motion :

That the City Marshal notify the Citizens' Street Railway Company to stop the reckless manner of dragging their cars over the bouldered streets, when off the track, the same being very damaging to the streets, and very cruel to the horses and mules.

Which was adopted.

Also, the following motion :

That in appointing overseers to superintend the laying of the block pavement on Delaware street, the Council nevertheless reserves the right to reject the work, if the same is not done according to contract.

Which was adopted.

Also, the following motion :

That the Street Commissioner be instructed to clean the gutters on Pennsylvania street, between Washington and North streets; also, all gutters needing cleaning.

Which was adopted.

Mr. Locke presented the following petition :

That the contractor for building the Meridian Street Methodist Episcopal Church, corner of Meridian and New York streets, be notified by the City Marshal to remove the stone and rubbish from Meridian and New York streets, adjacent to said building, placed there by and under him, within eight days, and in default of his so doing, that the Marshal remove the same at the expense of the contractor.

Which was adopted.

Also, the following motion :

That the City Clerk cause the passage of the ordinance in regard to hogs running at large, and prescribing the penalty therefor, to be duly published according to law.

Which was adopted.

Mr. Pyle introduced Special Ordinance No. 141, 1870, entitled :

AN ORDINANCE to provide for grading and bowldering the alley running north and south in square 57.

Which was read the first time.

Mr. Reagan introduced Special Ordinance No. 142, 1870, entitled:

AN ORDINANCE to provide for the erection of lamp posts, lamps and fixtures complete to burn gas, except the service pipe, on McCarty between Illinois and Tennessee street.

Which was read the first time.

Mr. Reagan offered the following motion :

That the Street Commissioner be directed to notify the Union Railroad Company to open the culvert on the west side of Louisiana and Tennessee streets, and build said culvert with rock, from the north side of Louisiana street to the railroad.

In case said Union Railroad Company fail to comply with this order, the Street Commissioner be directed to proceed with said work without further orders.

Which was referred to the Committee on Streets and Alleys.

Also, the following motion:

That a bridge be built across Pogue's Run on McCarty street. It is also recommended that it be built with, and arched over with rock. The said bridge to be twenty-four feet wide, and the Civil Engineer be instructed according to the general plan of bridges, and report back to this Council the estimate of the same.

Which was referred to the Committee on Bridges.

Mr. Thalman offered the following motion:

That Charles Kuhn be allowed to dig a well, and put in a pump, in front of his property on Indiana avenue, he complying with the ordinance governing the same.

Which was adopted.

Also, the following motion:

That the Lafayette and Indianapolis Railroad Company be notified to immediately put in culverts under their track on the north and south side of First street, which is now being improved.
