The Committee on Contracts, through Councilman Thalman, submitted the following report:

To the Mayor, Common Council and Board of Aldermen:

Gentlemen:-The Committee on Contracts, to whom was referred sundry proposals presented to Council September 18th, 1882, have examined the same, and find them to be as follows, viz:

1st. For grading and graveling the first alley east of Everson street, from the first alley south of Prespect street to Orange street.

and unless the work is done without unnecessary delay, they will be filed against for maintaining a nuisance, and that the Street Commissioner will do said work and charge the cost thereof to said Gravel Road Company.

That the City Marshal be, and is hereby, directed to notify the Wabash Railroad Company to plank their crossing at East street.

That the City Marshal be, and is hereby, directed to notify the P. C. & St. L. R. R. Company to plank their crossing on Cruse street.

That the City Marshal be, and is hereby, directed to notify the property owners to remove their fences out of Dillon street, between Harrison and Meek streets.

Councilman Egger introduced the following entitled ordinance; which was read the first time:


S. O. 170, 1882—An ordinance to provide for grading, and paving with brick, the sidewalks of Merrill street, from East street to Virginia avenue.

# REGULAR SESSION—SEPTEMBER 25, 1882.

#### Indianapolis, Sept. 18, 1882.

To the Mayor, Common Council and Board of A'dermen:

Gentlemen:-1. Since the last meeting of the Council, the case of John McIntire vs. The City, has been tried, resulting in a verdict for the city. It was an action for damages on account of injuries received in falling into an open area way alongside of the Capital House on west Washington street.

2. The plaintiff in the case of Levi Britton vs. The City, after the same was ready for trial, dismissed the same at his own costs. This was an action to recover damages for personal injuries sustained in falling on the ice in front of the Capital House in the winter of 1881.

3. Some weeks ago my attention was called to the fact that the city was entitled to a deed from the C., C., C. and I., and I., P. and C. Railway Companies for a strip of ground forty feet wide between Alabama and New Jersey streets, for the extension of Maryland street, under the contract and ordinance between said companies and the city, of March 4th, 1878, which may be found set out in full in the printed proceedings of the Council and Board of 1877-8, pp. 770 to 787, inclusive. I called upon Mr. Gale and Mr. Malott, representing said companies, respectively, who at once caused the proper deed to be executed, which I herewith hand to the Clerk, and suggest that he be directed to have the same recorded.

4. I also herewith hand to the Clerk a deed from the County Auditor to the City for Lots 1, 2, 3, 4 and 5, in Square 11, of Braden's Riverside Addition to Indianapolis, which the city heretofore purchased at tax sale. It should also be recorded.

5. At the request of various members of the Board and Council, I petitioned the Circuit Judge to appoint three appraisers, under the provisions of the Act of 1878, (see Sections 3,111 to 3,113, inclusive, of the Revised Statutes, 1881), to appraise the various pieces of real estate belonging to the city, which it is thought the city may desire to sell in the near future. I included all of the Tomlinson property, the "Sellers Farm," the Hospital property, and the "Garfield Park" property. Judge Adams appointed as such appraisers, John S. Spann, Lorenz Schmidt and E. B. Martindale. I hand said appointment to the Clerk. If your honorable bodies shall desire and order such appraisements made by said parties, I saggest that you direct the Clerk to notify them to appear and take the requisite oath, which I have prepared and appended to said appointments.

6. Since I was directed to bring suit on the bond of John Stumph & Son, for failure to complete the cistern at the corner of Eddy and Merrill streets, unless said work should be done without unnecessary delay, they have completed the same. I delayed bringing suit, ascertaining that it was impossible to do the work on account of natural causes, which the contractors could not possibly overcome. On account of the matters referred to, several individual members of your honorable bodies requested me to delay bringing suit, and I trust my action may be approved.

7. I was also directed to bring suit against R. H. Patterson on his bond, for failure to bowlder the first alley east of Meridian street, from the south line of Lot. No. 6, Square 97, south to Pogue's Run, unless said contractor, upon notice, should immediately do said work. I immediately gave such notice, and the work has been done. Respectfully submitted,

But believing the city ought not to take advantage of legal technicalities to secure doubtful or unjust claims, we recommend that the money be refunded, with legal interest.

Indianapolis, Sept. 25, 1882.

To the President and Members of the Board of Aldermen :

Gentlemen:—The question of the right of the Board of School Commissioners to levy a poll tax of \$1.00 against the citizens of Indianapolis, was referred to us for our opinion.

Under the Statute creating and governing the School Board, the Council and Board of Aldermen have no defined right to in any way interfere with the action of said School Board, either as to the levying or collecting of her taxes, or any other matters pertaining to the schools of said city.

Your committee, however, after a careful examination of the question referred to them, state it as their opinion, that the School Board have no right, under the law, to levy or cause to be collected, a poll tax of any amount whatever, and believe that any tax payer can, after the duplicate has been made up and delivered to the treasurer, enjoin the collection thereof. But as the work of putting this poll tax on the duplicates, will cost the city a considerable amount of money, and afterwards be of great annoyance to the officers of the city, in certifying the same off, in case the question should be decided against the School Board, we deem it our duty to recommend that the question of the legality of said levy be at once settled. Unless the School Board, therefore, will agree to submit the question to some good lawyer, and recall that part of their levy, in case the question is decided against them, we recommend that the Council and Board of Aldermen pass a motion requesting the City Clerk to refuse to put said tax on the duplicate. The Board can then proceed

by mandate to compel him to do so, and thus raise the question. This is the only way the question can by now presented to a court of record for determination.

Such committee is also directed to report whether or not, the "City Sexton" is complying with the ordinance requiring him to "generally perform all duties necessary to keep said burying grounds in the best order," and "to keep the same in repair."

Alderman Rorison offered the following motion; which was adopted:

That the City Civil Engineer be, and is hereby, instructed to notify the contractors for the improvement of Meridian street, from New York street to St. Clair street, that suit will be instituted to recover on their bond, if the work is not commenced at once, and finished according to contract.

Alderman Rorison, in behalf of a certain select committee, submitted the following *majority* report:

#### To the President and Members of the Board of Aldermen :

Your committee report as follows, on the resolution to raise the sidewalk to conform to the original grade of Tennessee street:

The original improvement caused the water to flow north; in the new improvement to cause the water from Tennessee street and Indiana avenue to run into the sewer. The Engineer raised the curb three inches. By so doing, the sidewalk was thrown three inches below the curb. The oridinal grade having been fixed by the City Engineer, it is but right that the city should bear the expense of the change of grade, and not the property owner. The total cost is estimated \$5.00.
