## REPORTS, ETC., FROM CITY OFFICERS.

The City Attorney submitted the following report; which was received:

Indianapolis, Oct. 2, 1882.

To the Mayor and Common Council:

Gentlemen:—I was instructed by the Board of Aldermen to prepare and have presented to the Council, an ordinance "to prevent persons from standing and riding on steps of street cars, and providing penalties."

I have prepared one, which I hand to His Honor, the Mayor, for introduction, covering, as I suppose, the matters desired by the author of the motion.

His Honor, the Mayor, as per foregoing report, presented the following entitled ordinance; which was read the first time:

G. O. 75, 1882—An ordinance making it unlawful to ride on the steps of Street Cars, and for drivers and conductors of Street Cars to allow persons to so ride.

The City Attorney submitted the following report; which was concurred in, and the City Attorney authorized to employ the law firm of Hawkins & Norton, as attorneys in the case:

Indianapolis, Oct. 2, 1882.

To the Mayor, Common Council, and Board of Aldermen:

Gentlemen:—Before I was elected City Attorney, the law firm of which I am a member, brought an action for one Malinda Murphy, against the city, to recover damages for personal injuries received on account of a defective street. The Circuit Court sustained a demurer to the plaintiff's complaint. An appeal was taken from that ruling to the Supreme Court, and that court has now reversed the judgment of the Circuit Court, and remanded the case for trial

Of course I cannot now take any further part on either side of said cause, and respectfully suggest that your honorable bodies each name a committee to select and employ an attorney to appear and defend said cause for the city, giving them power

to act.

2. Some months ago, the old case of Rockwood, et al. vs. The City, brought several years ago, to enjoin the city from the further collection of taxes on the lots or blocks of ground in what is known as the I. & C. R. R. Co.'s subdivision southeast of the city, was referred, with two other cases, to the Judiciary Committees of your two bodies, with power to instruct me as to what further steps, if any, I should take in defense. As to this case, the committees gave me no definite instructions; but the feeling seemed to be, that the decision of the court be taken on all the legal questions involved, at least, before the city should abandon the defense. I have consequently proceeded with the case to a final determination, the court holding against the city on every question in the case, and a perpetual injunction has now been entered against the city collecting any more taxes on land in this subdivision. The record was put in proper shape for an appeal, if your honorable bodies desire one taken.

I state it as my opinion, however, as 1 have done before, that the action of the Council in 1874, in attempting to annex this territory by resolution, was a nullity. Unless I am ordered to appeal said cause, I suggest that the Assessor and Clerk be directed to be resulting and the subdivisions.

be directed to hereafter leave all the lots in said addition, and the subdivisions thereof, off of the tax duplicates; and that the Treasurer be directed to cancel all taxes now on the duplicates in his hands, in accordance with the decree of the court.

The first is the petition of F. McWhinney, showing that on August 19th, 1880, he purchased Lot 2, Square 3, Myer's subdivision, for \$55.45, and paid addisig. 40.

tional taxes of \$2.68; also, Lot 1, Square 3, same subdivision, for \$55.45, and paid additional taxes of \$2.68; also, Lot 3, Myer's subdivision D. & M.'s second addition, for \$19.75, and paid additional tax of \$1.60, at city tax sale.

At time of sale, all the above real estate had been forfeited, under the School fund, to the State, and title was in State of Indiana before the above tax sale. For this reason petitioner asks that above amounts, with interest, be refunded.

The City Treasurer informs your committee that the facts stated in petition, are true. Our Supreme Court, in case of Grovrn, Auditor of Tipton County, vs. The State, on relation of Bowlin, 24 Ind., 255, decide that where lands are taken by the State for non-payment of mortgage debt, the State takes the land free from all assessments and taxes made and levied between the date of the mortgage and date of the deed.

The above sales were therefore void, and therefore recommend that above sums, with interest, be refunded to petitioner.

2. The second is the petition of Frank McWhinney, showing that on February 9th, 1880, he purchased at tax sale Lots 21, 22, 26 and 28, in Beli's subdivision of Square 26, Johnson heirs' addition, for \$50.29. The sale was void, that said lots were taxed double on the duplicate; property sold in name of Edwin A. Benedict, and taxes paid in name of Brown, before sale.

City Treasurer informs your committee that facts stated in petition, are true. We therefore recommend that \$50.29 be refunded, with interest.

3. The third is the petition of I. N. Patterson, City Treasurer, showing that he issued two receipts for the same tax, to-wit: Nos. 7,913 c., 2,532 d., each receipt for \$8,03—total, \$16.06. In making his report to the Council, both receipts have been credited, and stubs show that both have been received to the city, in the return of taxes for April, 1882.

We are satisfied a mistake has been made, and therefore recommend that \$8.03 be refunded to the City Treasurer.

To the President and Mombers of the Board of Aldermen:

Gentlemen:—The question of the right of the Board of School Commissioners to levy a poll tax of one dollar against the citizens of Indianapolis was referred to us for our opinion.

Under the statute creating and governing the School Board, the Council and Board of Aldermen have no defined right to in any way interfere with the action of said School Board, either as to the levying or collecting of her taxes, or any

other matters pertaining to the schools of said city.

Your committee, however, after a careful examination of the question referred to them, state it as their opinion, that the School Board have no right, under the law, to levy or cause to be collected a poll tax of any amount whatever, and believe that any taxpayer can, after the duplicate has been made up and delivered to the Treasurer, enjoin the collection thereof. But as the work of putting this poll tax on the duplicates will cost the city a considerable amount of money, and afterward be of great annoyance to the officers of the city, in certifying the same off, in case case the question should be decided against the School Board, we deem it our duty to recommend that the question of the legality of said levy be at once settled. Unless the School Board, therefore, will agree to submit the question to some good lawyer, and recall that part of their levy, in case the question is decided against them, we recommend that the Council and Board of Aldermen pass a motion requesting the City Clerk to refuse to put said tax on the duplicate. The Board can then proceed by mandate to compel him to do so, and thus raise the question. This is the only way the question can be now presented to a court of record for determination.

of the City of Indianapolis:

Gentlemen:—The undersigned, a committee appointed by the honorable Mayor to make arrangements for the forthcoming meeting of "The American Public Health Association," beg leave to submit the following facts:

This "Sanitary Congress" is made up of public spirited men who leave their homes and their business, and spend their time and their money, for the public good, not expecting to receive one dollar in return, and their work benefits all classes of society

Upward of 800 persons, many of them the most eminent sanitarians of the United States, have written to the chairman of the local committee, indicating their intention to attend the coming meeting. The meeting will open October 17, and continue in session four days.

There will be considered during the convention all the vital questions that pertain to public health, and this city as well the country at large can but derive

great benefit as the result of its deliberations.

So important have these subjects become, that many of the States have enacted laws "to prevent the spread of contagious diseases," etc., and spend large sums of money therefor. Much of what is known on these important subjects is the result of the investigations and discussions by members of this body.

In consideration of the above facts, and in consideration of the additional fact that the Association was invited to meet here by the Mayor of the city and the Governor of the State, and as it is customary in all cities in which the Association meets, to have all its local expenses paid, we submit the following statements:

The local expenses, including hall in which to meet, postage (which has already amounted to more than \$100), printing, etc., will amount to at least \$550. To meet this, the hotels and Street Railway Company have agreed to contribute \$250, leaving \$300 to be yet raised. This sum we ask you to appropriate, believing that in so doing you will conserve the highest interests of the taxpayers whem you represent.

That I. Rebensberger be permitted to lay brick sidewalk in front of his house, No. 23 west McCarty street, under direction of the City Civil Engineer, and at his own expense.

To the end that such want of room may be remedied, the undersigned respectfully proposes, and hereby offers to sell and convey to the city of Indianapolis, by warranty deed, free from encumbrance, 60 feet of the east end of Lot 1, in Yandes & Wilkins' subdivision of the south half of Square 62, in said city, for \$3,000.00, and to give possession of said premises within 30 days after such conveyance. Said 60 feet comprises a part of the same lot occupied by said prison.
