# ADJOURNED SESSION-NOVEMBER 13, 1882.

The Common Council of the City of Indianapolis, met in the Council Chamber, Monday evening, November 13th, A. D. 1882, at seven o'clock, in adjourned session.

#### To the Mayor, Common Council, and Board of Aldermen:

Gentlemen:—I wish to call your attention to the fact that, under your instructions, I was only ordered to rip-rap one thousand feet of the west bank of White River, and therefore could not protect it as far as needed. The work has been done by sinking the foundation most of the distance to two feet below how water mark, and it is therefore safe against cutting out. The ends have been also well protected. As at the time I first estimated the work there were 2,600 feet needing protection, will say that the sooner the work is done the cheaper the protection can be made. Respectfully submitted,

Gentlemen:—The time for the construction of the eistern at the corner of Deloss and Reid streets expired November 1, 1882. No part of the work has been done, but that it has not is no fault of the contractor, as the water in this section of the city has stood so near the surface, before and since the contract was let, that the building of the cistern has been impracticable. This difficulty will be obviated when Reid street sewer is completed. I therefore recommend that the time for the completion of said work be extended to June 1st, 1883.

#### Indianapolis, Sept. 22d, 1882.

To the Common Council:

Gentlemen:—I was directed by the Board of Aldermen, at its last session, to prepare and have presented to the Council an ordinance repealing the ordinances creating the Fire Board, Police Board, Hospital Board, and Board of Public Improvements, transferring the duties of said boards to the Chief Fire Engineer, etc., etc. I have complied with said order, and hand the ordinance to the Mayor for in-

troduction. Respectfully,

His Honor, Mayor Grubbs, as per foregoing report, presented the following entitled ordinance, which was read the first time:

G. O. 76, 1882.—An Ordinance repealing all ordinances authorizing and creating the Fire Board, the Police Board, the Hospital Board, and the Board of Public Improvements, and transferring the duties of said Boards, as now constituted, to the Chief Fire Engineer, Chief of Police, Superintendent of the City Hospital, and Street Commissioner, respectively, and making proper provisions as to the responsibility and qualifications of said officers.

Councilman Dowling moved a suspension of the rules for the purpose of placing the foregoing entitled ordinance on its final passage; which failed of adoption by the following vote:

- AYES, 6-viz. Councilmen Dowling, Fultz, Harrold, Hartmann, Koller, and Weaver.
- NAYS, 10-Councilmen Brundage, Bryce, Cole, Dean, Egger, Mauer, Morrison, Pearson, Pritchard and Thalman.

The City Attorney submitted the following report; which was concurred in, and the City Attorney instructed not to proceed against the estate of Moses Broyles for the recovery of the judgment against said Broyles.

To the Mayor, Common Council, and Board of Aldermen :

Gentlemen:--Since the last regular meeting of the Council, the Board of School Commissioners of Indianapolis brought an action in the Superior Court against Joseph T. Magner, City Clerk, asking a mandate against him to Tompel the placing of a poll tax of one dollar on the tax duplicates of 1882, levied by said Board for general school purposes. I immediately appeared to said action and demurred to the petition, which raised the question of the legality of said levy. The demurrer was argued before the full bench of said court, and all three of the judges joined in an opinion against the legality of the tax. An appeal has been taken to the Supreme Court, and it will be argued orally before that court to-morrow, and a decision will probably be made this week.

2. The case of Sarah S. Kingsbury et al. vs. The City, has been tried before Judge Walker, of the Superior Court, and decided in favor of the city This is the threatened commencement of a series of new suits by the Noble-Davidson heirs to quiet title to streets in the eastern part of the city. The one tried was to quiet title to Highland street, from Washington street to Meridian street, the claim being that no part of said street had been dedicated to the public, and therefore remains the private property of the heirs of Noah Noble, the original owner. I presented, as I believe, several good defenses to the claim of plaintiffs; but the one principally relied on, and which, I presume, will also he sufficient to defeat the other cases, if brought, is that of user by the public for many years without protest by the claimants.

3. In the case of Alice Rodgers vs. Mathew Rodgers, her husband, for support, under the late law on that subject, wherein the city was joined for the purpose of reaching the defendant's salary, he being an employe of the city in the Fire Department, the Superior Court in special term has sustained the city's demurrer to the complaint, and rendered judgment in favor of the city for costs, thus settling a very important legal question in favor of the city. The decision of the court is based (as it was in the Naltner garnishee cases heretofore reported) on the ground of public policy, neither of the statutes by express terms, including *municipal* corporations. These decisions will, I think, have the effect of saving the city from many annoying suits.

4. I was ordered, when I reported the verdict of \$275 against the city in favor of Annie Merrick, some months ago, on account of injuries sustained by her in falling over a trough across the sidewalk in front of the residence of Rev. Moses Broyles, to bring suit against said Broyles to recover back said amount, in case the judgment should not be paid by him. I immediately called on Mr. Broyles, but found him too weak to talk business at any length. He gave me to understand, however, that he had neither money nor property; but stated that he would, as soon as he was able to leave his bed, try and do something about the matter. He died a few weeks afterward, and about the time the city paid the judgment. I have been waiting to see if letters of administration would be taken out on his estate. None have been applied for as yet, and, I learn, will not likely be, as he left no property except the house where lived, which is mortgaged for more than its full value. I think, therefore, that as nothing could be made by having an administrator appointed and filing the claim, your former order should be withdrawn.

5. The case of David A. Richardson vs. David S. McKernan et al., the city being a mere nominal party, has been disposed of, the decree protecting the city against costs.

6. I also state, for the information of the members of the Council and Board of Aldermen, that an order has been entered by His Honor, the Mayor, on complaint filed before him against Lavina C. McCarty, to tear down and remove portions of the east and north walls of the Sherman House, the same being dangerous, and having been condemned by the Chief Fire Engineer and the committee on Insecure Buildings. A warrant has been issued to the Marshal to do said work, as provided by ordinance in such cases.

#### REPORTS, ETC., FROM OFFICIAL BOARDS.

The Hospital Board, through Councilman Bryce, submitted the following report; on motion by Councilman Dowling, the whole matter was referred to a special committee of three. The Chair appointed Councilmen Thalman, Morrison and Dowling to act as the members of such committee.

Indianapolis, Oct. 30, 1882.

#### To the Mayor, Common Council and Board of Aldermen:

Gentlemen:—In compliance with your instructions, we have procured plans and specifications for the erection of an addition to the City Hospital, we carefully investigated the question of erection of a frame building, as per recommendation of special committee, on new hospital, and before advertising for plans we decided that it was unwise to erect such a building, and requested the competing architects to submit plans for brick buildings. We also asked for the erection of a differently constructed and much better building than originally contemplated. This we did after being convinced, upon more careful investigation, that all the advantages claimed for a frame building could be obtained by a properly constructed brick building, and that very many disadvantages of a frame building could be avoided by a brick. Without entering into detail with reference to this change, we would respectfully represent that we advertised for plans and specifications offering the sum of one hundred dollars (\$100) as entire remuneration for drafting and furnishing the plans and specifications which should be accepted by us and finally approved by your honorable body as building plans. We also offered the sum of fifty dollars (\$50) for the plans which should, in our judgment, be regarded as second best in point of merit. In accordance with the foregoing, there were two plans with specifications submitted, the ones accepted being those of Hubner & Mueller, the ones being second in point of merit to those of J. H. & A. H. Stem. The plans and specifications adopted were accompanied by an estimate for their completion at a cost of eleven thousand eight hundred dollars (\$11,800) for the east wing, and a probable cost of fourteen thousand dollars (\$14,000) for the erection next year of a north wing, and a surgery, drug room, water closets, bath and wash rooms, and a kitchen and wash house, the latter two buildings to be separate from the hospital proper, as are also the surgery, bath rooms, water closets, etc. We have advertised for proposals to erect the east wing so much needed for immediate use, and, in answer to our advertisement, eight bids were submitted. We have accepted the bid of Mr. Peter Routier as being the lowest and best bid offered at the sum of twelve thousand dollars (\$12,000), to be were adopted, Messrs. Hubner & Mueller. We have also accepted the proposition of Messrs. Hubner & Mueller to superintend the construction of the east wing at the rate of two and one-half per cent of the entire cost of the building for such services. When completed next year, as is contemplated, the buildings will furnishe apacity for one hundred and twenty-six patients in addition to that furnished by the old brick building which it is intended to leave standing.

We herewith submit the plans and specifications of Messrs. Hubner & Mueller, together with the proposition of Mr. Peter Routier, and bis bond for the faithful fulfillment of the same; also, the foregoing statement of our action, all of which is conditioned upon your approval. Trusting that you will take immediate favorable action upon the same, so that building can be commenced upon the east wing in time for its completion and occupation before cold weather.

The order of the Council provided that your Board of Public Improvements should make the contract, and the Board of Aldermen amended said resolution by including four members of said Board to act with the Board of Public Improvements in making said contract. We find that no member of the Board of Public Improvements was present when the contract was made, and Mr. Rouse claims he made the contract with the Committee from the Board of Aldermen; and, if so, the bill should be paid, and your Committee recommend that the City Clerk include the amount of said claim in the next general appropriation ordinance. #### Chicago, October 20, 1882.

Fo the Honorable, the Mayor, Board of Aldermen and Common Council of the City of Indianapolis:

Gentlemen:—The Mutual Union Telegraph Company respectfully represents that the ordinance passed imposing a tax of two dollars upon each poll erected by it within the corporate limits of your city, should be repealed, or at least modified so far as it relates to this company, for the following reasons, viz.

1st. This is a young company, that is struggling to establish a business in the face of the most strenuous opposition on the part of an old, well-established and powerful monopoly, and in its efforts to afford the public additional and competitive telegraphic facilities, it is deserving of, and should receive, the support and encouragement of the representative men of Indianapolis.

2d. Its business is necessarily limited, owing to the comparatively small number of points it reaches, and such business as yet affords no profit.

3d. The tax of two dollars per poll which the ordinance imposes amounts to some 40 per cent. of the value of the property, and is therefore excessive, and out of all proportion to the rate imposed upon all other property in the city.

4th. While the company believes it is entitled, under an act of Congress, to maintain poles in the streets of Indianapolis, it is not disposed to raise this question, but announces its willingness to bear its fair proportion of the burden of municipal expenses, and only makes this appeal with a view to the procurement of an equitable adjustment of the question.

The company submits the accompanying ordinance, and respectfully requests its early consideration.

Gentlemen:— Your petitioner says that on the 12th day of February, 1879, at city tax sale, he bought lots 38 and 39, in McGill's subdivision of square 93, Indianapolis, for \$43.15, which sum he paid into the city treasury, and says that on the 26th of January, 1881, he paid tax \$41.19, and on 7th of February, 1882, he paid subsequent tax \$17.65, all of which sums were paid under certificate No. 14,380.

Your petitioner says that said lots were, by the County Board and Auditor forfeited to the State under a school fund mortgage, on the 22d day of March, 1880. (See Commissioners' Record No. 17, at page 502.) And on said 22d day of March, 1880, said property became, under said forfeiture, the property of Indiana, credited to the school fund, and still is the property of the State, and not liable for tax; that said forfeiture discharged all taxes and liens for taxes on said day; that there was no taxes due, because of these facts, on said property, on the 26th of July, 1881, said property not being liable to taxation after the date of said torfeiture, when petitioner paid \$41.19; nor on the 7th of February, 1882, when he paid said \$17.65; and says that said property was forfeited before the two years expired under which petitioner would be entitled to his deed, and that said city, on said day of forfeiture, lost all taxes and liens therefor, and can not make or execute a deed therefor; and, therefore, because of her failure and lack of ability to make such, she should also refund the said purchase money of \$43.15 so paid on the 12th day of February, 1879, all of which sums he asks refunded with interest; wherefore he prays your honorable boards to grant all proper relief, etc. S. The following report from the City Attorney was read, and the favorable action of the Common Council thereon (see pages 583 and 584, *ante*), was concurred in:

#### To the Mayor, Common Council, and Board of Aldermen:

Gentlemen:--Since the last regular meeting of the Council, the Board of School Commissioners of Indianapolis brought an action in the Superior Court against Joseph T. Magner, City Clerk, asking a mandate against him to compel the placing of a poll tax of one dollar on the tax duplicates of 1882, levied by said Board for general school purposes. I immediately appeared to said action and demurred to the petition, which raised the question of the legality of said levy. The demurrer was argued before the full bench of said court, and all three of the judges joined in an opinion against the legality of the tax. An appeal has been taken to the Supreme Court, and it will be argued orally before that court to-morrow, and a decision will probably be made this week.

2. The case of Sarah S. Kingsbury et al. vs. The City, has been tried before Judge Walker, of the Superior Court, and decided in favor of the city. This is the threatened commencement of a series of new suits by the Noble-Davidson heirs to quiet title to streets in the eastern part of the city. The one tried was to quiet title to Highland street, from Washington street to Meridian street, the claim being that no part of said street had been dedicated to the public, and therefore remains the private property of the heirs of Noah Noble, the original owner. I presented, as I believe, several good defenses to the claim of plaintiffs; but the one principally relied on, and which, I presume, will also he sufficient to defeat the other cases, if brought, is that of user by the public for many years without protest by the claimants.

3. In the case of Alice Rodgers vs. Mathew Rodgers, her husband for support, under the late law on that subject, wherein the city was joined for the purpose of reaching the detendant's salary, he being an employe of the city in the Fire Department, the Superior Court in special term has sustained the city's demurrer to the complaint, and rendered judgment in favor of the eity for costs, thus settling a very important legal question in favor of the city. The decision of the court is based (as it was in the Naltner garnishee cases heretofore reported) on the ground of public policy, neither of the statutes by express terms, including *municipal* corporations. These decisions will, I think, have the effect of saving the city from many annoying suits.

4. I was ordered, when I reported the verdict of \$275 against the city in favor of Annie Merrick, some months ago, on account of injuries sustained by her in falling over a trough across the sidewalk in front of the residence of Rev. Moses <sup>8</sup> Broyles, to bring suit against said Broyles to recover back said amount, in case the judgment should not be paid by him. I immediately called on Mr. Broyles, but found him too weak to talk business at any length. He gave me to understand, however, that he had neither money nor property; but stated that he would, as soon as he was able to leave his bed, try and do something about the matter. He died a few weeks afterward, and about the time the city paid the judgment. I have been waiting to see if letters of administration would be taken out on his estate. None have been applied for as yet, and, I learn, will not likely be, as he left no property except the house where lived, which is mortgaged for more than its full value. I think, therefore, that as nothing could be made by having an administrator appointed and filing the claim, your former order should be withdrawn.

5. The case of David A. Richardson vs. David S. McKernan et al., the city being a mere nominal party, has been disposed of, the decree protecting the city against costs.

6. I also state, for the information of the members of the Council and Board of Aldermen, that an order has been entered by His Honor, the Mayor, on complaint filed before him against Lavina C. McCarty, to tear down and remove portions of the east and north walls of the Sherman House, the same being dangerous, and having been condemned by the Chief Fire Engineer and the committee on Insecure Buildings. A warrant has been issued to the Marshal to do said work, as provided by ordinance in such cases.

We respectfully desire that you will take decisive action in relation to the matter to-night, as the blocks are still on board a railroad car, and must be unloaded immed ately or reshipped to another city where they can be sold.

Ap. O. 70 1882—An ordinance appropriating the sum of fifteen hundred dollars (\$1,500) on account of the Street Department of the city of Indianapolis.

The following petition was read, and the favorable action of the Common Council thereon (see page 605, ante), was concurred in:

That the contractor be, and is hereby, directed to place as many loads of cinders on south Illinois street, between Washington and South streets, as will be necessary to fill the many chuck-holes on said south Illinois street, under the direction of the Street Commissioner.

That the City Civil Engineer be directed to have a double row of stone crossings placed on Delaware street, on the north side of the New York street crossing.

The report of the Board of Public Improvements and Street Commissioner, showing expenses in the Street Repairs Department (see pages 594 and 595, *ante*), for the month of October, 1882, and also a report showing in detail the amount expended on the different streets during the month July, 1882 (see pages 595 and 605, *ante*), were read and received.

On motion, the Board of Aldermen then adjourned.
