"That the Street Commissioner and City Civil Engineer be, and are hereby, directed to immediately take such action as may be necessary to have placed in good condition the arches over Pogue's Run under Meridian street; and if it is not the city's duty to do the work, to report to the Council whose duty it is, and also to report whether the same is in good condition or not."

We would report that we have made careful examination, and find that there is no stone arch over Pogue's Run on Meridian street, but it is spanned by iron girders, which are in good condition; but there are three stone arches just east of Meridian street, over Pogue's Run, placed there by the Union Railway Company, which are in very bad condition, being undermined, and crumbling so badly that the earth falls through and liable to give way at any time; and if at the time of high water, certainly would cause great damage, by daming up the Run, inundating that part of the city.

We are of the opinion that some action should be taken to compel said Railroad Company to make the necessary repairs to said arches, to prevent any damage to person or property. Respectfully submitted,

There was no improvements upon said lots, and therefore asks the sum of \$5.34 be refunded. We recommend the sum of \$5.84 be refunded.

Sixth, is the petition of J. F. & H. L. Talbot, Meridian street contractors, showing that there is \$70.00 unpaid on their estimate.

The city gave the Messrs. Talbots a warrant for the full amount due them. When they went to the City Treasurer, they found a bill or note for \$70,00, in favor of Mr. McCutcheon, of First National Bank, which, the testimony given your committee, Messrs. Talbots consented to some arrangements by which this \$70.00 was paid to Mr. McCutcheon. The city, therefore, does not owe Messrs. Talbots any thing. We therefore recommend prayer of petition be not granted.

Seventh, is a bill of Roswell R. Rouse, asking for royalty, \$20.00, on two driven wells, one at sixth street Station House, and one at the City Hospital. Under the decision of the Supreme Court of the United States, Mr. Rouse is entitled to this royalty. But last year the city gave Mr. Rouse a contract to put in ten or twelve new driven wells, and he agreed to keep them in repair for three years. Your committee are informed that four or five of these wells utterly refuse to work, or furnish any water. When all these wells are put in good condition, then we recommend the \$20.00 of royalty be paid.

The eighth is the petition of Frank McWhinney, showing that he purchased, at city tax sales, sundry lots in various additions outside the city limits, paying the total sum of \$492.40. Some of these lots are in May & Wasson's addition, called Highland Park addition; some in Myers & McClain's southeast addition; also, in Stanton's addition, and others He alleges, in petition, that the sale was illegal, because all of said additions were illegally annexed, and therefore asks the sum of \$492.40 be refunded. It is believed that this case is not covered by case of McAvoy vs. City of Indianapolis, and we therefore recommend the prayer of petition be not granted.

Ninth, is the petition of Jas. C. Ferguson, showing that in his return for taxation for the firm of J. C. Ferguson & Co., for 1882, he included \$15,000.00 in money; that the same was returned in the City of Chicago, and paid for the same year, and he therefore asks that the sum of \$15,000.00 be stricken from the tax duplicate and from the Assessor's books. In the opinion of your committee, this matter should have been submitted to the Board of Equalization, in last June. It would be a bad precedent for the Council, at this last day, to order taxes stricken from the duplicate upon property voluntarily returned for taxation by petitioner. We therefore recommend the prayer of petitioner be not granted.

Gentlemen:—The undersigned, citizens and resident owners of property fronting on and lying along that portion of Eighth street between Illinois street and Pennsylvania street, would respectfully represent that said Eighth street, west of Illinois street, is only thirty-three feet wide, and east of first alley, and west of Pennsylvania street, is forty feet wide, whilst that portion from east side of Illinois street to said alley west of Pennsylvania street, is sixty feet wide, which in no way accommodates the public, and forms jogs at the corners, both unsightly and inconvenient. We therefore pray that said portion of Eighth street, being one and one-half squares, be ordered to be reduced to forty feet in width, within the bounds of said one and one-half squares, and that the lines of same be made to conform to the lines of that portion east of the alley aforesaid; and your petitioners will ever pray.
