OPENING AND REFERRING SEALED PROPOSALS FOR PUBLIC IMPROVE-MENTS.

Sealed proposals for making the following street improvements, and for constructing a sewer, were opened, read, and referred to the Committee on Contracts.

The proposals for the following improvements were advertised to be received April 7th, 1884. There being no session of Council at that date, they were laid over, and opened at this session.

(S. O. 154, 1883)—For grading and graveling the first alley south of Seventh street, from Pennsylvania street to Delaware street.

(S. O. 3, 1884)—For grading and paving with brick, the sidewalks of Bright street, from Michigan street to North street.

(S O. 7, 1884)—For the erection of lamp-posts, lamps and fixtures (complete to burn gas, except the service pipes), on Downey street, between East street and Madison avenue. (S. O. 16, 1884)—For grading and paving with brick, the sidewalks of Park ave nue, from Eighth street to Twelfth street.

(S. O. 23, 1884)—For grading, bowldering and curbing with stone, the south gutter of Christian avenue, from Central avenue to Ash street.

(S. O. 26, 1884)—For grading and bowldering the north gutter of Christian avenue, and curbing with stone and paving with brick the sidewalk thereof, from Central avenue to Ash street.

For the construction of a brick sewer, two and one-half $(2\frac{1}{2})$ feet internal diameter, in and along Hill street, and through the private grounds, from Meridian street to the old bed of the Canal, with the necessary catch-basins and man-holes.

Owing to the vast amount of unavoidable repair work to our tracks throughout the city, and the double track necessary on Pennsylvania street, to comply with the request of your honorable bodies of February 21st—to shorton the interval between our cars on that line, also to the fact that we are under obligations to give precedence to the Peru street, (ordered last year), and other pressing work—we feelobliged to ask you to allow us to defer building on Prospect street at present.

Very respectfully,

Gentlemen:—We would like to have you give us permission to dig a cistern on Wab ish street, between Delaware and Pennsylvania streets, in the rear of our store, to be walled up with brick and arched over, and lined inside, for the purpose of storing 15 or 20 barrels of gasoline; we to pay all the expense attached to same, and to replace the street in as good a condition as we found it. Hoping you will grant the same, I am yours respectfully, Chas. W. MEIKEL.

The City Clerk presented the following petition; which was referred to the Committee on Sewers and Drainage;

Indianapolis, Ind., March 31, 1884.

Hon. Mayor, Hon. Common Council, and Hon. Board Aldermen, of the City of Indianapolis:

Sirs: — We, the undersigned, city tax payers, owners of property, would respectfully pray your honorable bodies to the condition of the sewer running down the-C., St. L. & P. R. R., and the cause of its incapacity to carry off the accumulation of water. In the first place, the C., St. L. & P. R. R. in extending their siding on the north side of the main track from State street to Oriental street, connected a sewer to the one already built, and put in a smaller pipe. Second place, in extending their south siding across State street to connect with one above, they stopped up a drain pipe that was laid under said State street, which carried off the water from the upper yards and from the State grounds east of said State street that passed down between the said C., St. L. & P. R. R. and C., H. & I. R. R. to some point below. Third, by so shutting up said pipe the water overflowed said State street and run down on the north side of said company's tracks, at 1 now the said company has put down a wooden box pipe under said State street to let the water pass under said street. And now the water from the sidings up at the new shop grounds and upper yards, and from the State grounds, pass down the north side of said railroad tracks and flows there so that it backs up for nearly a square on Summit street and makes it impassable. The last instance, March 11th, it rained in the evtning and the water stood on Summit street from that time till Friday 14th, before it all passed off.

We, the undersigned, owners and agents of property on Summit street, pray that your honorable bodies will cause said railroad companies to fix the sewer that they have spoiled and arrange some way to carry off the water that they cause to flow down on us, to the injury of our property. Hoping that you will grant our prayer, we remain respectfully yours,

'To the Mayor, Common Council and Board of Aldermen:

Gentlemen:—Since the last regular meeting of the Council, the case of Olof Johnson vs. The City, Joseph R. Shelton and A. L. Stoner, has been disposed of by the special term of the Superior Court. It was an action for \$10,000 damages, founded upon an alleged wrongful ejectment of plaintiff and his family from one of the stationary stands of the West Market, the charge being, that Stoner, when Market Master, leased said stand to him for a definite time and rental, and that he was forcibly ejected by Shelton and the city before the expiration of the lease, without cause, and that the exposure to his family before he could procure suitable shelter, caused the death of two infant children, beside causing a large outlay of mones and the loss of business, etc. The case went off on demurrers to the complaint, Judge Taylor holding that no recovery could be had upon the facts stated, and judgment has been finally entered in favor of all the defendants. I do not believe an appeal will be taken.

In one of the numerous suits by Frank McWhinney vs. The City, asking a refunding of some \$700 taxes paid by him at delinquent tax sales, where the city has been unable to pass to him even a lien, on account of irregularities, the general term of the Superior Court has affirmed the judgment of the special term, in favor of the city, holding as in all the other cases of a similar character, so far passed on, that he can not recover. The plaintiff will appeal to the Supreme Court.

Three cases where the city was a mere nominal party, have also been disposed of since the last regular session, the decrees in each case protecting the city's rights nd giving her judgment for costs.

The Board of Health submitted the following report; which was received, and the claim of J. B. & J. E. Hendricks referred to the Committee on Account and Claims;

Indianapolis, April 14th, 1884.

To His Honor, the Mayor, and the Members of the Common Council of the City of Indianapolis: Gentlemen:—It gives us plea-ure to announce to you that our city is now virtually free from small pox. There are now no patients in the small pox hospital, and but one in the city, and she is rapidly convalescing.

[Special Session

The first case occurred in the Station House, and was reported from the Jail, January 15, 1884—the patient having been taken from the Station House January 9th. From these exposures, the disease was carried throughout the city, and there were a total of 113 cases in the Jail, Station House and city; 26 in the Jail, 2 in the Station House, and 85 in various parts of the city.

The disease was principally confined to a class of people who were very difficult to control, and who bad but little care or appreciation for the dangers to the public. Consequently it was only by the exercise of the most untiring care and watchfulness that the disease was controlled. As it was, there were outside of the jail and Station House, no less than 55 infected houses. In some instances the cases were kept concealed until the disease had about run its course. Yet notw that the disease were kept disadvantages, we have been able to prevent the spread of the malady, and the cases only number one and one-half for each infected locality. Where we removed the first case to the hospital, we have almost in every case arrested the disease at thatpoint. In houses where the patients were allowed to remain, other cases tave almost always occurred. The Sanitary Police have disinfected and had charge of the cleaning of all the infected houses, and they are free from infection.

Before arrangements were made for vaccinating infected persons, and since the arrangements were countermanded, the Sanitary Police and Board of Health have vaccinated 93 persons. We enclose a bill for amount owing for disinfecting mateterials and vaccine virus, amounting to less than \$25.00. The amount of money saved the city for vaccination fees alone, is nearly three times as great as the entire amount due for disinfecting materials and vaccine virus. The Sanitary Policemen have been exceedingly efficient, and we consider the city largely indebted to them for the remarkable escape from a serious outbreak of this loathesome disease.

WHEREAS, The City Civil Engineer, Street Commissioner, Chief of the Fire Department and President of the Fire Board have personally investigated and agree as to the danger that will ensue by the Union Railway Company proceeding with its work; therefore
