#### COMMUNICATIONS, ETC., FROM THE MAYOR.

His Honor, the Mayor, presented the following communication; which was received;

To His Honor, the Mayor, Common Council and Board of Aldermen, of the City of Indianapolis:

Gentlemen:—I presented a proposition to your honorable body, dated January 29, 1884, to furnish plans to do away with Pogue's Run, provided the city pay me one thousand dollars for my plans, if so practicable, if not practicable, I was not to charge anything for my plans, and the cost would be merely nominal, compared to what had been suggested, and the experiment would cost only about two hundred dollars to test the practicability of the matter. I contend that the matter should be carried this far at least, before it can be respectably dropped, as to the City Council's duty to a law abiding citizen, and who has formerly been a heavy tax payer, and taking into consideration what they have already passed upon, which has encouraged me to give the matter a great deal of physical labor as well as mental, and has so far been considerable damage to me, as I have given the matter almost my whole, undivided attention. Turning Pogue's Run into this stream is not all there is in the matter for the safety of the city. This stream is very powerful, and lies immediately under the blue clay, and Pogue's Run is already cut partly into that, and if it cuts into this stream it will be an impossibility to save the city from an enormous overflow, but if it is turned into Pleasant Run, so it can clean itself of some sand and gravel that has partly choked it up, and give it a free current before other streams, in and above the city, cuts into it will do no harm. Fall Creek is already eight feet down into the blue clay and sooner or later this ancient stream is going to give the city a great deal of trouble. I now ask that this test be made or that it be heard at the earliest convenience and your petitioner will ever pray.

We would recommend that the defective arches be taken down, and be replaced with a truss bridge.

An appeal would avail nothing, I am sure, and the costs would be large, on account of writing out the evidence, which was taken down by a short-hand reporter, at the request of appellant. There have been so many irregularities and delays in the proceedings that we do not believe the contractor could enforce a lien for his work, and therefore feel that the Board of Alderman ought not, in justice to Mr. Patterson (or the property owners either) further attempt to have the work done under Mr. Patterson's bid.

We therefore recommend that the contract and bond of Mr Patterson be not approved, and that no further steps be taken by this Board looking to the imprvements of said avenue under any ordinance heretofore passed. And we further recommend that the Council be requested to take prompt action in passing the

Cos. have been ordered to span Pogue's Run with a thorough span bridge; and whereas, by so doing East street would be partially obstructed by said bridge extending on to the same; therefore

Resolved, That the P., C. & St. L., and the C., H. & D. R. R. Cos. be, and are hereby, directed to span the stream by transverse iron girders."

"Section 10. It shall hereafter be unlawful for any huckster to sell any produce or merchandise from any vehicle in the City of Indianapolis, which shall not at the time have plainly painted thereon, the name of the person for whom sales are made therefrom, together with the number of the license authorizing him to sell as a huckster. And it shall likewise be unlawful for any huckster to sell any produce or merchandise in said city, without having a badge plainly displayed upon his clothing, bearing the words, 'Licensed Hucksters,' and the number of his license in figures. Said badges shall be furnished by the City Clerk, who shall be entitled to charge therefor not exceeding fifty cents each."

27 Gentlemen:—The undersigned, freeholders of the City of Indianapolis, respectfully pray an order from your honorable body, vacating all that portion of Fifth street lying and situate east of Illinois street, in the City of Indianapolis, Marion County, Indiana, and described as follows, to-wit:

Beginning at the southeast corner of Lot number six (6), in Square or Block number twenty-one (21), in James P. Drake's addition to the City of Indianapolis, recorded in Plat Book No. 1, page 95 of the records in the Recorder's office of said Marion County; thence south fifty (50) feet; thence west one hundred and nine and one-half (109½) feet to the east line of Illinois street; thence north fifty (50) feet to the southwest corner of said Lot six (6); thence east along said Lot six (6) to the place of beginning.

Your petitioners would respectfully show and urge in support of this petition, that they are the owners in fee-simple of all the real estate immediately adjoining and bordering upon the above described portion of Fifth street; that your petitioners, and no other person whomsoever, can be affected by said proposed change or vacation; that said described portion of Fifth street has never been used by the public, and has never been improved as one of the streets of the city, and is of novalue or benefit to the public, and is practically closed as a public thoroughfare; that immediately south of said portion of Fifth street, and adjoining the same, lies a public street, improved, and now used as a thoroughfare by the inhabitants of said city; that the vacation of the above described portion of Fifth street will not interfere with the convenience of the public in any respect whatever; that we deem it expedient for the public interests of the city that such vacation be made; that no damages or injury will result from said vacation, and no costs occasioned thereby to the city.

Councilman Edenharter presented the following remonstrance; which was ordered filed with the ordinance, S. O. 55, 1884:

To the Mayor, Common Council and Board of Aldermen:

33 Gentlemen:—The undersigned, owners of real estate fronting on North street, between Noble and Pine streets, respectfully remonstrate against the passage of an ordinance providing for the paving with brick the south sidewalk on North street.

Councilman Haugh presented the following petition; which on motion by Councilman McClelland, was referred to the Committee on Contracts, and City Attorney:

To the Common Council and Board of Aldermen of the City of Indianapolis:

Gentlemen:—Your petitioner would respectfully show, December 17, 1883, hefiled a petition before your honorable body, which was that day referred to the City Civil Engineer and the City Attorney, in regard to the unlawful appropriation by the city, of part of lots 73 and 75 of Ovid Butler's 2d addition to the City of Indianapolis, by the extension of Massachusetts avenue off the line thereof. This petition, as informed, has not been acted on because of press of other duties.

Special Ordinance No. 21, for 1884, was passed by the Council March 17, 1884, and by the Board of Aldermen April 14, 1884, providing for paving with brick the sidewalk from Peru street to the Wabash Railway tracks, on the north side of

Massachusetts avenue, no property holder petitioning therefor.

Being the owner of all the ground between Peru street and said Railway tracks, fronting on said avenue, on the Thursday or Friday preceding the next meeting of the Common Council after the passage of said ordinance by the Board of Aldermen, I filed in the office of the City Clerk, a petition asking that I be permitted to do said paving, without contract by the City, under the supervision of the City Civil Engineer. The deputy City Clerk, to whom the petition was handed, said it would be properly placed before you. Mr. S. H. Shearer, the City Civil Engineer, was by me notified of the filing of said petition, and requested to withhold advertising for proposals until you could act thereon. The City Clerk informs me that said petition was handed to Mr. McClelland, Councilman from the ward where the paving is to be done; the date of handing same he does not know, and he presumes Mr. McClelland still has the petition. Two meetings of the Council have been held since the petition was filed with the Clerk, and no action. The City Civil Engineer has advertised for proposals to do that work.

As that petition seems to have failed of its purpose, though duly filed with the Clerk, I now protest against the letting of any contract under said Special Ordinance, providing for paving with brick the north sidewalk of Massachusetts ave nue, from Peru street to the Wabash Railway tracks, until it is determined what is the legal location of said Massachusetts avenue. Of course, the sidewalk must

conform to the proper location of said avenue.

Should the Council determine to press this work, over my protest, I ask to be permitted to lay said sidewalk with brick six feet wide, from Peru street northeastwardly to the point of the legal terminus of said avenue, where it strikes said lot 73, Ovid Butler's 2d addition to said city, about 225 feet from said Peru street. Should the Council decide to continue said pavement beyond the said legal terminus to said Railway tracks, to which I protest, then I ask permission to do said paving, reserving all my rights as owner of the ground unlawfully taken by the city, and appropriated to public use.

As that Special Ordinance provides for a brick pavement 8 feet wide, I respectfully ask that the width be reduced to six (6) feet, because,

1st. All said ground is unimproved, is on the market for sale, and when buildings are erected, the pavement will be more or less injured, and will have to be re-

newed. 2d. There is little travel there, and six feet in width will accommodate the public, there being no connecting sidewalk east of said Railway track; any fairminded person will say six feet is wide enough.

A plat of the ground is herewith filed, taken from an accurate survey by H. B. Fatout, County Surveyor, the red lines indicating that part of my ground illegally occupied now as part of Massachusetts avenue.

That the City Attorney be directed to carefully investigate the legal points in regard to the city's right to the State Ditch, and her right to make the improvement contemplated by the ordinance, also whether it will not be necessary to have the matter referred to the City Commissioners, for their action as to condemning property through which the straightening and widening is contemplated; also what steps are necessary to dissolve a perpetual injunction said to exist against the city, preventing her from disturbing the same.
