Proceedings of Joint Convention.

SECOND SESSION-MAY 20, 1884.

The Common Council and Board of Aldermen of the City of Indianapolis, convened in second Joint Convention in the Council Chamber, Tuesday evening, May 20th, A. D., 1884, at nine forty (9:40) o'clock, P. M., pursuant to concurrent resolution, passed by the Common Council and Board of Aldermen at the sessions held this, Tuesday evening.

It appearing from an informal count that a quorum was present, on motion by Councilman Thalman, Hon. Brainard Rorison, President of the Board of Aldermen, was called to the Chair, to serve as presiding officer until the Joint Convention could be permanently organized.

Alderman Rorison, on assuming the Chair, announced that the first business in order would be the election of a President and Secretary.

The roll of the members of the Common Council and Board of Aldermen having been called, the following members of the Joint Convention were found to be present:

PRESENT—Hon. John L. McMaster, Mayor, and Aldermen Cox, Endly, King, Prier, Pritchard, Tallentire and President Rorison—7; Councilmen Cowie, Curry, Doyle, Gallahue, Haugh, Mack, McClelland, Newcomb, Pearson, Reynolds, Sheppard, Smither, Thalman, Trusler, and Wharton—15. Total Present, 22.

ABSENT—Aldermen Bernhamer, Cobb, McHugh—3; Councilmen Benjamin, Coy, Dowling, Downey, Edenharter, Moran, Rees, Reinecke, Spahr, and Wolf—10. Total Absent, 13.

Alderman Pritchard offered the following resolution:

Resolved, by the Joint Convention of the Common Council and Board of Aldermen of Indianopolis, That Geo. W. Spahr be, and he is hereby, removed as President of this Joint Convention.

And it was adopted by the following vote:

Aldermen Pritchard placed in nomination Hon. Brainard Rorison, as permanent President of the Joint Convention. There being no other nominations, Brainard Rorison was unanimously elected as President of the Joint Convention.

On motion by Councilman Pearson, Geo. T. Breunig, City Clerk, was unanimously elected Secretary of the Joint Convention.

Councilman Pearson moved to proceed to the election of members of Fire Board, Board of Public Improvements, Dispensary Board and Hospital Board.

President Rorison appointed Alderman Prier and Councilman Sheppard to act as tellers.

Fire Board—Councilman Pearson placed in nomination Councilmen Thalman, Trusler and Mack.

A ballot was then had which resulted as follows:

Councilman Thalman received 20 votes.

Councilman Trusler received 20 votes.

Councilman Mack received 20 votes.

Councilmen Dowling, Coy, Benjamin, Gallahue and Wharton one each.

Councilman Thalman, Trusler and Mack having each received a majority of all the votes cast, they were declared by the President duly elected members of the Fire Board.

Board of Public Improvements—Councilman Thalman placed in nomination Councilmen Reynolds, Cowie and Curry.

A ballot was then had which resulted as follows:

Councilman Reynolds received 19 votes.

Councilman Cowie received 20 votes.

Councilman Curry received 20 votes.

Councilmen Reynolds, Cowie and Curry having each received a majority of all the votes cast, they were declared by the President as duly elected members of the Board of Public Improvements.

Dispensary Board—Councilman Thalman placed in nomination Councilmen Smither, McClelland and Moran.

On motion by Councilman Cowie, the Secretary was instructed to cast the unanimous vote of the Joint Convention for the nominees.

Councilman Smither, McClelland and Moran having thus received the unanimous vote of the Joint Convention, they were declared by the President duly elected members of the Dispensary Board.

Hospital Board—Councilman Pearson placed in nomination Councilmen Newcomb, Gallahue and Doyle.

On motion by Alderman Prier, the Secretary was instructed to cast the unanimous vote of the Joint Convention for the nominees.

Councilmen Newcomb, Gallahue and Doyle having thus received the unanimous vote of the joint convention, they were declared, by the President, duly elected members of the Hospital Board.

Alderman Pritchard moved that when the joint convention adjourns, it adjourn to meet again at the call of the President.

Which motion was adopted.

On motion, the Joint Convention then adjourned.
