Gentlemen:—Your petitioner would respectfully represent that he is the owner of Lots Nos. 5 to 10, inclusive, and Lot 13, in Merritt & Coughlen's subdivision of Out-lot 148, in the City of Indianapolis, Marion County, Indiana; that said lots were

assessed for benefits caused by the widening of Blackford street, from Market street to Washington street, and from North street to Indiana avenue, although said lots are situated between Market and North streets, on the 14th day of July, 1873, in the total sum of \$132.00; (Council Proceedings 1883-4, pages 295, 304, 467), and that said claim for benefits still remains on the books and records of the city against your petitioner, and constitutes a cloud on his title. Your petitioner further shows that the only basis or authority for the assessment of benefits for the widening of said street, was the written consent of certain of the lot owners; but your petitioner says that no notice was given him of such proceedings, and that he did not sign any such agreement, nor give his consent in any way to the assessment of benefits to his said lots; all of which is shown by the record of the proceedings for the widening of said street. Wherefore he says that said assessment was illegal, rull and void; and he therefore prays that it be so declared, and that the charges against him for the same, be stricten from the books and records of the city.

To the Honorable, the Mayor, Board of Aldermen and Common Council of the City of Indianapolis: Gentlemen:—Your petitioner respectfully shows: That on June 21, 1880, Bishop-Chatard filed his sworn petition before your honorable bodies, showing that real estate described therein: 60 feet off of the north ends of Lots 10 and 11, in Square 77, had been illegally sold for taxes March 10, 1873, to the undersigned, by the City-Treasurer, and asked that the sale be cancelled, and money refunded to purchaser. (Proceedings of 1880-81, page 161.)

Your honorable bodies, finding the sale invalid for the reasons shown by the Bishop, promptly ordered the sale he mentioned to be cancelled, and the money refunded, the City Attorney concurring. (Proceedings of 1880-81, page 278)

Now, as above stated, the Bishop made his affidavit and petition to say that sixty-feet, &c., had been sold, but doubtless by inadvertance only set out in his petition, the sale which covered, as the Treasurer's Sale Book and the original certificate shows, only 'forty feet south of 20 feet off of the north ends of" said lots. (Tax. Sale Book, Vol. 3, page 52.)

The Bishop overlooked the fact that the 60 feet he mentions had been sold by the Treasurer in two parts—40 feet at one time, and 20 feet at another, and immediately following the first. Your petitioner knew nothing of the Bishop's petiti n, or he would then have suggested the omission, as he shows it now. The Bishop by his careful description of 60 feet, &c., certainly intended to cover the sales of the 60 feet, i. e. the 40 feet and the 20 feet, both; but in drafting his petition, doubtless by

clerical error, omitted the sale of the 20 feet, and therefore had relief only to the intent of the 40 feet, instead of the 40 feet and 20 feet both, as he petitioned.

The sale of the 20 feet is to the same purchaser, at the same moment, and should be refunded and cancelled, as the other ought as your honorable bodies held that both are unquestionably invalid. The sale of the 20 feet appears at Tax Sale Book 3, page 54, and is still outs anding, and in full force, until cancelled.

Your petitioner asks refunding, and will surrender his certificate for cancellation on payment to him of \$57.15, the amount legally due him.

Gentlemen:—The undersigned would respectfully represent that they are respectively the owners of Lots 39 and 40, in Bradshaw's subdivision, situate, lying, and being in the City of Indianapolis, and upon the east side of north Pine street, and fronting the eastern terminal of North street, where the same intersects said north Pine street, to-wit: Lydia Kingsbury is the owner in fee simple of said Lot No. 39; and Fidele Schuler is the owner in fee simple of said Lot No. 40: that heretofore, to-wit, on the 1st day of January, A. D. 1878, said lots were respectively of great value, to-wit, each of them was of the value of five thousand dollars: but they say that afterwards, to-wit, on the — day of April, A. D. 1878, the honorable Common Council of said City of Indianapolis passed a General Ordinance, known and designated as "General Ordinance 4," and dated April —, 1878, a copy whereof is found in the printed Book of Ordinances, page 305; and the said ordinance is found at length, spread upon the records of the ordinances of said city, beginning at page 437, and extending thence to and upon page 453; that the said ordinance embodies in and among the recitals upon which its provisions are founded, a certain contract between said city and certain railroads therein named; and thereupon among other things ordains and enjoins upon said railroad company that it shall "open, extend and improve North street across its grounds to the full width of its grounds immediately west thereof;" and therein recites that "the aforesaid grounds are bounded on the west by a north and south alley, one hundred and twenty feet and a half east of Pine street; and thus a break is made in North street from Pine street to the aforesaid north and south alley; and the only connecting link between the broken ends of said North street is an alley fifteen feet wide, which separates Lots 39 and 40, in Bradshaw's subdivision;" and which said alley is the only connection between said ends of North street, and passes between the property of your petitioners: And your petitioners further respectfully represent that by reason of the opening of the said east end of said North street, under and in pursuance of said General Ordinance, by said Railroad company, the whole travel and commerce between the two ends of said North street, and between the property of your petitioners aforesaid in, upon and along the said alley 1202 feet long, and which said alley is so made do duty for said entire North street; and they say that since the opening of the east end of said North street by said railroad company, under said ordinance, by throwing the entire travel and commerce of said North street in and upon said fifteen foot alley, has by thronging the same and its constant use greatly impaired the value of said Lots Nos. 39 and 40, and has greatly reduced the rental value of the same and of the tenements thereon standing; and has so changed the situation of said lots with respect to the public, and the instability of the tenure of the same, that said lots severally are not worth one-half the sum they were respectively worth when said ordinance was passed, and before said North street was thereby ordained to be opened; and they say that said lots are, by reason of the action of said city and railroad, severally of no more value than fifteen hundred dollars. That the action of said Common Council in regard to the passage of said ordinance, and said ordinance itself, are respectfully referred to and by reference made part of this their petition; and as the matter was once before brought before your honorable body by your petitioner, Fidele Schuler, but imperfectly, he begs to refer you to his action and that of the Common Council thereupon at that time; and by reference to make the same, so far as it may tend to elucidate the rights of your petitioners, and the duty of your honorable body. The same will be found in the printed proceedings of your honorable body of the year 1879, June 16th, at pages 144 and 145, and at pages 532 and 533 of the same volume.

In consideration of the premises your petitioners respectfully ask that your honorable body does one of two things, namely:

1. Pay each of them the reasonable value of their respective lots, at the time the said ordinance was passed, and before the value thereof was impaired and reduced by reason of the operations of said railroad company thereunder, and take said lots for the opening of said North street, or so much of them as may be necessary for that purpose: or,

2. Have the damage resulting to them respectively from the action of said city, in and by the making of said contract with said railroad company, and the passage of said ordinance, and the action of said railroad company thereunder, assessed and

found, and pay the same to your petitioners respectively.

Or grant such other, further and general relief as may be just in the premises.

And as in duty bound they will ever pray, etc.
