Resolved, That the petition of Kingan & Co., L'd, and others, praying for the vacation of 18 feet off of the west side of Helen street, from the north side of Georgia street to a point 250 feet north of said line, be referred to the City Commissioners, with instructions to determine what persons, if any, will be benefited thereby, and to assess benefits to persons and property affected thereby, Provided, however, That said Commissioners do not consider the vacation of more than fourteen feet off of the west side of said street between the points named; and that if a vacation of said 14 feet be recommended, that it be upon the express condition that the petitioners and their grantees and representatives shall ever thereafter keep in proper repair all the remainder of said Helen street, between said points above named, at their own expense, to the satisfaction of the City of Indianapolis, as directed by her proper officers.

Resolve lby the Common Council and Board of Aldermen of the City of Indianapolis, That the report of the City Commissioners in the matter of the petition of Stoughton J. Fletcher, Francis M. Churchman, et al., asking for the vacation of certain streets and alleys in the east part of Bruce Place Addition, included within the boundaries of Bruce street on the north, the Wabash, St. Louis & Pacific Railway Company's track on the east, Reagan street on the south, and Rohampton avenue on the west, being lots numbered from 145 to 198, inclusive, in said Bruce Place Addition, be, and the same is hereby, in all things accepted, adopted and approved;

and that in accordance with the said report, the following streets and alleys, to-wit: Greenwood street, from Reagan street on the south to Bruce street on the north, a distance of twelve hundred and twenty-seven and ninety-two hundredths feet, the width of said Greenwood street being 80 feet; Clyde street, from Bellefontaine avenue to the right of way of the Wabash, St. Louis & Pacific Railroad, a distance of seven hundred and forty-seven feet, said Clyde street being 60 feet wide; the alley between Bellefontaine avenue and Greenwood street, twenty feet wide, and running from Bruce street to Reagan street, a distance of twelve hundred and twenty-seven and ninety-two hundredths feet—be, and the same are hereby, vacated.

Resolved, further, That the petitioners be, and the same are hereby, required to pay to the City Treasurer, within twenty days from the adoption of this resolution, the sum of \$54 00, the amount of expenses reported by the City Commissioners as taxed in this matter, and that said petitioners also be, and they are hereby, required to procure and have recorded in the office of the Recorder of Marion County the proper certified copies of proceedings and maps, as required by law, at their own expense, and that until such expenses are paid, and proceedings and maps recorded, as aforesaid, said streets and alleys shall not be closed or used otherwise than as now.
